Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Iron Woman 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Iron Woman 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Administration

Iron Woman Partners, LLC (the "Company") is the sponsor of the Plan and has responsibility for the administration of the Plan. Reliance Trust Company functions as the custodian of the Plan, and The Standard Insurance Company (The Standard) serves as the Plan's third-party administrator.

General

The Plan is a defined contribution plan covering all full-time employees of participating employers of the Company who have completed three months of service and are age 18 or older. The entry date for eligible participants is the first day of the first month coinciding with or following obtaining eligibility.

Excluded employees include union employees covered by a collective bargaining agreement, nonresident aliens with no U.S. income, residents of Puerto Rico or any employee performing services in Puerto Rico, leased employees, or reclassified employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants are automatically enrolled in the Plan and have 3 percent of their pay withheld as elective contributions unless the participant elects a different percentage or opts out of participation. Participants who are automatically enrolled in the Plan will also be enrolled in the Plan's automatic contribution increase program (1 percent per year up to 10 percent).

Contributions

The Plan provides for employee salary deferral contributions up to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through regular payroll deductions.

The Plan allows participants to elect that some or all of their 401(k) contributions be designated as after-tax Roth 401(k) contributions. A participant's combined before-tax Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law. The Plan does not allow for in-plan Roth rollover contributions.

Effective January 1, 2024 through June 30, 2024, the Plan had employer matching contributions of 100 percent of the participant's elective contributions, not to exceed 1 percent of the employee's compensation. Effective July 1, 2024 through December 31, 2024, the Plan had employer matching contributions of 100 percent of the participant's elective contributions, not to exceed 6 percent of the employee's compensation.

Certain participant contributions in 2023 and 2024 were paid after the time frame required by the Department of Labor. The 2023 delinquent contributions were remitted during 2023 and 2024. Certain lost earnings related to 2023 delinquent contributions were remitted in 2024 and the rest are expected to be remitted in 2025 or 2026. Certain 2024 delinquent contributions were remitted to the Plan in 2024 and the remaining delinquent contributions are expected to be remitted in 2025 or 2026. No related lost earnings for 2024 delinquent contributions were remitted and have yet to be calculated.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates ranging from 6.25 to 8.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator at loan origination and mature at various dates through September 2031. Principal and interest are paid ratably through weekly payroll deductions, and the carrying value of participant notes receivable is recorded at amortized cost plus accrued interest.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 25 percent vested in the employer match portion of their account after one year of credited service and becomes 100 percent vested in the employer match portion of their account after two years of credited service. Vesting in the sponsor's nonelective contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service, beginning at 20 percent after two years of service and increasing by 20 percent for each year of continuous service thereafter.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$7,000 to be automatically rolled out of the Plan.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. Forfeitures in the amount of \$35,790 were applied for the year ended December 31, 2024 to reduce employer contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$3,493 and \$26,799, respectively.

Party-in-interest Transactions

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Note 1 - Plan Description (Continued)

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation

The Plan's investments are stated at fair value.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policy utilizing information provided by the investment advisors, including the appointment of investment managers, and by monitoring the performance of the Plan's investment funds.

Investments in the money market fund and mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market values.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including December 17, 2025, which is the date the financial statements were available to be issued.

In 2025, Iron Woman Logistics Services, LLC and QP Services, LLC ceased to be participating employers in the Plan, and, as a result, the Company had a reduction in workforce that resulted in a partial termination of the Plan subsequent to year end. Accordingly, the terminated participants became 100 percent vested in their account balances. All other participants remain subject to the Plan's vesting requirements. Impacted participant's assets under these employers were distributed to participants via benefit payments, balances rolled over to an IRA, or rolled into the Bison Infrastructure Services LLC 401(k) Plan. Total distributions as a result of the partial plan termination were approximately \$2,400,000.

Note 3 - Certified Information

Reliance Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 5 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
