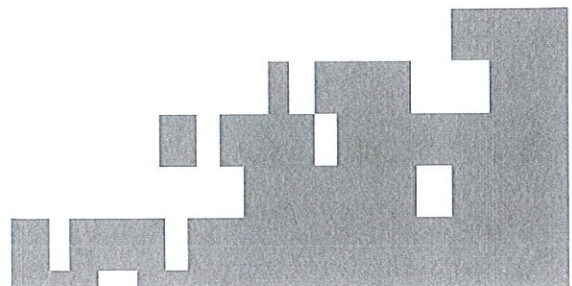

#### Note 1. Plan Description and Subsequent Event

The following description of Vahala Foam, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established February 1, 2022 and is a defined contribution plan covering substantially all employees of Vahala Foam, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As defined by the Plan Agreement, all employees who have three months of service and are age 18 or older are eligible to participate in the Plan. Employees who are excluded from participating are those who are part-time employees or leased employees.

Subsequent to December 31, 2024, the name of the Plan was amended to Vahala Foam – Cutters Foam Retirement Plan. Effective January 20, 2025, Cutters Foam Fabricating, Inc. adopted the Plan as a participating employer and employees of Cutters Foam Fabricating, Inc. who meet the eligibility criteria are eligible to participate in the Plan.

**Contributions:** Each year, participants may contribute a percentage of pretax and post-tax annual compensation, as defined in the Plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, make a matching contribution and/or profit-sharing contribution to the Plan. There were no matching contributions or profit-sharing contributions for the year ended December 31, 2024. Included in the accompanying financial statements is approximately \$800 of employer qualified nonelective contribution related to the correction of operational defects for the year ended December 31, 2024 which is included as a receivable. The Company contributions are invested into various investment options in a manner that is consistent with participant contributions. Contributions are subject to certain limitations.

Contributions from Plan participants and any matching contribution and/or profit-sharing contribution are recorded in the year in which the related services for which the wages are earned on are performed.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant's account may be charged a fee for certain investment or benefit payment activity, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Participants may borrow from their fund accounts to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable terms generally range from one to five years, unless the note qualifies as a home purchase, as defined by the Plan Agreement. The notes are collateralized by the balance in the participant's account and will bear interest at a reasonable rate. Principal and interest are paid ratably through payroll deductions. There were outstanding notes receivable from participants of \$7,895 and none as of December 31, 2024 and 2023, respectively.

#### Note 1. Plan Description and Subsequent Event (Continued)

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer contributions is based on years of service. A participant is 100% vested after six years of credited service.

**Forfeitures:** Forfeitures of the employer's contributions, if any, are used first to pay administrative expenses while any remaining amounts would be used to reduce future Company contributions payable under the Plan. For the year ended December 31, 2024, there were no forfeitures used to pay administrative expenses of the Plan. The Plan did not have any available forfeited nonvested accounts as of December 31, 2024 and 2023.

**Payment of benefits:** Upon termination of service, attainment of age 62, death, disability or retirement, a participant may elect to receive either a lump-sum or rollover distribution amount equal to the vested interest in his or her account. In-service withdrawals are permitted for hardship, early retirement age of 59½, normal retirement age of 62, rollover, or qualified military service. Benefits are recorded when paid.

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and, therefore, are not reflected in the Plan's financial statements.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the period.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### Note 2. Significant Accounting Policies (Continued)

**Fair value measurements:** The framework for measuring fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during the year ended December 31, 2024.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through December 22, 2025, the date the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classifications of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Related-Party Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and third-party administration services amounted to \$2,171 for the year ended December 31, 2024.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 7. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Nonexempt Transactions

During the years ended December 31, 2024 and 2023, the Plan Sponsor inadvertently failed to deposit a total of \$20,977 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor intends to deposit lost interest to correct this failure in 2025. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.
