Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Mattoon Precision Manufacturing Inc. Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements
March 31, 2025

1. Description of Plan

The following description of Mattoon Precision Manufacturing Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all non-union employees of Mattoon Precision Manufacturing Inc. (the Company) upon reaching 19 years of age with six months of service, except for non-resident aliens, the Chairman of the Board and employees of related entities (Nukabe Automotive Part Sales and Nukabe USA). Employees that have reached the eligibility requirements will be able to enroll semi-annually on the first day of the plan year or the first day of the seventh month of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendment – The Plan was amended effective April 1, 2025, to comply with legislative changes:

- To add Roth 401(k) elective deferrals and in-plan Roth Rollovers to the Plan
- To allow in-service distributions from the Plan for participants aged 59 1/2 and older
- To increase the automatic force out service for participants separated from service to \$7,000 and under.

Contributions – Participants may contribute annually to the Plan a pre-tax amount of up to the maximum annual contribution allowed by the Internal Revenue Code. Participants who will be age 50 or older during the year can make special catch-up contributions. Participants direct the investment of their contributions into various investment funds offered by the Plan. The Plan currently offers various mutual funds and a common collective trust.

The Company may, at its option, make matching contributions. For the year ended March 31, 2025, an amount equal to 50 percent of employee contributions up to a maximum of 6 percent of compensation was contributed as a matching contribution. The Company may also, at its option, contribute an additional discretionary amount, as determined by the Company's Board of Directors, as a profit-sharing contribution. The Company made a the discretionary profit-sharing contribution of 7 percent for the year ended March 31, 2025. Total contributions for the year ended March 31, 2025 included \$224,081 of matching contributions and \$718,173 of discretionary profit-sharing contributions.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, if any, and allocations of (a) the Company’s contribution, if any, (b) administrative expenses, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions are subject to vesting percentages based on years of continuous service. A participant is 25 percent vested after two years, 50 percent vested after three years, 75 percent vested after four years, and 100 percent vested after completion of five years of service. All Company contributions vest immediately upon a participant’s death, disability, or attainment of the normal retirement age.

Payment of Benefits – Upon termination or retirement, if the account balance is over \$1,000, a participant can select a lump-sum payment, or deferral until age 65. The Plan provides for automatic lump-sum distributions of account balances of \$1,000 or less. The Plan also allows for financial hardship and in-service distributions as defined in the Plan.

Forfeited Accounts – Forfeitures of terminated participants’ non-vested accounts may be used to pay the administrative expenses of the Plan, allocated to remaining participant accounts based on plan provisions, or used to reduce Company contributions. As of March 31, 2025 and 2024, forfeited non-vested accounts totaled \$28,399 and \$30,114, respectively with \$14,589 of forfeitures used to pay plan expenses for the year ended March 31, 2025.

Notes Receivable from Participants – Participants may borrow from their account a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant’s vested account balance. Loan terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at the prime rate as published in the Wall Street Journal Money Rate Section. Participants may only have one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans that are fully collateralized but treated as deemed distributions under Form 5500 reporting rules are carried to the Plan's books until a distributable event occurs based upon the terms of the Plan document, at which time the loan is treated as a distribution.

Investment and Administrative Expenses – The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

Payment of Benefits – Benefit payments are recorded when paid for financial statement purposes.

Subsequent Events – The Plan has evaluated subsequent events through December 1, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by Ascensus Trust Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the investment custodian of the Plan:

4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at March 31, 2025.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Common Collective Trust (CCT): The Vanguard Retirement Savings Trust held by the Plan is a collective investment trust that seeks stable returns comparable to those of short-term fixed income securities by investing in a combination of synthetic contracts, traditional insurance, and

bank contracts. The trust maintains a strict credit policy, investing with issuers rated AA and higher, and investing in funds that are rated investment grade or higher. The net asset value is based upon the fair value of the underlying investment comprising the trust less its liabilities.

Management has determined that the CCT qualifies for the net asset value practical expedient under FASB ASC 80, and, as such, the CCT is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment custodian imposes basic trading restrictions in which participants must wait 30 days before exchanging back and forth into the same fund on all investments. There are no unfunded commitments, or significant redemptions or other restrictions on the investments measured at net asset value per share using the practical expedient as of March 31, 2025 and 2024.

5. Administrative Expenses and Party-In-Interest Transactions

A transaction with certain service providers to the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to Ascensus, LLC, an affiliate of Ascensus Trust Company, the investment custodian, record keeper, and third-party administrator as of March 31, 2025. Of these fees, \$19,419 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Certain expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Additionally, certain plan investments are both held and managed by the investment custodian.

Notes receivable from participants are considered to be both party-in-interest and a related-party transaction.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the termination of the Plan, participants will become 100 percent vested in the employer's contributions, if any.

7. Tax Status

On June 30, 2020, the Internal Revenue Service stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the pre-approved plan provider believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
