## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Regent Care Center 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Regent Care Center 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following description of the Regent Care Center 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan was a defined contribution plan, effective December 1, 2000, that provided benefits to eligible employees, covering substantially all employees of Regent Management Services, LP (the "Company") who had attained the age of 18 years and had completed six months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Termination

On September 17, 2024, the Company exercised its right under the Plan to discontinue its contributions and to terminate the Plan, effective September 17, 2024. Upon termination, participants became 100% vested in their account balances with no additional contributions allowed to the plan. All plan assets were distributed to participants as of May 29, 2025.

#### Administration

The Company was responsible for the administration and operation of the Plan. An employee of the Company served as trustee of the Plan and Great-West Life & Annuity Insurance Company (the "Custodian") served as the custodian and recordkeeper. Alliance Benefit Group served as the third-party administrator.

#### Participant Contributions

Each year, participants could contribute pre-tax contributions up to 100% of their annual compensation and any bonus received, not to exceed the limitation set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Additionally, participants could make catch-up contributions (pre-tax contributions that exceed the annual elective deferral limit) during any calendar year ending on or after the participant's 50<sup>th</sup> birthday. Participants could also make rollover contributions from other qualified plans under ERISA. Participants directed the investment of their contributions into various investment options offered by the Plan.

#### Company Contributions

The Company made Safe Harbor matching contributions equal to 100% of the participant's elective deferrals that did not exceed 4% of the participant's compensation. During the period January 1, 2025 through May 29, 2025 and the year ended December 31, 2024, the Company made Safe Harbor matching contributions of \$0 and \$305,058, respectively. The Company, at its discretion, could also make matching contributions to all participants who had completed one year of service, equal to either a discretionary percentage of the participants' elective deferrals or a discretionary dollar amount, all of which must be applied on a uniform basis for all participants. The Company could also make non-elective profit-sharing contributions in an amount to be determined by the Company. Participants must have first completed one year of service to be eligible for non-elective profit-sharing contributions, but then must have subsequently completed 500 hours of service each Plan year and have been employed at the end of the year to be eligible to share in the allocation of such contributions. The Company made no discretionary matching or non-elective profit-sharing contributions during the period January 1, 2025 through May 29, 2025 and the year ended December 31, 2024. The Company made qualified non-elective contributions of \$0 and \$24,109 during the period January 1, 2025 through May 29, 2025 and the year ended December 31, 2024, respectively.

#### Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Earnings were allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' accounts in that fund. Upon the occurrence of a distribution event, the benefit to which a participant was entitled was the benefit that could be provided from the participant's vested interest in his or her account.

#### Vesting

Participants were immediately vested in their elective contributions, rollover contributions, Safe-Harbor matching contributions, and earnings thereon.

#### Vesting, continued

Vesting in Company non-elective profit-sharing contributions was based on a participant's years of continuous service as follows:

6	100%

Additionally, a participant became fully vested in Company discretionary matching and non-elective profit-sharing contributions and related earnings if such participant, while employed by the Company, became totally and permanently disabled, or upon death.

#### Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to or the lesser of \$50,000 or 50% of their vested account balance. A participant could have only one outstanding loan at any time. The term of the loan could not exceed five years or ten years if used for the purchase of a primary residence. The loans were secured by the vested balance in the participant's account and bore interest at a rate of prime plus 1.00%. Participant loans bore interest rates ranging from 4.25% to 9.50% at December 31, 2024. Principal repayment and the interest on outstanding balances were deducted ratably from the participants' pay.

#### Payment of Benefits

Upon termination of employment, retirement, death or disability, a participant (or his or her beneficiary in the event of death) was entitled to receive a distribution in the form of lump-sum payout, rollover, or, if the vested balance was greater than \$5,000, it could have been left in the Plan for future investment.

#### Forfeited Accounts

Plan forfeitures generally resulted from terminating participants that were not fully vested in their Company discretionary matching and non-elective profit-sharing contributions. Any forfeitures were used first to pay administrative expenses and then to reduce any employer contributions. For the period January 1, 2025 through May 29, 2025 and the year ended December 31, 2024, \$0 and \$8,803 of forfeitures were used to pay Plan expenses or reduce Company contributions, respectively. At May 29, 2025 and December 31, 2024, the forfeiture account balances were \$0 and \$5, respectively.

#### Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

#### Expense Offset Arrangements

Fees incurred by the Plan for investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan were prepared under the accrual method of accounting in accordance with U.S. GAAP.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affected the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments in pooled separate accounts were valued at fair value based on the quoted market prices of the underlying assets and the number of units owned by the Plan at the reporting date. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for the discussion of the fair value measurements.

The Plan invested in a fully benefit-responsive investment contract ("FBRIC"), which was accounted for at contract value. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to FBRICs because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Net appreciation in fair value of investments included realized gains and losses on investments sold during the year and unrealized appreciation of investments held at the end of the year. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

#### Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document.

#### Benefit Payments

Benefit payments were recorded when paid.

### 3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### 3. Fair Value Measurements, continued

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining the fair value of assets and liabilities, the Plan generally used the market approach, which used prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodology used by the Plan for investments measured at fair value. There had been no change in the methodology used at December 31, 2024.

*Pooled separate accounts:* Valued at the net asset value ("NAV") of units based on the quoted market price of the underlying securities and the number of units owned by the Plan at year end. The NAV, as provided by the Custodian, was used as a practical expedient to estimate fair value.

For the investments in pooled separate accounts as of December 31, 2024, there were not any unfunded commitments or redemption notice period and the redemption frequency was daily. Pooled separate accounts invested primarily in long-term bonds, domestic and international stocks, or single mutual funds. These funds sought both capital and appreciation and included a combination of assets, such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets. The allocation percentage to each asset type may be fixed, bounded by a range, or determined at the discretion of the manager. Managers of these funds reviewed market conditions regularly and refined the asset allocation mixture they believed would achieve the best risk adjusted performance based on the stated objectives and target allocations of the particular fund. The underlying investments held by each pooled separate account were traded on an active market.

#### **Fair Value of Investments in Entities That Use NAV**

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Update ("ASU") No. 2015-07, *Fair Value Measurements (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*, investments measured at NAV per share (or its equivalent) as a practical expedient, are not classified in the fair value hierarchy. At December 31, 2024, all investments were either reported at contract value or were in pooled separate accounts and were measured at fair value, using NAV as a practical expedient. Accordingly, no fair value hierarchy is presented.

### **4. Group Annuity Contract with Insurance Company**

The Plan invested in a fully benefit-responsive guaranteed interest contract with Empower. Empower maintained the contributions in the general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was reviewed on an annual basis for resetting. The general account did not permit the insurance company to terminate the agreement prior to the scheduled maturity date. As of and for the year ended December 31, 2024, the guaranteed interest was 1.25%.

As described in Note 2, this contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value approximated fair value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments. Certain events could have limited the ability of the Plan to transact at contract value with the issuer. Such events included, but may not have been limited to the following: 1) the complete or partial termination of the Plan, 2) the establishment of, or material change in, any Plan investment fund, or 3) an amendment to the Plan or a change in the administration or operation of the Plan. As discussed in Note 1 to the financial statements, all plan assets were distributed to participants as of May 29, 2025 as a result of the plan termination.

### **5. Information Certified by the Plan's Custodian (Unaudited)**

The Plan Administrator had elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at May 29, 2025 and December 31, 2024, and net appreciation in the fair value of investments, interest and dividends and interest income from notes receivable from participants for the period from January 1, 2025 through May 29, 2025 and the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **6. Tax Status**

The Plan adopted by the Company was a volume submitter ("VS") plan that was designed to comply with provisions of the IRC's Economic Growth and Tax Reconciliation Act of 2001 ("EGTRRA"). Such VS plans were pre-approved by the Internal Revenue Service ("IRS") by reference to the Cumulative List of Changes in Plan Qualification Requirements (the "Cumulative List") provided under EGTRRA. Because the Plan was a VS plan, the Company was not authorized to amend the Plan except to comply with changes in the Cumulative List. The VS Plan received a favorable determination letter from the IRS on June 30, 2020. Management of the Company and the Plan administrator believed the Plan complied with and was being operated in accordance with the applicable requirements of the IRC and therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

U. S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain Plan investments were in accounts managed by the Custodian, and the Plan issued notes receivable from participants. In addition, the Plan paid expenses to Custodian related to the plan operations. These transactions qualified as party-in-interest transactions, as defined by ERISA. However, such transactions were permitted under the provisions of the Plan and were exempt from the prohibition of party-in-interest transactions under ERISA.

### **8. Delinquent Participant Contributions**

During the year ended December 31, 2024, the Company determined that certain employee deferrals aggregating \$24,391 had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures were taken. The lost earnings for 2024 contributions, at less than \$100, were processed and deposited to participant accounts during 2025.

### **9. Subsequent Events**

The Plan management has evaluated subsequent events through December 12, 2025, which is the date the financial statements were available to be issued, and noted no significant events to be reported.
