To: IRS and Department of Labor,

I would like to file a reasonable cause letter regarding the delay in filing our 2024 Form 5500. The purpose of this letter is to provide an explanation and request for abatement of penalties to the late filing of Form 5500 for the plan year ending 2025. There was not an attempt to file directly against plan year 2024.

The delay in filing was due to administrative oversight. There has been a transition in administrative staff, and the filing deadline was missed due to miscommunication between the previous and current plan administrator. Once the oversight was identified we took immediate action to correct the issue and would like to submit the Form 5500 as soon as possible.

We have since implemented additional internal procedures to ensure future filings are completed. We did not willfully neglect our filing responsibilities, and we have made every effort to correct the oversight promptly. The late filing was due to reasonable cause and not due to willful neglect.

We respectfully request that any penalties assessed for the late filing of Form 5500 for the plan year ending 2024 be waived or abated under reasonable cause provisions.
