Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to the financial statements

Note 1: Description of Plan

The following description of the Milwaukee Academy of Science 403(b) Plan (the Plan) is provided for general informational purposes only. For a more complete description of the Plan and Plan investments, participants should refer to the Plan document and individual investment prospectuses. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined contribution plan originally effective July 1, 2005 sponsored by Milwaukee Science Education Consortium, Inc. (the Employer). The Plan covers substantially all employees of Milwaukee Science Education Consortium, Inc., (the Employee).

Eligibility

Employees may become a participant in the Plan for participant deferrals as soon as administratively feasible on or after the employee's first day of employment. The employee may become a participant in the Plan for Employer match and discretionary contributions after attaining age 21 and completing 1 year of service (defined as 1,000 hours of service).

Contributions

Each year participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the maximum allowable by the Internal Revenue Service (IRS). Participants may also contribute distributions from other qualified plans (rollovers). Participants may elect to have any portion, or all, of their contribution designated as Roth 403(b) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Auto-Enrollment - The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Employer Match - The Employer may, at its discretion, make a matching contribution to the Plan. For the year ended June 30, 2024 and 2023, the match contribution was 2.0% of participating employees' compensation.

Employer Discretionary Contribution - The Employer may also, at its discretion, make other non-elective contributions to the Plan. The Employer did not make any non-elective contributions to the Plan during the years ending June 30, 2024 and 2023.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching and discretionary contributions, and an allocation of the Plan's investment earnings (losses) and expenses paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings (losses) thereon. Participants hired prior to August 30, 2020 were immediately vested in the Company matching and discretionary contribution portion of their accounts, plus actual earnings thereon and will continue to be 100% vested. Effective September 1, 2020, the Plan was amended to include a five-year modified ERISA vesting schedule for all new participants eligible to participate in the Plan as follows:

3 years	50 %
4 years	75 %
5 years or more	100 %

Investment Options

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants may choose to direct their contributions and all of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Notes Receivable From Participants

Participants may receive a note from their account balance with a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

A participant who terminates employment or qualifies for withdrawal due to death or upon reaching age 59½, is entitled to receive his or her account in a lump-sum or partial payment. If a terminating participant's account balance does not exceed \$5,000, the Plan will distribute the benefit in a lump-sum as soon as administratively practicable. Account balances exceeding \$5,000 are paid at the participant's discretion. Under certain circumstances, participants may qualify to receive a hardship distribution.

Note 1: Description of Plan (Continued)

Forfeitures

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$2,060 and \$717, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the Plan document. During the years ended June 30, 2024 and 2023, no forfeitures were used to reduce Employer contributions or administrative expenses of the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC), which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Expenses directly attributable to a participant's transaction are deducted from the participant's account. Certain expenses of maintaining the Plan are paid by the Plan. Plan expenses paid directly by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through December 17, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Custodian

Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year), including investments held at June 30, 2024 and 2023, interest and dividend income and net appreciation in fair value of investments for the years ended June 30, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company, the Custodian of the Plan as of June 30, 2024 and 2023.

Note 4: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 5: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There have been no changes in the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6: Group Annuity Contract With Insurance Company

The FBRIC provides a guarantee of principal and interest which is guaranteed by the general account assets of Standard Insurance Company for the years ended June 30, 2024 and 2023. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. The crediting interest rate is set using a process determined by the issuer, but it may not be less than 1.00%. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The issuer may terminate the contract with 30 days' advance notice for reasonable cause which could result in a market value adjustment. The Plan Administration believes the occurrence of any event that may limit the Plan's ability to transact at contract value with participants is not probable.

Note 7: Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and overall market volatility, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 8: Party-In-Interest Transactions

Plan investments in pooled separate accounts, mutual funds and the FBRIC are managed by affiliates of Reliance Trust Company and Standard Insurance Company. These transactions, as well as administrative expenses and notes receivable from participants, qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

Note 9: Tax Status

The Sponsor adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
