Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note A – Description of Plan

The following description of The Earle Companies (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering substantially all employees of The Earle Companies (the Sponsor) and its affiliates, who have completed at least 250 hours of service during the first 3 months of employment or one year of service and are age eighteen or older. Employees who are residents of Puerto Rico or a non-resident alien that does not receive any compensation from U.S. sources, are excluded from participating in the Plan. Effective January 1, 2023, employees covered under a collective bargaining agreement are able to participate in the Plan once they meet the eligibility requirements as set forth in the Plan Document. Participation in the Plan is entirely voluntary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In January 2024, Ashland Contractors, Inc. 401(k) and Profit Sharing Plan merged into The Earle Operating Holding Company Inc. 401(k) Profit Sharing Plan. A special provision applies to the vesting provisions of the plan solely with respect to employees from Ashland Contractors, Inc., who were eligible to participate in the plan prior to January 1, 2024. Such employees shall be 100% vested.

On August 29, 2024, the Plan began the conversion process of transferring plan assets from Nationwide Trust Company, FSB to John Hancock Trust Company LLC and entered into a temporary black-out period. During this time, participants had restricted access to their accounts and were unable to obtain distributions from the plan. On September 27, 2024, the temporary blackout period ended, and full account access was restored to all participants.

Contributions. Participants may contribute both pre-tax and after-tax (Roth) deferral amounts up to the maximum percentage allowable not to exceed the limits of Code Sections 401(k). For 2024, the maximum deferral amount is \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled at a deferral rate of 6%, unless they affirmatively elect not to participate in the Plan. Automatically deferred contributions are invested in a qualified default investment arrangement until changed by the participant.

Contributions (continued). Each year, the Company has the option of making discretionary matching and/or profit-sharing contributions. In order to be eligible, participants must be employed on the last day of the plan year and complete one year of service. The 401(k) matching formula is a flexible discretionary match based on employee groups. Employer match contributions funded totaled \$1,179,847 and \$707,116 for the years ended December 31, 2024 and 2023, respectively. For 2024 and 2023, there were no profit-sharing contributions made. Contributions are subject to certain limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participant. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 8.50% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. All principal and interest payments made by the participant are credited back to the participant's account. Participants are limited to two outstanding loans in one calendar year.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or receive annual installments paid over a specific period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$53,812 and \$43,860, respectively. These accounts are first available to offset Plan expenses, and then if applicable, used to reduce any future employer contributions.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB and/or John Hancock Trust Company, LLC (the trustees of the Plan).

Note D – Guaranteed Investment Contracts

Nationwide Fixed Select

The Plan invested in the Nationwide Fixed Select Contract, a fully benefit-responsive investment contract prior to the transition to John Hancock Trust Company, LLC during September 2024. Nationwide maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 1.75%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not have a scheduled maturity date. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value, which approximated fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or the transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments. Certain events might have limited the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The net rate, credit rate and average yield earned are the same. The rate history for the contract is as follows:

John Hancock Stable Value Guaranteed Income Fund

As of September 5, 2024, the Plan invested in the John Hancock Stable Value Guaranteed Income Fund (the “Fund”), which is a fully benefit-responsive stable value investment option. The Fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The Fund is offered through a group annuity contract issued by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), which guarantees principal and accumulated interest for participating retirement plans. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value, which approximated fair value.

The Fund’s crediting rate is established by John Hancock and is generally set on January 1 and July 1 of each year and may also be reset on October 1 or April 1 if the weighted value of certain indexes changes by more than 2%. The crediting rate in effect is net of applicable fees and is subject to a minimum rate of 1%. Crediting rates may be adjusted prospectively in accordance with the terms of the contract.

Participant-initiated withdrawals (such as distributions, loans, hardship withdrawals, and transfers to non-competing investment options) are permitted at contract value, which represents contributions plus credited interest, less withdrawals. Contract value is the amount participants would receive under normal Plan operations, and accordingly, the Fund is reported at contract value in the accompanying financial statements.

Withdrawals initiated by the Plan Sponsor—such as plan-level withdrawals, plan terminations, mergers, layoffs, or other employer-driven events—may be subject to payment restrictions, a market value adjustment, or payout over a five-year period, depending on the terms of the group annuity contract. Transfers to competing funds are subject to a standard 90-day equity wash provision.

The primary risks associated with the Fund include capital preservation risk, contract risk (including insurer credit risk and the risk of payment restrictions or market value adjustments), equity wash restrictions, and risks associated with a privately offered stable value product. The guarantee of principal and interest is backed solely by the general account assets of John Hancock; if John Hancock were to fail, the guarantee may not be honored.

No events occurred during the year ended December 31, 2024 that would limit the Fund’s ability to transact at contract value.

Note E – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs

consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Mutual funds: Valued at quoted market prices in active markets. (Level 1 inputs)

Fully benefit-responsive investment contracts: Valued based on the contractual terms of the underlying guaranteed investment contract. (Level 3 inputs)

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F – Excess Participant Contributions Payable

The plan failed the discrimination test for the year ended December 31, 2023. Excess contributions amounting to \$966 are recorded as a liability in the accompanying statement of net assets available for benefits. Corresponding reductions were made to participant contributions in the amount of \$966.

The plan refunded these excess contributions in March 2024.

Note G – Related Party and Party in Interest Transactions

The Plan invests in select mutual funds and a group annuity contract managed by Nationwide Trust Company, FSB and John Hancock Trust Company LLC. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules. Participant loans also qualify

as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$62,963 for the year ended December 31, 2024.

Note H – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note I – Tax Status

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note J – Nonexempt Transactions

During 2024, the plan sponsor did not remit certain participant contributions and loan repayments to the plan in a timely manner, as defined by ERISA. These late contributions, in the amount of \$3,305 were remitted to the plan on July 28, 2025. The Company calculated lost earnings on this in the amount of \$359 and remitted this to the plan on October 17, 2025.

These contributions are considered nonexempt party-in-interest transactions and do not affect the tax status determination of the plan.

Note K – Plan Amendments

Effective September 1, 2024, the Plan amended its distribution provisions. Participant consent is required for any distribution in excess of \$5,000. If a participant does not make an affirmative election, the distribution amount will be automatically rolled over to an individual retirement account (IRA). The amendment also permits hardship distributions from all accounts, subject to the condition that hardship distributions are not available to individuals who are former employees at the time of the request.

The amendment also revised the Plan's In-Plan Roth Rollover provisions. The following limitations apply:

- The minimum in-plan Roth rollover amount is \$1,000.

- In-plan Roth rollovers may only be made from accounts that are 100% vested.
- No more than two in-plan Roth rollover transfers may be made during a plan year.
- In-plan Roth rollovers may only be made while the participant is actively employed.
- Outstanding loans may not be distributed as part of an in-plan Roth rollover.

Effective, October 1, 2023 the Earle Companies 401(k) Profit Sharing Plan was amended and renamed as The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note N – ERISA Bond Requirement

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets, and is

required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained bond coverage in the amount of \$500,000.

Note O – Subsequent Events

Subsequent events were evaluated through December 12, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, American Asphalt Company, Inc. 401(k) Profit Sharing Plan merged into The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan.

During 2024, certain participant elective deferrals intended for American Asphalt Company, Inc. 401(k) Profit Sharing Plan were inadvertently deposited into The Earle Operating Holding Company, Inc. 401(k) Profit Sharing Plan. The related amounts have been recorded as Other Liabilities in the accompany statement of net assets available for benefits as of December 31, 2024 and will be reclassified in 2025.
