We have performed audits of the accompanying financial statements of Meisner Electric, Inc. Employees Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of Meisner Electric, Inc. Employee Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on January 1, 1996, as a defined contribution plan. The Plan has since been amended and restated throughout the years to comply with certain tax legislation. The Plan is available to eligible employees of Meisner Electric, Inc. (the Company, Employer or Plan Sponsor). Eligible employees may enter the Plan and make deferral contributions after completing the service requirement of six (6) months of credited service during a plan year, and have reached the age of twenty-one (21), prior to April 8, 2024, and eighteen (18) years of age, effective April 8, 2024, have been regularly scheduled to work at least one thousand hours in a plan year, and are direct employees of the Company. The eligibility requirements of the Plan (as defined) are set by the Company.

The Plan's Trustee is Fidelity Management Trust Company (Fidelity or FMTC) (the Trustee). Fidelity holds the Plan's investment assets, executes investment transactions and provides recordkeeping services. The Company is the Plan Administrator

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Amendment

The Plan was amended, effective April 8, 2024, to change the eligibility to participate requirement from twenty-one (21) to eighteen (18) years of age.

#### Contributions

Each year, participants may voluntarily contribute up to 75% of their annual compensation, as defined, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may make Roth 401(k) elective deferrals in accordance with the Plan's provisions.

The Plan includes an automatic enrollment feature, whereby all newly hired eligible employees are automatically enrolled in the Plan at a deferral rate of 3%, upon meeting the Plan's eligibility requirements, unless the employee affirmatively elects not to participate in the Plan.

The Plan's provisions provide for Employer non-discretionary matching contributions. For the year ended March 31, 2025, the Employer matched 25% of the first 6% of eligible compensation, as defined, that a participant contributes to the Plan.

The Plan's provisions also provide for additional Employer matching contributions which are determined solely by the Employer's Board of Directors. There were no such contributions made to the Plan during the year ended March 31, 2025.

Contributions are subject to certain IRS limitations.

### Note 1 – Description of Plan, Continued

#### Participant accounts

Each participant account is credited with the participant's contribution and an allocation of: (a) the Employer's contributions (if any) and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options offered by the Plan.

#### Vesting

Participants are immediately vested in their individual contributions plus actual earnings or losses thereon. Participants vest in their Employer's contributions, plus earnings and losses thereon, based on years of credited service. A participant is 100% vested in their Employer's contributions after six years of credited service, based on a graded vesting schedule. Regardless of years of service, a participant is fully vested upon death, disability, reaching normal retirement (age 65), or upon termination of the Plan.

#### Forfeitures

Forfeited nonvested accounts may be utilized to offset certain Plan administrative expenses or reduce future Employer contributions. For the year ended March 31, 2025, forfeitures utilized to offset certain Plan administrative expenses or reduce Employer contributions, amounted to \$19,311. Unallocated forfeited amounts available to be utilized in future periods at March 31, 2025 and 2024, amounted to \$56,372 and \$53,087, respectively.

#### Notes receivable from participants

Plan participants may borrow from their accounts between \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participants vested account balance. Loan terms range from one year to five years, except in the case of loans for the purchase of a primary residence of the participant. Loans are secured by the balance in a participant's account and bear a reasonable rate of interest. Principal and interest are paid through regular payroll deductions and remitted to the Trustee. Any delinquent notes receivable from participants are reclassified as distributions.

#### Payment of benefits

Upon termination of service for any reason other than death, disability or retirement, a participant will receive payment of his or her voluntary contributions and related earnings and the vested portion of the Company's contributions. Terminated participants with vested account balances of \$5,000 or less will receive a distribution in a single lump-sum amount or through a direct rollover, as soon as practicable following the termination date. Upon death, disability or retirement, the participant or beneficiary will be entitled to the full value of his or her vested account. Participants may elect to take an in-service withdrawal of vested funds upon attainment of early retirement age of 59½, or if they have a proven financial hardship, as defined.

#### Plan administration

The Company is the Plan Administrator and, as such, controls and manages the operations of the Plan. The Company bears substantially all administrative expenses of maintaining the Plan in accordance with the Plan document. The Plan's investment assets are maintained by Fidelity who maintains the records of the participant data and invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of participants). Fees from covered service providers of the Plan are in compliance with the Department of Labor's regulations regarding ERISA Section 408(b)(2).

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's advisor and the Plan's Trustee.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. Any delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded at March 31, 2025 and 2024.

Payment of benefits

The Plan records benefits when paid.

Plan expenses

The Plan has classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Plan Sponsor and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, trustee, and third-party administrator fees. Certain participant directed transactions such as loan processing fees are charged directly to participants' accounts.

### Note 2 – Summary of Significant Accounting Policies, Continued

#### Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at March 31, 2025, that it would be unable to substantiate.

### Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants shown on the statements of net assets available for benefits as of March 31, 2025 and 2024;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended March 31, 2025; and
- Investment information included in the Schedule H, line 4i – Schedule of Assets (held at end of year) as of March 31, 2025, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 4 – Fair Value Measurement

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

### Note 4 – Fair Value Measurements, Continued

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at March 31, 2025 and 2024. During the years ended March 31, 2025 and 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended funds traded on national exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at those prices. The mutual funds are deemed to be actively traded.

*Money market fund* – institutional short-term investment vehicles valued daily with a NAV of \$1.

*Collective investment trust (CIT)* – is measured at the NAV of units held in the CIT. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT, less its liabilities. This practical expedient is not used if it is determined to be probable that the CIT will sell its underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV and there are no unfunded commitments related to this investment. This is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Refunds Payable for Excess Contributions

During the years ended March 31, 2025 and 2024, the Plan received contributions from participants in excess of Plan and IRS limitations totaling \$12,511 and \$16,796, respectively. Such amounts were refunded to participants in each of the subsequent years with a liability and corresponding reduction of contributions recorded in the year the excess contributions were received.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer's contribution portion of their accounts.

### Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Certain Plan investments are maintained, managed, and/or issued by Fidelity which serves as the Plan's Trustee and, therefore, these transactions qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

FMTC provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (MSA) between the Company and FMTC. FMTC receives revenue from mutual fund service providers for services FMTC provides to the funds. If the revenue received by FMTC from such mutual fund service providers exceeds the amount owed under the MSA, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to FMTC for administrative expenses not covered by revenue sharing.

Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services.

### Note 8 – Tax Status

The Plan uses a non-standardized pre-approved profit sharing plan with CODA plan document sponsored by Fidelity Management and Research Company, LLC. Fidelity Management and Research Company, LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.
