## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of the Safe-Harbor 403(b) Thrift Plan for Employees of Knute Nelson (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2025 (in liquidation) and June 30, 2024 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the period ended February 28, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 28, 2025 and June 30, 2024 and for the period ended February 28, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 2 and Note 10 to the financial statements, the Board of Directors of the Plan voted on November 25, 2024, to terminate the Plan and effective February 28, 2025, all assets were liquidated and transferred out of the Plan. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2024 financial statements to the liquidation basis of accounting used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## **Note 1 - Description of Plan**

The following brief description of the Safe-Harbor 403(b) Thrift Plan for Employees of Knute Nelson (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of Knute Nelson (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan.

The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

Employees are eligible to make salary deferrals into the Plan and receive employer match deferrals immediately upon employment. There is no minimum age or service requirement to make salary deferrals or to receive employer match deferrals.

### **Entry Date**

Employees may enter the Plan for salary deferrals on the first day of each pay period coinciding with or following the date they satisfy the Plan's eligibility requirements.

Employees may enter the Plan for the employer match on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan document. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Organization contributed a matching contribution equal to 100% of the amount of a participant's salary reduction contribution up to a maximum of 4% of compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated age-weighted fund until changed by the participant.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Organization matching contribution, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct employee and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions and the Organization's contributions, plus actual earnings thereon.

### **Plan Loans**

Participants investing through Mutual of America may use their vested balance to collateralize loans directly from Mutual of America outside the Plan. The balances of these loans are not included in the Plan and thus are not reported on the statement of net assets available for benefits. The loan balances collateralized by the Plan's assets as of February 28, 2025 and June 30, 2024, were \$0 and \$85,658, respectively.

### **Payment of Benefits**

Participants may elect to receive a lump-sum amount equal to the value of their vested interest, annuities, installment payments, or partial cash payments as defined in the Plan document upon retirement, termination of service, death, or disability. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ (employee contribution accounts only) or for hardship reasons as defined in the Plan document.

### **Plan Termination**

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. As detailed in Note 2 and Note 10, the Plan sponsor adopted a provision to terminate the Plan in November 2024. Effective February 28, 2025, Plan assets were distributed and Plan participants had to elect either to have their single sum distribution paid to them or to an eligible retirement plan in a direct rollover.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

As noted in Note 1 and Note 10, effective as of November 25, 2024, the Plan sponsor elected to terminate the Plan. The Plan was terminated and the Plan has changed its basis of accounting from the ongoing plan basis, used in presenting the June 30, 2024 financial statements, to the liquidation basis used in presenting the February 28, 2025 financial statements in accordance with Generally Accepted Accounting Principles (GAAP). The liquidation basis of accounting is a basis of accounting under GAAP for terminating plans. Under the liquidation basis of accounting, the Plan is required to measure assets to reflect the estimated amount of cash or other consideration expected to be collected in settling or disposing of those assets in carrying out the liquidation plan, accrue income that it expects to earn through the end of its liquidation when there is a reasonable basis for estimation and accrue costs it expects to incur when selling assets.

### **Excluded Contracts and Accounts**

The Plan Administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with Department of Labor Field Assistance Bulletin 2009-02 due to the following:

- The contract of account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact stopped making contributions to the contract or account before January 1, 2009;
- All the rights under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer; and
- The individual owner of the contract is fully vested in the contract or account.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

## **Contributions**

Participant contributions and the related Organization matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

## **Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

## **Expenses**

The Plan's expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with general administration of the Plan that are paid by the Plan, net of revenue sharing, are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses, net of revenue sharing, are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits in liquidation.

## **Subsequent events**

The Plan sponsor has evaluated subsequent events through December 2, 2025, the date which the financial statements were available to be issued.

## **Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

# Safe-Harbor 403(b) Thrift Plan for Employees of Knute Nelson

Notes to Financial Statements

February 28, 2025 (in Liquidation) and June 30, 2024 (Ongoing)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and June 30, 2024.

Pooled Separate Accounts: Valued at fair value based on the net asset value (NAV) of units as determined by the insurance company. The NAV is based on observable market prices of the underlying assets within the account, less liabilities. The NAV for the underlying asset of the account is a readily determinable measure of their fair value and is the basis for current transactions.

Guaranteed Interest Account: The fair value of the non-fully benefit-responsive guaranteed investment contract is measured using an income approach and discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

No investments were held at fair value as of February 28, 2025.

**Note 4 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements including investments held at February 28, 2025 and June 30, 2024, and net appreciation in fair value of investments, interest, and dividends, for the period ended February 28, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by Mutual of America Life Insurance Company, which received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Contract with Insurance Company**

The Organization entered into an investment contract with Mutual of America Life Insurance Company. As part of the contract, Mutual of America Life Insurance Company maintains a portion of the contributions in a guaranteed account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Mutual of America Life Insurance Company. The guaranteed account is included in the financial statements at fair value.

**Note 7 - Related Party and Party-in-Interest Transactions**

Certain Plan investments consisted of a guaranteed interest contract and pooled separate accounts managed by Mutual of America Life Insurance Company, the custodian. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions were exempt party-in-interest transactions under ERISA.

**Note 8 - Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Plan Amendments**

Effective October 30, 2024, the Plan adopted the mandatory provisions of the Secure 2.0 Act. The Plan would have been formally amended for the adoptions during the 2026 plan year but was terminated.

Effective January 1, 2025, the Plan was amended for the following:

- No new employees are eligible for the Plan.
- No additional employee or employer contributions are allowed.
- No new loans are permitted.
- No new rollover contributions are allowed.
- No transfer of funds to the Plan are allowed.
- The Plan is terminated.

**Note 10 - Plan Termination**

As detailed in Note 2, the Plan sponsor adopted a provision to terminate the Plan in November 2024. Effective February 28, 2025, Plan assets were distributed and Plan participants had to elect either to have their single sum distribution paid to them or to an eligible account plan in a direct rollover.
