**Opinion**

We have audited the accompanying financial statements of the Toyota of Escondido Employee Benefit Trust Employee Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the benefit obligations and net assets available for benefits of the Toyota of Escondido Employee Benefit Trust Employee Welfare Plan as of December 31, 2024 and 2023, and the changes in its benefit obligations and net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

**1. Description of Plan**

The following brief description of the Toyota of Escondido Employee Benefit Trust Employee Welfare Plan (the "Plan") is provided for general information purposes only. For additional information concerning the Plan's provisions, participants should refer to the Summary Plan Description.

**General**

The Plan is a self-insured health and welfare benefit plan established by Toyota of Escondido (the "Company" and "Employer") on January 1, 2007, to provide health, disability and death benefits to full-time employees and to their beneficiaries and covered dependents. The Company self-insures these benefits from the general assets of the Company as well as through insurance contracts to pay certain benefits to employees whose claims exceed certain amounts during any Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Benefits**

The Plan provides health benefits (medical, dental, vision and prescriptions) for eligible employees of the Company and their dependents. All covered employees receive \$10,000 of life insurance coverage. The life insurance benefit is funded by a life insurance contract purchased by the Plan.

In accordance with the Consolidated Omnibus Budget Reconciliation Act (COBRA), the Plan provides for continuation of benefits for certain terminated employees up to eighteen (18) months and certain dependents for a period of up to thirty-six (36) months depending upon eligibility. The cost of these benefits is paid by the terminated employees or their dependents.

The Plan includes a cafeteria arrangement maintained pursuant to Section 125 of the Internal Revenue Code ("flex plan") in which employees can elect to reduce their taxable salary in favor of purchasing non-taxable benefits including reimbursements of medical expenses and dependent child care expenses. The Plan also sponsors voluntary and supplemental benefits.

**Eligibility**

Those employees who are employed a minimum of thirty-two (32) hours per week are eligible to participate after ninety (90) days of service. An employee will become a participant in the Plan on the first day of the month immediately following the date the employee satisfies the eligibility conditions.

**Contributions**

The Company makes contributions to the Plan administrator to fund the health claims payable, insurance premiums, commissions, administrative fees, prepaid legal and other voluntary supplemental benefits. Additional contributions are received from terminated employees to continue their benefits under the COBRA provisions. The Company receives reimbursements from stop-loss carriers when claims exceed predetermined deductible thresholds, which are used to reduce the Company's losses.

**Contributions (Continued)**

The Plan receives contributions from the Employer based on withholdings taken from employees per salary reduction elections as provided by Section 125 of the Internal Revenue Code. These contributions are used to fund employees' medical reimbursement accounts, dependent child care, pre-paid legal and supplemental voluntary policies.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and Employer contributions were recognized in the period that contributions are due.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, claims incurred but not reported (IBNR), claims payable, liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Employer Contributions Receivable**

Employer contributions receivable represent the total of the health claims payable and estimated claims incurred but not reported, net of any cash held in the Plan. Employer contributions receivable totaled \$284,049 and \$174,014 at December 31, 2024 and 2023, respectively.

**Allowance for Doubtful Accounts**

Bad debts are recognized on the allowance method based on historical experience and the Plan administrator's evaluation of outstanding receivables. Management believes that all employer contributions receivable are fully collectible; therefore, no allowance for doubtful accounts was recorded at December 31, 2024 and 2023.

**Benefit Obligations**

Plan liabilities for estimated health claims incurred but not reported are calculated using a "lag matrix formula", which calculates the average lag time between when a medical claim is incurred and when it is actually submitted to the Plan for payment. This lag time is then applied to the claims submitted to the Plan for payment during the year and the result is the estimated health claims incurred during the Plan year that will be submitted for payment following the end of the Plan year and when it is actually paid by the Plan. Health claims payable and claims incurred but not reported totaled \$284,049 and \$174,014 at December 31, 2024 and 2023, respectively.

**Benefit Payments**

Benefits are reported when incurred.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through December 22, 2025, the date the financial statements were available to be issued.

**3. Administrative Expenses**

The Plan has an agreement with a third-party administrator to provide administrative services, claims adjudication, COBRA administration and other services. In addition, the Plan pays fees for services provided through other contracts. Administrative expenses consist of the following for the year ended December 31, 2024:

**4. Termination of the Plan**

Under certain conditions, the Plan may be terminated. Although the Company has not expressed an intention to do so, upon termination the remaining assets shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

**5. Income Taxes**

The Plan received a favorable determination letter from the Internal Revenue Service stating that the Plan meets the requirements for qualification under Section 501(c)(9) of the Internal Revenue Code and, as such, is exempt from taxation. The Plan has also received a determination letter from the Franchise Tax Board and is exempt under Section 23701(i).

The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

**6. Related Party and Party in Interest Transactions**

The Company withholds and remits participant contributions to the Plan, and pays all premiums and claims processed by the third-party administrator. In addition, the Plan has a number of service providers which are parties in interest under ERISA. These transactions are related party and party in interest transactions as applicable. The Company pays all of the expenses of maintaining the Plan.


