To the Board of Trustees of Project Renewal Inc., as Sponsor
of Project Renewal Employees' Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Project Renewal Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Project Renewal Employees' Retirement Plan (the "Plan") provides only general information. Readers should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General** – Effective January 1, 1998, Project Renewal, Inc. (the "Sponsor" or "Employer") established a defined contribution plan covering all employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments. Manhattan Bowery Management Corporation has also adopted this Plan as an Adopting Employer for the benefit of any of its employees who are eligible to participate. On January 1, 2016, the Plan was amended to permit hardship distributions under certain circumstances. The Plan is frozen, and no new participants can be enrolled into the Plan.
- B. **Eligibility** – All the employees are eligible except for the following ineligible classes of employees: (1) Union Employees; (2) Non-Resident Alien Employees; and (3) Leased Employees. All the eligible employees will be eligible to enter the Plan as a participant upon being credited with 1,000 hours of service within one-year of service.
- C. **Contributions** – Under the terms of the Plan, the Employer, at its discretion, contributes 5% of the total compensation of all eligible participants, except as noted in the Plan agreement. Effective March 2010, the Employer suspended its contributions to the Plan until further notice. Participants may contribute in the form of a rollover. There is no provision for any other employee contributions.
- D. **Participant Accounts** – Each participant's account is credited with the Employer's contribution, if any, and the Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. **Vesting** – After fulfilling the eligibility requirements, all participant accounts are immediately 100% vested.
- F. **Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. However, if the vested aggregate account balance of a participant is \$20,000 or less, he or she may borrow up to the lesser of \$10,000 or 100% of the participant's vested aggregate account balance if adequate security is provided on the loan amount. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 6.5 percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator, and are generally payable in installments over periods ranging from one to five years unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years. The loans are repaid quarterly by the employee directly to the Custodian. A loan that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.
- G. **Payment of Benefits** – The Plan provides for normal retirement at age 65. The Plan permits distribution to participants or their designated beneficiary upon termination of services, hardship, disability or death. Distribution of benefits to participants will be made in the form of an annuity, unless a participant specifically elects to receive their benefits in a lump-sum payment.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. **Basis of Accounting** – The Plan prepares its financial statements adhering to accounting principles generally accepted in the United States of America (“U.S. GAAP”) and uses the accrual basis of accounting.
- B. **Use of Estimates** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by investment advisors, the custodian and insurance company. See Note 5 for a discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

- D. **Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 since the Sponsor deemed it not necessary after evaluating criteria such as prior loss history, creditworthiness of the individual, etc. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded.
- E. **Payment of Benefits** – Benefits are recorded when paid.
- F. **Administrative Expenses** – Administrative expenses are paid by the Plan to the extent not paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.
- G. **Regulatory Compliance Affecting Retirement Plans** – The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution (“RMD”) rules, increasing the age from 70 ½ to 72 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

- H. **Reclassifications** - Certain items in the December 31, 2023 financial statements have been reclassified to conform to the December 31, 2024 presentation. These classifications had no impact on the Change in Net Assets Available for Benefits for the year ended December 31, 2023.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be distributed as prescribed by ERISA.

NOTE 4 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by State Street Bank and Trust Company ("State Street"), as the Trustee and Custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

NOTE 5 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

Guaranteed Income Fund:

The New York Life Guaranteed Interest Account (“GIA Fund”) is a fully benefit-responsive stable value product that guarantees principal and accumulated interest. Contract value, as reported by New York Life Insurance Company (“New York Life”), is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses. Guarantees are provided to participating retirement plans through a group annuity contract issued by New York Life. The investment contract is included in the financial statements at contract value. Contributions are directed to a broadly diversified fixed income portfolio within New York Life’s general account. Participants may deposit and withdraw on a daily basis at contract value. Participants may also transfer to other investment options in the Plan.

New York Life determines the minimum interest rate based on an interest rate formula. The minimum interest rate credited by New York Life to the GIA Fund is subject to change every six months, but will always be subject to a range between 1.00% and 3.00%. The annualized gross credit rate under the group annuity contract was 4.75% and 4.70% as of December 31, 2024 and 2023, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity-wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

The investment contract does not have any restrictions that impact the ability of the Plan to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance Company may not terminate the contract at any amount less than the contract value.

Investments carried at contract value amounted to \$503,210 and \$700,262 at December 31, 2024 and 2023, respectively.

NOTE 7 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments as of December 31, 2024 and 2023 are managed by State Street, the Trustee and Custodian of the Plan. Transamerica Retirement Solutions ("Transamerica") is the recordkeeper of the Plan. Gelman Pension Consulting, Inc. ("Gelman") is the consultant of the Plan.

Administrative fees paid by the Plan to Transamerica for recordkeeping and investment management amounted to \$25,784 and \$28,547 for the years ended December 31, 2024 and 2023, respectively. Administrative fees paid by the Plan to Gelman amounted to \$3,381 and \$3,324 for the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions. The Plan Sponsor pays directly certain administrative fees.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There has been significant volatility in the market in 2023 which has negatively impacted fair values. Management is unable to determine the impact on the Plan as of the date of this report.

NOTE 9 – TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the volume submitted Profit Sharing Plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specified to the Plan itself; however, the Plan administrator (and the Plan's tax counsel) believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated, for potential recognition and disclosure, events subsequent to the statement of net assets available for benefits date through December 23, 2025, the date the financial statements were available to be issued.
