INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of Project Renewal Inc., as Sponsor
of Section 403(b) Retirement Plan for Project Renewal, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Section 403(b) Retirement Plan for Project Renewal, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Section 403(b) Retirement Plan for Project Renewal, Inc. (the “Plan”) provides only general information. Readers should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan was adopted on August 1, 1982.

A. General

The Plan is a defined contribution plan covering all full-time employees of Project Renewal, Inc. (the “Sponsor” or “Employer”) except for those employees who are deferring into another plan established by the Employer under Section 403(b) or Section 457(b) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent amendments. Manhattan Bowery Management Corporation has also adopted this Plan as an Adopting Employer for the benefit of any of its employees who are eligible to participate.

B. Administration

The Plan is administered by the Sponsor, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

C. Contributions

Each year, participants may contribute up to any percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan-year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employees will become participants after they complete and return a salary deferral agreement to the Plan administrator. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Employer contributions are discretionary, which the Sponsor may elect to make to the Plan for any Plan year. Employer discretionary contributions are generally made as a percentage of salary and was last amended by the Plan on November 30, 2022. During the years ended December 31, 2024 and 2023, the Sponsor made Employer contributions of \$531,819 and \$502,740, respectively, to the Plan.

The Board of Directors of the Sponsor determines the amount the Sponsor will contribute to the Plan. During the years ended December 31, 2024 and 2023, the Plan Sponsor matched 100% of each individual employee's deferrals up to a maximum of 2.5% of the employee's salary per pay. An employee is eligible for employer matching contributions after completing at least 1 year of service. The employer contributions are fully vested when the participant has completed three years of vesting service. Contributions are fully and automatically vested when the participant reaches age 65, is totally and permanently disabled or upon death..

D. Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions, if any, and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Total value of employees' contributions balance is fully and immediately vested. The Employer match will be 100% vested after completion of three years of service.

F. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator, and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). The loans are repaid through payroll deductions for active employees and/or quarterly by the employee directly to the custodian. A loan that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.

G. Payment of Benefits

Upon termination of service due to death, hardship, disability, retirement or separation, a participant may elect to receive either lump sum, installment or partial cash payment.

H. Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$134,959 and \$43,591, respectively. These accounts will be used to reduce future Employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan prepares its financial statements adhering to accounting principles generally accepted in the United States of America ("U.S. GAAP") and uses the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determined the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 5 for a discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 since the Sponsor deemed it not necessary after evaluating criteria such as prior loss history, creditworthiness of the individual, etc. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

E. Payment of Benefits

Benefits are recorded when paid.

F. Expenses

Administrative expenses are paid by the Plan to the extent not paid by the Employer. Investment related expenses are included in net appreciation in fair value of investments. Expenses paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses.

G. Regulatory Compliance Affecting Retirement Plans – The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution (“RMD”) rules, increasing the age from 70 ½ to 72 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As participants are fully vested in their accounts, there would be no forfeitures in the event the Plan is terminated.

NOTE 4 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by State Street, the custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

State Street has certified to the completeness and accuracy of the investments included in the financial statements as of and for the years ended December 31, 2024 and 2023.

Investments of the Plan are subject to market volatility conditions that could substantially change their carrying values in the near term.

Interest and dividend income amounted to \$517,035 and \$403,185 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,254,627 and \$2,488,037, respectively.

Notes receivable from participants amounted to \$235,848 and \$231,316 as of December 31, 2024 and 2023, respectively, and interest income on notes receivable from participants of \$20,301 and \$11,115 for the years ended December 31, 2024 and 2023, respectively, have also been certified by the custodian.

NOTE 5 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The New York Life Guaranteed Interest Account ("GIA Fund") is a fully benefit-responsive stable value product that guarantees principal and accumulated interest. Contract value, as reported by New York Life Insurance Company ("New York Life"), is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses. Guarantees are provided to participating retirement plans through a group annuity contract issued by New York Life. The investment contract is included in the financial statements at contract value. Contributions are directed to a broadly diversified fixed income portfolio within New York Life's general account. Participants may deposit and withdraw on a daily basis at contract value. Participants may also transfer to other investment options in the Plan.

The investment contract does not have any restrictions that impact the ability of the Plan to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. New York Life may not terminate the contract at any amount less than the contract value.

New York Life determines the minimum interest rate based on an interest rate formula. The minimum interest rate credited by New York Life to the GIA Fund is subject to change every six months, but will always be subject to a range between 1.00% and 3.00%. The annualized gross credit rate under the group annuity contract was 4.75% and 4.70% as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity-wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Investments at contract value amounted to \$2,181,553 and \$2,648,277 as of December 31, 2024 and 2023, respectively.

NOTE 7 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments as of December 31, 2024 and 2023 are managed by State Street. State Street is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Transamerica Retirement Solutions ("Transamerica") is the recordkeeper of the Plan. Administrative fees paid by the Plan to Transamerica Retirement Solutions for recordkeeping and investment management amounted to \$152,862 and \$149,929 for the years ended December 31, 2024 and 2023, respectively. Administrative fees paid by the Plan to Gelman Pension Consulting, Inc. to \$20,806 and \$17,729 for the years ended December 31, 2024 and 2023, respectively. Certain funds provide revenue sharing of fees to the Plan participants.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated August 2, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 – REFUND OF EXCESS CONTRIBUTIONS LIABILITY

Subsequent to December 31, 2024, certain participant contributions were deemed to be excess contributions under the IRC. Such contributions and the related investment earnings thereon were refunded to Plan participants. A liability for excess contributions of \$1,018 was recorded in the Plan financial statements as of December 31, 2024.

NOTE 11 – DELINQUENT PARTICIPANT CONTRIBUTIONS AND LOAN REPAYMENTS

In accordance with the Department of Labor's Regulation 2510.3102, an employer is required to segregate participants' contributions and loan repayments from its general assets as soon as practical, but in no event more than the 15th business day following the end of the month within the time frame required by the Department of Labor ("DOL") under the Plan asset rules.

Participant contributions and participant loan repayments in 2024 amounting to \$74,415 were not remitted by the Sponsor to the recordkeeper within the period prescribed by the Department of Labor regulations. The Sponsor agreed to absorb all costs incurred by the Plan because of the untimely remittance of the participant contributions and loan repayments and will correct such delinquency through the Voluntary Fiduciary Correction Program of the Department of Labor.

NOTE 12 – SUBSEQUENT EVENTS

Management has evaluated, for potential recognition and disclosure, events subsequent to the statement of net assets available for benefits date through December 23, 2025, the date the financial statements were available to be issued.
