### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of ISS Action, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following description of ISS Action, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a plan covering all employees of ISS Action, Inc. (the “Company”) who have completed one year of service and attained at least 21 years of age. Employees who are covered by a collective bargaining agreement are excluded from Company non-elective contributions, Company safe harbor contributions, and employee elective deferrals. The Plan includes a provision for prevailing wage contributions that are required for employees working on certain government contracts or projects subject to prevailing wage laws, such as those under the Davis-Bacon Act or other local prevailing wage requirements. These employees are immediately eligible to join the Plan, however are restricted from all other portions of the Plan until the above requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

For 2024, participants could contribute 100% of pre-tax annual compensation up to \$23,000, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to \$7,500. Participants may also contribute funds from another qualified retirement plan or qualified individual retirement account (“rollover contributions”), subject to certain requirements. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes prevailing wage contributions in accordance with federal, state, or local prevailing wage laws. Employer contributions are made on behalf of employees working on government contracts or projects subject to prevailing wage requirements. These contributions are separate from employee elective deferrals and are based on the prevailing wage rates for the applicable projects. For 2024, the Company made prevailing wage contributions totaling \$1,365,051.

In addition, the Company may make discretionary matching contributions as a uniform percentage of a participant’s elective deferrals and non-elective contributions to the Plan in proportion to a participant’s compensation. In 2024, the Plan made non-elective safe harbor contributions equal to 3% of the participant’s contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and employer contributions (if any) and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant’s earnings or account balances, as defined. Forfeited balances of terminated participant’s non-vested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in prevailing wage, safe harbor, and their own contributions plus actual earnings thereon. Vesting in the Company’s matching and non-elective contributions portion of their accounts plus actual earnings thereon is determined under the following schedule:

A participant is also 100% vested under any of the following conditions:

- Death before retirement date;
- Disability before retirement date

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions. Loans must be repaid within 5 years unless the loan is used to purchase the participant's primary residence.

Payment of Benefits

On termination of service due to death or disability or retirement, a participant or his or her beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals or hardship withdrawals are permitted by the Plan.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,182 and \$1,030, respectively. Forfeitures of Company matching contributions of terminated participants' nonvested accounts may be used to pay administrative expenses on the Plan or used to reduce Company contributions. During 2024, forfeitures in the amount of \$1,566 were used to reduce Company contributions.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's net appreciation in the fair value of its investments consists of realized gains and losses and unrealized appreciation and depreciation on investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees charged directly to the borrowing participant's account are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays administrative expenses associated with the management of and professional services for the Plan. Certain administrative fees are paid from forfeited account balances while others, including fees for hardship withdrawals, are paid by the participants.

Subsequent Events

The Plan's management has evaluated subsequent events through December 3, 2025, the date the financial statements were available to be issued.

**Note 3 – Information Prepared and Certified by the Plan's Trustees**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (the trustees of the Plan).

**Note 4 – Fair Value Measurements**

FASB ASC Topic 820, Fair Value Measurements, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities

(level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Inputs other than quoted prices that are observable for the asset or liability and;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled separate accounts*

Investments in pooled separate accounts represent a unit of account whose per unit value is a result of the accumulated values of the underlying investments. The underlying investments are public investment vehicles valued using net asset value ("NAV") per share, as determined by the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value.

*Mutual funds*

These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair values of receivables approximate their carrying values.

**Note 5 – Guaranteed Investment Contract with Insurance Company**

In 2021, the Plan entered into a fully-benefit responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$2,387,700 for 2024 and \$2,777,129 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were willing to initiate permitted transactions under the term of the Plan. Contract value as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the Plan's ability to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 7 – Party-In-Interest Transactions**

Some of the Plan’s investments are shares of pooled separate accounts managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the trustee for other administrative expenses, management services, and bookkeeping services also qualify as party-in interest transactions.

The Plan issues loans to participants, which are secured by the balances in participants’ accounts. These transactions qualify as party-in-interest transactions.

**Note 8 – Termination of Plan**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 9 – Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 10 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.


