Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Digital Currency Group Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Digital Currency Group Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Digital Currency Group Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Digital Currency Group Inc. 401(k) Plan’s ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

1. Description of Plan

The following description of the Digital Currency Group Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established effective January 1, 2014, as restated October 1, 2022. The Plan covers all employees, excluding certain classes of employees, as set forth in the Plan document, of Digital Currency Group, Inc. (the “Company”, “Employer”, or “Plan Sponsor”) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan Administrator, defined as the Plan Sponsor and ForUsAll Advisor LLC, is responsible for oversight of the Plan. The Plan’s Investment Fiduciary, ForUsAll Advisor LLC, determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Administrator.

Contributions

Each year, participants may contribute up to 92 percent of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (“IRC”). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1 percent on the anniversary of their enrollment date until their deferral rate reaches 15 percent. Under a safe harbor provision, as defined in the Plan document, the Company matches 100% of participant contributions that are not in excess of 5% of the participant's compensation. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their accounts into various investment options offered by the Plan. The investment options available in the Plan shall include a cryptocurrency window as an investment option. The cryptocurrency window shall not be a designated investment option for a participant. Participants may not contribute more than 5% of their deferrals to the cryptocurrency window. As of December 31, 2024, participants have the following cryptocurrency options available: Bitcoin (BTC), Ethereum (ETH), Solana (SOL), Polkadot (DOT), and Cardano (ADA). A self-directed brokerage account option is also available to allow participants to select investment options not specifically offered by the Plan. Investments in the self-directed brokerage accounts include investments in registered investment companies (such as mutual funds or exchange-traded funds), common stock, and bank-issued money market securities (such as certificates of deposit). These are presented as participant-directed brokerage accounts in the supplemental schedules.

Vesting

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Forfeitures

The Plan maintains a forfeiture account which is used to pay administrative expenses and may be used to reduce future employer contributions. Forfeitures arise from various plan reconciliations, corrections, and returned allocations, as well as QMACs and other contributions. For the year ended December 31, 2024, forfeitures totaling \$2,349 were used to pay plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The maximum number of loans outstanding at any one time is 2. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the date of the loan, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Under the provisions of Secure 2.0 Act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Fiduciary determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through December 23, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to December 31, 2024 that would require adjustment to, or disclosure in, these financial statements, see Note 11.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Include money market funds, common stock, and unit investment trusts. Money market funds are valued at the quoted NAV of shares held by the fund. Other holdings are typically valued at the closing price reported in the active market in which the individual securities are traded.

Cryptocurrency: Valued based on the price reported on the Coinbase exchange for each respective coin held by the Plan. Cryptocurrency held by the Plan is deemed to be actively traded.

4. Concentrations

Four investments represented 19%, 13%, 11%, and 10% of net assets available for benefits as of December 31, 2024. Six investments represented 17%, 14%, 13%, 11%, 10%, and 10% of net assets available for benefits as of December 31, 2023.

5. Transfers Into or Out of the Plan

The Plan Sponsor sold off the CoinDesk, Inc and CoinDesk Indices, Inc division and their assets from the Plan. The assets related to these divisions were transferred to a new unrelated plan, Bullish 401(k) Plan. Net assets totaling \$5,882,046, which included \$114,759 of participant loan balances, were transferred out of the Plan on July 22, 2024 and August 9, 2024.

6. Information Certified by Trustee and Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, American Trust Company and Coinbase Custody Trust Company, the Trustee and Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

7. Related-Party and Party In-Interest Transactions

Certain Plan investments are managed by the Trustee and Custodian, and therefore, these transactions qualify as party in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

9. Tax Status

The Plan adopted a pre-approved plan offered by CCH Incorporated, DBA ftwilliam.com. The pre-approved plan received an IRS Determination Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Determination Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

9. Tax Status (Continued)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Cryptocurrency Risks

Custody of cryptocurrency assets

The Plan may hold its cryptocurrency assets in custody with financial institutions, digital asset custodians, trading counterparties (such as digital asset exchanges), or in private digital asset wallets controlled by the Trustee and Custodian. The Plan has group concentrations of credit risk with the third-parties that hold its assets in custody. In the event of a custodial party's insolvency, the Plan may be unable to recover some or all of its assets on deposit with that party, resulting in a partial or even total loss of capital. The Plan's digital assets may also be at risk of loss due to computer hacking, loss of passwords, compromised access credentials, malware or other forms of cyber-attack perpetrated against the party holding the private keys that control access to the Plan's digital assets. The Plan does not have access to the private keys held by third-parties. Digital asset trading platforms are also largely unregulated, provide limited transparency with respect to their operations and have come under increasing scrutiny due to cases of fraud, business failure and security breaches. Any such events could lead to a loss of the Plan's digital assets resulting in a partial or even total loss of capital. The Trustee and Custodian are responsible for taking such steps as they determine necessary, in their sole judgment, to maintain access to the private keys they control and prevent them from being compromised due to hacking, malware or other general security threats. In the event that their security systems are penetrated, any loss of the Plan's digital assets may adversely affect a participant's investment and could result in a partial or even total loss of capital. The blockchains that record digital assets and related transactions are also susceptible to certain security risks. For example, if one or more malicious actors obtained control of a sufficient number of network nodes on a given blockchain, or obtained other means of alteration, that blockchain could be unilaterally changed, potentially leading to stolen or compromised digital assets. Such a compromise could adversely affect a participant's investment and could result in a partial or even total loss of capital in cryptocurrency assets.

Volatility and speculation risk

Digital assets represent a speculative investment and involve a high degree of risk. A key risk in trading digital assets is the rapid and substantial fluctuation of their market prices. Digital assets have demonstrated significant volatility in the past. The value of the Plan's investments is directly correlated to the value of the digital assets it holds, and fluctuations in the price of digital assets could, therefore, adversely affect investors' capital. The price of digital assets may be affected by a wide variety of complex and difficult to predict factors such as digital asset supply and demand; rewards and transaction fees for the recording of transactions on the blockchain; difficulties with converting digital assets to fiat currencies; availability and access to digital asset service providers (such as payment processors), exchanges or other digital asset users and market participants; perceived or actual digital asset network or digital asset security vulnerability; network inflation levels; fiscal policy; interest rates; and political, regulatory, natural and economic events.

11. Delinquent Participant Contributions

For the years ended December 31, 2024, 2023, and 2022, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$210,358 for the year ended December 31, 2024 have been corrected outside of the Department of Labor Voluntary Fiduciary Correction Program as of the report date. Untimely remittances of \$11,960 were identified on the Schedule of Delinquent Participant Contributions in prior years and were not corrected prior to January 1, 2024. The prior year untimely remittances were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program in 2024. Additionally, the Company has compensated participants for lost earnings resulting from the delay in contributions.

For the year ended December 31, 2024, the Plan Administrator determined that the definition of compensation used by the Plan Sponsor for employee contribution deferrals was inconsistent with that of the Plan document and excluded compensation related to a relocation bonus and stock appreciation rights. The operational failure was identified in 2025 during the reconciliation of 2024 payroll. Corrective actions were performed and contributions were funded to the impacted participants' accounts. The contributions related to the operational failure have been included in the accompanying statements of Net Assets Available for Benefits as a qualified nonelective contribution.
