INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Colonial Metals Company Retirement Income Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Colonial Metals Company Retirement Income Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in liquidation as of February 28, 2025 and February 29, 2024, and the related statements of changes in net assets in liquidation for the years ended February 28, 2025 and February 29, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Colonial Metals Company Retirement Income Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of and for the years ended February 28, 2025 and February 29, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Colonial Metals Company Retirement Income Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1, 2, 5, and 9 to the financial statements, the Plan sponsor terminated the Colonial Metals Company Retirement Income Plan effective December 1, 2023, and Plan management determined liquidation is imminent. As a result, the Colonial Metals Company Retirement Income Plan changed its basis of accounting from the going concern basis to the liquidation basis which is used in presenting the 2025 and 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

1. Description of Plan

The following description of the Colonial Metals Company Retirement Income Plan (“Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a noncontributory defined benefit plan, which is funded exclusively by employer contributions. The Plan provides that all members of the collective bargaining unit between Local 1035 United Steelworkers of America, AFL-CIO and Colonial Metals Company (the “Company”) hired before May 1, 2011 were eligible participants in the Plan on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective July 1, 2011, the Company froze the accrual of benefits for employees employed on or after January 1, 2010. Also, each employee who was employed or reemployed on or after May 1, 2011 was not eligible to participate in the Plan. Benefits continued to accrue for those participants employed prior to these dates up through February 29, 2016. On February 23, 2014, an agreement was made to freeze the Plan effective February 29, 2016, and therefore the Plan was amended so that no additional benefits accrue for any participants after February 29, 2016. The Plan was most recently amended and restated effective March 1, 2016.

During 2018, the former Plan sponsor, Colonial Metals Company, ceased operations and closed its plant. Any unfunded liability remaining was to be satisfied by the Plan participating member, Columbia Reduction Company. Effective March 1, 2019, the Plan was amended to transfer sponsorship of the Plan from Colonial Metals Company to its controlled group affiliate, Columbia Reduction Company, the Plan sponsor. The Pension Benefit Guaranty Corporation (“PBGC”) was notified of these events as required and approved the change in sponsorship.

The Company terminated the Plan effective December 1, 2023, the “Termination Date” (see Notes 2, 5, and 9). As part of the termination, provisions for providing a lump sum payout window in conjunction with the Plan termination were added to the Plan.

Benefits Provided to Participants

Normal Retirement Benefit – Retirement income payable on the basis of the joint and survivor form (if married) or on the normal form (if single or if elected), as determined under the benefit formula and which is based on a factor multiplied by the number of the participant’s years of credited service as defined in the Plan document. Normal retirement age is the date a participant attains the age 65 and has participated in the Plan for five years.

Early Retirement Benefit – A participant is eligible for early retirement after attainment of age 55 and completion of ten years of vesting service. The benefit is the actuarial equivalent of the pension accrued to the date of early retirement; however, if the participant is age 62 with 25 years of credited service, the early retirement benefit shall be unreduced.

Pre-Retirement Spouse Benefit (Survivor Benefit) – There is a pre-retirement spouse benefit that is fifty percent of the pension benefit accrued to date of death reduced by appropriate early retirement and joint survivor factors, provided participant is eligible for early retirement and married one full year prior to death.

Death Benefit – Fifty percent of retirement pension benefit will be paid to the surviving spouse, assuming they have been married at least one year. The amount of the survivor benefit is equal to the 50% survivor benefit payable under the joint and 50% survivor pension option, based upon the pension accrued to the date of death and reduced for early commencement of benefits, if applicable. If the participant is not married or has not been married for a complete year at the time of death, no benefit will be paid.

Disability Benefit – If a participant is actively employed and has completed ten years of benefit service, they will be entitled to receive a disability benefit if they have been totally and permanently disabled for six months. The benefit will be payable until the participant recovers, dies or attains their normal retirement date. The monthly

disability benefit will be equal to the normal retirement benefit accrued to the date of disability, reduced by the monthly value of any periodic payment provided under workers' compensation.

Vesting

Vesting refers to a participant acquiring a non-forfeitable right to receive retirement benefits. Vesting is based on years of credited service. Participants are vested after completing five years of credited service.

Funding Policy

All contributions to the Plan are made by the Plan sponsor based upon an annual actuarial valuation. The Plan sponsor's policy is to fund the Plan with contribution amounts required under the ERISA minimum funding requirements. No contributions were made to the Plan for the years ended February 28, 2025 and February 29, 2024 as the minimum funding requirements were met.

Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

During 2023, the Company began the process of terminating the Plan in a standard termination. The Company set December 1, 2023 as the termination date (see Notes 2, 5 and 9) and began providing participants with the formal "Notice of Intent to Terminate" beginning September 29, 2023. As part of the Plan, all participants became fully vested in their accrued benefit.

The Plan termination did not impact the amount of benefits that participants were due under the Plan. All participants were 100% vested in their benefit earned under the Plan. Active employees and deferred vested participants had the option to elect a lump sum distribution. Participants who did not elect the lump sum had their benefit converted to a deferred annuity contract placed with an insurance company.

During the year ended February 29, 2024, as part of the Plan termination, the Plan issued lump sum payments to certain participants who were eligible and elected to receive such payments. During the year ended February 29, 2024, the Plan disbursed \$311,023 of lump sum payments to 14 participants. Additionally, in March 2024, the Plan disbursed \$338,828 of lump sum payments to 15 participants.

In connection with the Plan termination (see Notes 2, 5 and 9), the Plan distributed \$4,792,154 to CMFG Life Insurance Company in April 2024 for the provision of benefits related to participants who did not elect a lump sum and therefore had their benefit converted to an annuity contract placed with an insurance company. Under this annuity contract, CMFG Life Insurance Company assumed the liability for the remaining deferred participants effective June 1, 2024 and became responsible for monthly benefit payments to participants effective with the participants' June 1, 2024 monthly benefit payment. The Plan was no longer obligated to pay any benefits to these participants after May 31, 2024. In June 2024, the Plan received a refund from CUNA Mutual Group of \$51,325 for reimbursements of benefit payments on behalf of the insurance company after June 1, 2024 and this amount was recorded as an offset to the benefits paid to insurance carrier and/or PBGC for the provision of benefits in the accompanying statement of change in net assets in liquidation for the year ended February 28, 2025. As part of the Plan termination, the Plan also distributed \$26,833 to the PBGC for the benefit of missing participants which is included in the benefits paid to insurance carrier and/or PBGC for the provision of benefits.

After the completion of these settlement transactions, the Plan had remaining assets. During December 2024, the Plan transferred the remaining balance of \$362,980 to the Plan sponsor. After this transaction, the Plan had no assets. The Plan sponsor is responsible for determining if a *Form 5330 Return of Excise Taxes Related to Employee Benefit Plan* is required to be filed and paying any related excise tax on reversion of qualified plan assets to the employer.

The Plan sponsor filed a Form 501, Post Distribution Certificate, with the PBGC. The PBGC may audit a sample of plans terminating and the Plan sponsor is required by law to maintain and preserve Plan records relating to the termination for six years after the Form 501 is filed with the PBGC. Plan management believes with the action previously described, it has fully fund the Plan on a termination basis and all benefit payments have been made to participants or transferred to CMFG Life Insurance Company. However, management expects to work with the PBGC and the IRS if any additional actions are necessary related to the Plan termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

Effective December 1, 2023, the Company elected to terminate the Plan (see Notes 1, 5 and 9), and the Plan administrator determined liquidation was imminent. Accordingly, the accompanying statements of net assets in liquidation as of February 28, 2025 and February 29, 2024, and statements of changes in net assets in liquidation for the years ended February 28, 2025 and February 29, 2024 are prepared on the liquidation basis of accounting.

Adjustment to the Liquidation Basis

Under the liquidation basis of accounting, an entity accrues costs and income that it expects to incur or earn through the end of its liquidation if and when it has a reasonable basis for the estimation. Adjustment to the liquidation basis can include estimated contributions, payments to participants upon liquidation, fees that will be incurred, interest expected to be earned on interest-bearing investments held as of the statement of net assets date as a result of the Plan's termination, as well as estimated premiums paid or refunds from insurance carriers for the provision of benefits, legal fees, actuary fees, and audit fees. As of February 29, 2024, the Plan did not believe it had a reasonable basis to accrue costs, income or estimated payments to participants upon liquidation and no such adjustments were recorded in connection with the Plan's adoption of the liquidation basis of accounting during the year ended February 29, 2024. As of February 28, 2025, all amounts had been distributed by the Plan and no further estimates of income or expenses were deemed necessary. The actuarial present value of accumulated plan benefits has also been presented on a liquidation basis and the actuary utilized assumptions based on the final lump sums, annuity payments and group annuity contract (see Notes 1 and 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by trustees, custodians, and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan may pay certain direct expenses of the Plan. Other direct expenses of the Plan are paid by the Plan sponsor and excluded from these financial statements. Certain investment-related expenses are included in the

net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets in liquidation.

3. Information Certified by a Qualified Institution

The Plan administrator, having determined that it is permissible in the circumstances, elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental of reportable transactions, was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by American Trust, a qualified institution and subsidiary of EdgeCo Holdings, L.P. which acquired Unified Trust Company, N.A. ("UTC"), also a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments at fair value, and payables due to broker, as shown in the statements of net assets in liquidation as of February 28, 2025 and February 29, 2024.
- Investment activity, including net appreciation (depreciation) in fair value of investments, and dividend and interest income, as shown in the statements of changes in net assets in liquidation for the years ended February 28, 2025 and February 29, 2024.
- The information in the schedule of reportable transactions for the year ended February 28, 2025, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at February 28, 2025 and February 29, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange

Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Group annuity contract: Valued at contract value, which utilizes a cost-based approach as significant inputs (observable or unobservable) are not available. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the termination of the Plan, there were no assets with fair value measurements held by the Plan as of February 28, 2025.

The Standard Stable Asset Fund II (“Stable Asset Fund”) is a group annuity contract that offers a full guarantee on principal and interest by the Standard Insurance Company. The Stable Asset Fund’s interest rates are adjusted to market quarterly. Contract value, which represents net contributions plus interest at the contract rate, approximates fair value. There are not any specific securities in the general account that back the liabilities of this annuity contract and it would be inappropriate to look to the market value of the securities within the issuer's

general account to determine a fair value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period as outlined in the group annuity contract. This product is not a traditional guaranteed income contract and therefore there are not any known cash flows that could be discounted. As a result, the fair value amount shown is equal to the contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. Due to the Plan termination and liquidation of assets, during March 2024, the Plan liquidated the remaining assets held in the Stable Asset Fund and incurred a market value adjustment of (\$86,557). Such amount was included in the net appreciation (depreciation) in fair value of investments in the accompanying statement of change in net assets in liquidation for the year ended February 28, 2025.

5. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' years of service on the date the benefit information is presented (the valuation date). Benefits payable under all circumstances (e.g. retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to employee service rendered prior to the valuation date. On February 23, 2014, an agreement was made to freeze the Plan effective February 29, 2016, and therefore the Plan was amended so that no additional benefits accrue for any participants after February 29, 2016.

The actuarial present value of accumulated plan benefits is determined by the Plan's consulting actuary and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits earned by participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The foregoing assumptions are based on the liquidation basis. As detailed in Notes, 1, 2 and 9 to the financial statements, the Company terminated the Plan effective December 1, 2023, which indicates that the Plan is not a going concern. As a result of the Plan termination, subsequent to March 1, 2023, different actuarial assumptions and other factors were applicable in determining the actuarial present value of accumulated plan benefits. More specifically, since the final liability of the Plan was known, the final lump sums, annuity payments and group annuity contract purchase premium were utilized to develop the actuarial present value of accumulated plan benefits in liquidation as of March 1, 2024 and the changes in the actuarial present value of accumulated plan benefits in liquidation for the period ended March 1, 2024.

As of February 28, 2025, there are no remaining accumulated plan benefits due to distributions as a result of the Plan termination. During the year ended February 28, 2025 benefits paid to participants were \$410,198 and benefits paid to insurance carrier and/or PBGC were \$4,767,662. The change from the actuarial present value of accumulated plan benefits as of March 1, 2024 and the actual payment of benefits during the year ended February 28, 2025, consists primarily of additional interest accumulated.

6. Tax Status

The IRS has determined and informed the Company by a letter dated November 13, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter (see Notes 1 and 9). The Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 28, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to February 28, 2022.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

As of February 28, 2025 and February 29, 2024, the Plan had investments of \$0 and \$1,185,899, respectively, concentrated in a group annuity contract (see Note 4).

8. Related Party and Party-in-Interest Transactions

Transactions involving investments managed by affiliates of American Trust, the trustee, are considered party-in-interest transactions. UTC is an affiliate of American Trust. Direct expenses paid to American Trust, UTC or affiliates, totaled \$16,237 and \$39,384 for the years ended February 28, 2025 and February 29, 2024, respectively. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

9. Plan Amendments

In September 2023, the Company approved a resolution to terminate the Plan with an effective date of December 1, 2023 provided that such termination is carried out in accordance with the terms of the Plan, ERISA, and the applicable provisions of the IRC (see Notes 1, 2 and 5). As a result, effective December 1, 2023, the Plan was amended to include the following:

- Reflect provisions of the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act”) and SECURE Act 2.0;
- Fully vest all affected participants under the Plan who were not previously vested;
- Update the required minimum distribution age;
- Update the Plan provisions for handling “missing” participants;
- Provide for a lump sum election window upon Plan termination; and
- Make other general administrative changes.

10. Subsequent Events

The Plan has evaluated subsequent events through December 23, 2025, the date the financial statements were available to be issued.
