Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ODA Primary Health Care Network 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements December 31, 2024

Note 1 - Description of Plan

The following description of the ODA Primary Health Care Network 403(b) Plan (the "Plan"), provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a contributory Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Opportunity Development Association Primary Health Care Network, Inc. (the "Company"). The Plan was adopted on August 1, 2014 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Nonresident aliens are excluded from participation in the Plan. The Company's Board of Directors are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Eligibility

All eligible employees of the Company may participate in the Plan pursuant to IRC Section 403(b)(12)(A)(ii), also known as the Universal Availability rule. Universal Availability states that if an organization permits one employee to defer their salary into a 403(b) plan, the organization must extend this offer to all employees of the organization. Eligible employees may begin to make salary deferral contributions to the Plan immediately following their date of hire. Participants are eligible for any discretionary matching contributions and discretionary nonelective contributions on the first day of the quarter following the completion of one year of service (with a minimum of 1,000 hours). Participants must also be actively employed on the last of the Plan year to share in an allocation of any discretionary nonelective contributions. Employees covered by a collective bargaining (union) agreement and leased employees are excluded from receiving any Company contributions.

Contributions

Each year, participants may make salary deferral contributions to the Plan up to 100% of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have completed 15 years of service, as defined, are eligible to make special long service catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its sole discretion, elect to make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the Company elected to not make any discretionary matching contributions to the Plan. The Company may also elect to make discretionary nonelective contributions to the Plan. For the year ended December 31, 2024, the Company elected to not make any discretionary nonelective contributions to the Plan. Employees covered by a collective bargaining (union) agreement, leased employees and per-diem employees are excluded from receiving any Company contributions. Participants also direct the investment of any Company contributions. All contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and any discretionary matching contributions, as well as an allocation of any discretionary nonelective contributions and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are incurred by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their salary deferral contributions and any rollover contributions, plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement (defined by the Plan as age 65), participants shall become 100% vested in the Company's discretionary matching and nonelective contribution portions of their account. For all other participants, vesting in the Company's discretionary matching and nonelective contribution portions of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of benefits

Upon termination of service for any reason, participants with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of the vested interest in their account. For participants with an account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator, unless otherwise directed by the participant. Participants with an account balance greater than \$5,000 will have the option to receive their vested benefit in the form of a lump-sum distribution or defer payment of benefits until a later date.

Withdrawals from the vested portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who are at least 59½ years of age or become disabled may withdraw all or a portion of their vested account balance prior to termination. Participants may make withdrawals from the rollover portion of their account at any time.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6 and \$5, respectively. Forfeited nonvested accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan. There were no forfeited nonvested accounts utilized by the Plan for the year ended December 31, 2024.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Noninterest-bearing cash

Assets of the Plan that are not invested by the custodian may, at times, be temporarily held in a noninterest-bearing cash account. These temporary cash accounts are not subject to federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

Contributions

Contributions from Plan participants and any discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Any discretionary nonelective contributions from the Company are recorded in the year in which the contributions are earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration and recordkeeping, notes receivable from participants and certain

investment advisory fees are charged directly to the participant's account and are included in administrative expenses. Indirect investment-related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation.

Subsequent events

The Plan has evaluated subsequent events through December 23, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. The mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued at the NAV of units of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption, the fund reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Related party transactions and party-in-interest transactions

Plan investments include shares of mutual funds held by Advisor Trust, Inc. AdvisorTrust, Inc. is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Advisor Trust, Inc. has contracted with Standard Insurance Company to provide Plan participants with a stable value fund investment option, therefore, these transactions also qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. The Plan also made direct payments to its third-party administrator and investment advisor, also considered parties-in-interest, for certain administrative and investment advisory fees totaling \$49,779 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by CCH Incorporated, DBA ftwilliam.com. CCH Incorporated, DBA ftwilliam.com received an advisory letter dated March 31, 2017 in which the Internal Revenue Service ("IRS") stated that the volume submitter 403(b) plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by AdvisorTrust, Inc., the custodian of the Plan.
