### Note 1 - Plan Description

The following description of The Don Lee and Affiliates 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a single-employer defined contribution plan covering all eligible employees of Don Lee Distributor, Inc. (the "Company"). All employees, excluding those covered by a collective bargaining agreement, temporary employees, or leased employees, are eligible and automatically enrolled at a minimum of a 2 percent deferral. Participants are auto-escalated annually by 1 percent until reaching 10 percent. These eligible participants are also immediately eligible to receive discretionary employer matching contributions. Employees who have attained the age of 21 and have completed at least one year of service are eligible to participate in discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary 401(k) contributions pre-tax up to a maximum of 80 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Effective January 1, 2024, the Company added post-tax contributions and changed its employer matching contribution policy from 100 percent of the participant's contribution, up to a maximum of \$2,000 to 100 percent of contributions up to 3 percent of compensation and an additional 50 percent on the next 3 percent of compensation, which amounts to a maximum of 4.5 percent of compensation. The Company, at its discretion, may make additional profit-sharing contributions to the Plan at an amount equal to a percentage of the participant's annual eligible compensation for the profit-sharing contribution, as defined by the Plan. The Company approved a profit-sharing contribution of 2.6 percent of eligible employees' compensation in 2024, which amounted to \$347,000.

Certain participant contributions and loan repayments in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions, loan repayments, and applicable lost earnings during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 20 percent after two years of service and an additional 20 percent each successive year through year six, at which time they are fully vested.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

### Note 1 - Plan Description (Continued)

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain restrictions, including maximum and minimum amounts prescribed in the Plan. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are first used to pay the administrative expenses of the Plan, secondly used to reduce future company contributions, and lastly allocated among the accounts of the participants.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

#### ***Party-in-interest Transactions***

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company and qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Participants are charged directly for fees related to notes receivable.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including December 15, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the inputs and valuation techniques used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs used quoted prices in active markets for identical assets that the Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
