Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Skillz Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS**

NOTE 1 - DESCRIPTION OF THE PLAN:

The Skillz Inc. 401(k) Retirement Savings Plan (the Plan) is a contributory, defined contribution plan formed effective January 1, 2017, for the benefit of the employees of Skillz Inc., dba Skillz.com (the Company). In connection with the Company's acquisition of another company, the acquired company employees became eligible to participate in the Plan effective January 1, 2022. Effective March 15, 2022, the acquired company's 401(k) plan was merged into the Skillz Inc. 401(k) Retirement Savings Plan.

The Plan is administered by the Company and effective October 1, 2019, the Plan assets are held in a trust and administered by Fidelity Management Trust Company (Fidelity). Prior to October 1, 2019, the Plan assets were held in trust by Reliance Trust, and the Plan was administered by ADP Retirement Services (ADP). The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes a 401(k) feature whereby employees may contribute a portion of their pre or post tax compensation, as defined in the Plan and subject to statutory limitations. Catch-up contributions are permitted for those participants who are at least 50 years of age during the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Beginning January 1, 2022, the Company match was established at 100% of the first 3% deferred by participants. Contributions of employee deferrals and the match are made with each payroll, and a match true-up is computed annually.

Employees are eligible for participation in deferrals and employer contributions upon attaining 21 years of age. If the employer makes a nonelective employer contribution, as defined, the employee must be employed on the last day of the year and have earned at least 1,000 hours of service in that Plan year to receive an allocation of the contribution. There was no such nonelective contribution declared in respect of 2024 and 2023.

Each participant's account is credited with the participant's contribution, and allocations of the related matching contribution, if any, and net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Effective October 1, 2019, participants are immediately vested in their voluntary contributions and the employer matching contribution, plus actual earnings thereon. If an employee terminated employment prior to October 1, 2019, the discretionary employer contribution is subject to a graded vesting schedule, with 100% vesting achieved after 6 years of service are earned. Unvested benefits of terminated participants are forfeited and used to reduce employer matching contributions or to pay administrative expenses of the Plan.

Note 1 – continued:

In addition to vesting, various corrections to deferrals and match may result in additional forfeitures. As of December 31, 2024 and 2023, the balance in the forfeitures account is \$29,712 and \$28,185, respectively, and \$0 was used in 2024 to pay expenses or fund the employer match.

Vested benefits are payable upon the retirement (normal retirement is defined as age 62), death, disability or termination of a participant. In-service withdrawals are permitted in cases of hardship, or upon the participant attaining age 59-1/2. In-service withdrawals of amounts rolled in from other plans are also permitted. In the event of termination of the Plan, the amounts in each participant's account shall be fully vested and nonforfeitable and shall be distributed upon liquidation of plan assets.

Employee contributions, employer matching contributions, if any, and earnings thereon are invested as directed by the participants. The investment options include various mutual funds. Participants may change their investment options at will.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**Valuation of investments-**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation (depreciation) in fair value of investments represents the net increase (decrease) in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative costs of the Plan are borne by the sponsor. In addition, the sponsor may provide services to the Plan for which the sponsor receives no compensation. The costs borne by the Plan include investment advisory fees, third party administration and other direct and indirect administrative costs. These costs are presented net of revenue sharing and other arrangements.

Notes receivable from participants-

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect at loan inception.

Note 2 – continued:

Principal and interest are paid through payroll deductions. Because of the adequate collateral at loan inception, no allowance for credit losses is recorded.

Use of estimates-

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in valuation methodologies in 2024 and 2023.

Money market and mutual funds. Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

The Plan’s current trustee is Fidelity Management Trust Company. The following information included in the accompanying 2024 and 2023 financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

1. Value of investments as of December 31, 2024 and 2023,
2. Investment income earned for the year ended December 31, 2024,
3. Notes receivable from participants as of December 31, 2024 and 2023, and,
4. Interest income on notes receivable from participants for the year ended December 31, 2024.

NOTE 5 - FEDERAL INCOME TAXES:

The Plan has adopted a volume submitter plan created by Fidelity. The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020, that the Plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Plan’s management believes that the Plan is designed and currently being operated in compliance with the applicable IRC requirements. Therefore, the Plan’s management believes that the Plan is qualified and the related trust was tax exempt as of the financial statement date.

There are no Internal Revenue Service examinations in progress; tax years of the Plan for 2021, 2022 and 2023 remain open for examination. See Note 9.

NOTE 6 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS:

Fidelity currently acts as trustee for investments of the Plan. In addition, Fidelity provides services, such as recordkeeping and preparation of the Form 5500. Therefore, transactions with Fidelity, in addition to transactions with the Plan sponsor, qualify as party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 9 - PLAN COMPLIANCE CONTINGENCY:

During Plan Years 2017 to 2021, the Plan operationally excluded bonuses in eligible compensation for purposes of determining employee deferrals and employer matching contributions although the written Plan terms included bonuses from such compensation. In June 2023, management of the Plan filed an application with the Internal Revenue Service Voluntary Correction Program (VCP) to propose correcting this error by conforming the Plan's written terms to the Plan's operational practice. The IRS informed the Plan in a letter dated May 8, 2025, that the proposed correction has been accepted. Management completed the correction on July 30, 2025.

NOTE 10 - SUBSEQUENT EVENTS:

Management has evaluated subsequent events through December 22, 2025, the date the financial statements were available to be issued.
