Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of National Domestic Violence Hotline 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025 to July 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of National Domestic Violence Hotline 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of July 31, 2025 and December 31, 2024, and for the period January 1, 2025 to July 31, 2025, stating that the certified investment information, as described in the Certified Investment Information footnote to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Domestic Violence Hotline 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As explained in the footnotes to the financial statements, the Plan was merged into the WELLthBuilder II Pooled Employer Plan effective August 1, 2025. Our opinion has not been modified in respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about National Domestic Violence Hotline 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Plan Description

The following description of the National Domestic Violence Hotline 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan which was adopted on January 1, 2018 to provide retirement benefits for employees of the National Domestic Violence Hotline (the "Plan Sponsor"). The Plan was restated effective May 1, 2021. In connection therewith, the Plan covers substantially all employees except union employees, nonresident aliens, leased employees, and residents of Puerto Rico, who are age eighteen or older and have completed two months of service ("participants"). Prior to May 1, 2021, the service requirement was one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective August 1, 2025, employer and employee contributions to the Plan ceased as a result of the merger of the Plan into the WELLthBuilder II Pooled Employer Plan.

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may also make after-tax Roth 401(k) contributions and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees are automatically enrolled in the Plan upon meeting the eligibility provisions. Unless the participants elects another deferral percentage or chooses not to participate, participants automatically defer 3% of compensation, as defined in the Plan agreement. The automatic deferral provision increases the deferral contribution by 1% at the beginning of each year up to a maximum of 6%.

The Plan Sponsor makes a qualified automatic contribution arrangement ("QACA") safe harbor matching contribution equal to 100% of participants' contributions up to 6% of eligible compensation.

The Plan also provides that the Plan Sponsor may make additional safe harbor matching contributions and/or discretionary profit sharing contributions. Participants must be employed on the last day of the Plan year and have completed at least one year of service to receive profit sharing contributions. There were no such contributions made during 2025 and 2024.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Notes to Financial Statements

July 31, 2025 and December 31, 2024

Plan Description (continued)

Participant Accounts

Each participant's account is credited (charged) with the participant's contributions, Plan Sponsor contributions, allocations of investment earnings (losses), and administrative expenses. Allocations are based on participant compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the investment of their accounts into various pooled separate account investment options offered by the Plan.

Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings (losses) thereon. Participants are 100% vested in all Plan Sponsor safe harbor matching contributions plus actual earnings (losses) thereon after two years of service. Vesting in Plan Sponsor discretionary contributions and actual earnings (losses) thereon is based on years of continuous service. Participants vest 25% per year after one year of service, becoming 100% vested after four years of service.

Notes Receivable from Participants

Effective May 1, 2021, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The participant notes receivable are secured by the vested balances in the respective participants' accounts and bear interest at fixed rates which were commensurate with local prevailing rates at the time of the loan distribution as determined periodically by the Plan Administrator. As of July 31, 2025, interest rates on participant notes receivable ranged from 4.25% to 10.50%. Principal and interest are collected ratably through ACH deductions.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump sum payment, a partial withdrawal, or payments in equal installments over a specified period amounting to the participant's entire account vested account. For termination of service due to other reasons, a participant will receive a payment equal to his or her vested account balance as a lump sum distribution.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor's contribution portion of their accounts. Such forfeitures may be used to reduce the Plan Sponsor's contributions or pay Plan expenses. At December 31, 2024, forfeited nonvested accounts totaled approximately \$67,000. During 2025, participants forfeited approximately \$10,000. Approximately \$23,600 of forfeitures were utilized to reduce the Plan Sponsor's contribution and pay Plan expenses during 2025.

Plan Description (continued)

Hardship Withdrawals

The Plan permits distributions in the event of a hardship event, as defined in the Plan agreement. These distributions are taxable and generally subject to tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's vested account balance.

Administrative Expenses

Administrative expenses are paid by the Plan or the Plan Sponsor. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain fees incurred by the Plan for the investment management services are netted within net appreciation in fair value of investments. Fees related to recordkeeping are charged directly the applicable participant accounts and are included in administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Summary of Significant Accounting Principles

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and insurance company. See the Fair Value Measurements footnote for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued by unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Pooled Separate Accounts: Valued at net asset value ("NAV") based on the underlying investments reported to the Plan by The Standard Life Insurance Company.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company, a qualified institution, has certified the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of July 31, 2025 and December 31, 2024;
- Net appreciation in fair value of investments and dividends and interest earned as shown in the Statement of Changes in Net Assets Available for Benefits for the period January 1, 2025 to July 31, 2025;
- Investment information included in the Notes to Financial Statements;

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedules.

Tax Status

The Plan Sponsor adopted a non-standardized defined contribution pre-approved plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, in which the IRS stated that the pre-approved plan design was in compliance with applicable requirements of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since adopting the non-standardized defined contribution pre-approved plan and the Plan itself has not obtained a determination letter. However, the Plan Administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Risks and Uncertainties

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Related Party Transactions

Plan investments were held and managed by The Standard Life Insurance Company at July 31, 2025 and December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions under ERISA. The Plan paid expenses to various service providers and held participant notes receivable which also qualify as party-in-interest transactions.

Plan Merger

Effective August 1, 2025, the Plan merged and combined with the WELLthBuilder II Pooled Employer Plan and the National Domestic Violence Hotline 401(k) Plan was terminated in the process. Accordingly, all assets and their related account balances were transferred to the WELLthBuilder II Pooled Employer Plan on August 1, 2025, as approved by the Plan trustees.

Subsequent Events

The Plan evaluated subsequent events through November 20, 2025, the date the financial statements were issued.
