### Note 1: Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Lakeshore Community Healthcare, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. The Plan is sponsored by Lakeshore Community Healthcare, Inc. (the "Sponsor"), a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives.

Mid Atlantic Trust Company ("Mid Atlantic") is the Plan Custodian and July Business Services, LLC ("July") is the Plan Recordkeeper.

#### Eligibility

Substantially all employees of the Sponsor are eligible to participate and receive Sponsor matching contributions in the Plan upon employment if they normally work more than 20 hours per week and are not nonresident aliens or independent contractors. Employees are also eligible to receive Sponsor discretionary contributions; however, to receive the Sponsor discretionary contributions, they must be employed on the last day of the Plan year.

#### Contributions

Each year, participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers").

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for Sponsor matching contributions and discretionary contributions that may be contributed to the Plan. The Sponsor matching contribution is equal to 100% of participant contributions, up to 2% of participant eligible compensation. During the year ended May 31, 2025, the Sponsor also made discretionary contributions of 2% of participants' eligible compensation.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor matching contributions and Sponsor discretionary contributions, if any, and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a fixed rate determined by the Plan Administrator based on prevailing market conditions. Interest rates on existing notes range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, or retirement up to the amount of the participant's vested interest in their account. Benefits may be paid in a lump-sum distribution or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, hardship distributions from the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Sponsor matching contributions and discretionary contributions are based on years of continuous service. Participants become fully vested after one year of service. Participants must complete at least 1,000 hours to receive credit for a year of service.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service before becoming 100% vested in Sponsor contributions. These accounts will be used to reduce future Sponsor contributions or to pay administrative expenses of the Plan in accordance with the Plan document. In 2025, \$6,765 of forfeitures were used to reduce Sponsor contributions. No amounts were used to pay administrative expenses. At May 31, 2025 and 2024, forfeited nonvested accounts totaled \$2,480 and \$6,578, respectively.

#### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and there is no material impact on the Plan. Plan management will determine the optional provision(s) to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits paid to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through November 18, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of May 31, 2025 and 2024.

*Money market and mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. The money market fund is valued using \$1 as the net asset value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of May 31, 2025 and 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at May 31, 2025 and 2024, and net appreciation in fair value of investments and interest and dividends for the year ended May 31, 2025, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Mid Atlantic.

### Note 5: Related-Party and Party-in-Interest Transactions

Plan investments managed by Mid Atlantic and administrative expenses paid to them, and notes receivable from participants, qualify as party-in-interest transactions. Administrative expenses paid to July also qualify as party-in-interest transactions. These transactions are not considered prohibited transaction under the rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

### Note 7: Tax Status

The Sponsor adopted a Volume Submitter Plan which is based on a pre-approved plan document to be in compliance with applicable sections of the IRC. The Plan's management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
