To Whom It May Concern,

Please find reference the 5500-SF Form that was submitted on our behalf by ADP. The form was prepared by ADP and submitted immediately upon discovery of the filing requirement. This statement is submitted in support of penalty relief under the Delinquent Filer Voluntary Compliance Program (DFVCP) and to explain the circumstances that resulted in the late filing.

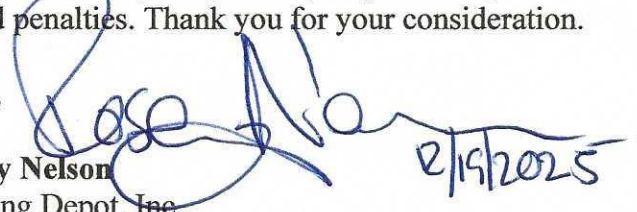
The Moving Depot, Inc. established a 401(k) plan and retained ADP as the plan's third-party administrator. We paid ADP a monthly administrative fee and provided an online portal for plan monitoring and transaction approvals. It was my good faith understanding that ADP would prepare and submit all required filings related to plan administration.

Due to significant business and financial challenges, participant contributions to the plan ceased in 2017, with the final contribution made on May 2, 2017. Despite the lack of ongoing activity, ADP's administrative services and monthly fees continued. In late 2022, the company ceased operations and was officially closed effective December 31, 2022. On or about December 13, 2022, I contacted ADP to request termination of the 401(k) plan. ADP subsequently confirmed in writing that the plan termination date was **February 28, 2023**. Because the business closed in 2022, I mistakenly believed that no Form 5500-SF filing would be required for the 2023 plan year. Additionally, I no longer had access to the ADP portal after termination and did not receive automated filing reminders. I later learned that under the service level maintained, ADP prepared the Form 5500-SF but the obligation to ensure timely filing remained with the plan sponsor.

Upon learning of the missed filing requirement, I acted promptly to correct the issue and file the delinquent Form 5500-SF. There was no intent to avoid compliance, no ongoing plan activity, and no harm to plan participants. The late filing was the result of an administrative misunderstanding following business closure and plan termination, not willful neglect. The plan sponsor has demonstrated good-faith compliance by voluntarily correcting the issue as soon as it was identified.

Based on these facts, I respectfully request acceptance under DFVCP and abatement of any associated penalties. Thank you for your consideration.
