When I received a letter from IRS telling me that IRS did not receive my 5500 SF filing for year 2023 I was not aware of that problem prior to receiving the letter. Loren D Stark was our TPA until the middle of 2024. I was expecting from them that they would file 5500 SF in the first half of 2024 but they did not do that. I tried to get an explanation from them and see what can be done about this problem but I have not heard back from them. I had to deal with this filing myself and learn as much as I could to do late filing. My company Agile Seismic LLC is under great financial stress and I am in the process of terminating company sponsored 401 k plan because I am the only person left in the company and the balance in my 401k account is \$0. I will have to pay taxes for the 401k loan that I cannot pay back. I am also preparing to file both business and personal bankruptcy. I would appreciate if you would accept my late filing for year 2024. I will file for 2024 before the end of year to avoid having the same problem.
