As of the report date, some of these failures have been self-corrected by Plan management while others remain in the process of being corrected. We cannot, and do not, provide any assurance that the Plan would maintain its tax-exempt status should regulatory agencies deem the self-corrections of the identified operational failures to be insufficient or if the remaining compliance matters remain uncorrected.

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Alpha Genesis, Inc 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alpha Genesis, Inc 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Alpha Genesis, Inc 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Alpha Genesis, Inc 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### ***Supplemental Schedules Required by ERISA***

The supplemental schedules of Schedule H; Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H; Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of Alpha Genesis, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Alpha Genesis, Inc. (the "Company") The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Plan Document was amended to exclude bonuses as eligible compensation and change the designated Plan administrator to the Plan Sponsor.

#### **Eligibility**

Employees who are eighteen or older are eligible to participate in the Plan. Employees who have satisfied the age requirement are permitted to enter the Plan as a participant on the first day of the calendar month that coincides with or next follows the date such requirements are satisfied. Employees whose employment is governed by a collective bargaining agreement, leased employees and non-resident aliens are not eligible to participate in the Plan.

#### **Contributions**

Each year, participants may contribute an elected amount of pre-tax and post-tax annual compensation, as defined in the Plan. Participants who are age fifty or older by the end of the year may also elect to make an additional catch-up contribution to the Plan. With the Trustee's consent, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may contribute on behalf of each participant a matching contribution or profit-sharing contribution to be determined each year by the Board of Directors. For the 2024 and 2023 plan years, the Company made matching contributions at the following rates, based on the employees' elected deferral rate:

For the plan years ended December 31, 2024 and 2023, the Company elected to calculate the matching contribution on a pay period basis.

For the 2024 and 2023 plan years, the Company made no profit sharing contributions to the Plan. Company contributions are invested according to the investment allocation selected by the participant. Contributions are subject to certain IRS limits.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust fund as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

### **Vesting**

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of credited service. Participants are fully vested in employer matching and profit-sharing contributions after six years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at date of note issuance, is set at one percent above the prime rate, as defined. Principal and interest is paid ratably through bi-weekly payroll deductions. Interest rates on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50%.

### **Payment of Benefits**

On termination of service, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the vested account balance does not exceed \$5,000, distribution may be made without participant consent. Participants may also request hardship distributions for reasons specified in the Plan document. In-service withdrawals are permitted for participants who have attained age 59 ½.

### **Forfeited Accounts**

The plan administrator may elect to use all or any portion of the forfeited amounts to pay administrative expenses incurred by the Plan or to reduce Company contributions. Activity in the forfeiture reserve account for the plan years ended December 31, 2024 and 2023, is as follows:

Plan management is working with the Plan's third-party service provider to identify updated contact information for the participants with uncashed distribution checks over \$150. Uncashed distribution checks less than \$150 are deemed to be less than the cost to reissue the distribution and will be added to the Plan's forfeiture reserve fund.

## **2. Summary of Significant Account Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded for tax purposes. Deemed distributed loans continue to be reported in the Plan's financial statements until the participant has reached a distributable event.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through December 15, 2025 the date the financial statements were available to be issued.

### **New Accounting Pronouncements**

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law. This act contains provisions that go into effect at various times starting in the 2023 year and ending in 2033. The deadline for adopting any required plan amendments pursuant to the SECURE 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective date of each new provision. Management has reviewed the provisions effective for the 2023 year and continues to monitor and adjust operations in accordance with provisions as they become effective. As of December 31, 2024, no formal Plan amendments have been made to adopt SECURE 2.0 Act provisions. Management has determined that the Plan was in compliance with all applicable provisions for the year ended December 31, 2024.

### **3. Investment Information Certified by Custodian**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, plan management has instructed the plan's independent auditors not to perform any auditing procedures with respect to information certified by the Plan's custodian, except for comparing such information certified by the custodian with the information included in the Plan's financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year).

#### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

##### Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate account:* The Plan's assets are held in a group annuity unallocated contract offered as a pooled separate account (PSA). The PSA invests in mutual funds that are valued based on the market value of the underlying net asset in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted.

*Collective investment trust:* Collective trust funds held by the Plan consist of the John Hancock Stable Value Fund which invests all of its assets in the John Hancock Stable Value Fund Collective Investment Trust. Fair value is calculated as the number of units of the sub-account held on a particular date multiplied by the unit value on that date, and generally is the value that would be paid out for participant-initiated benefit withdrawals. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Money Market funds:* Valued at \$1 per share.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Collective Investment Trust

The John Hancock Stable Value Fund (SVF) is an investment option within the Plan's group annuity contract. The SVF sub-account invests into the John Hancock Stable Value Fund Collective Investment Trust (CIT). The underlying CIT honors eligible redemptions at \$1.00 per unit. The daily net asset value published by the CIT is a stable \$1.00 per unit, and is effectively its contract value. This value is used for valuing the sub-account and determining the sub-accounts unit values daily. The investment in the John Hancock Stable Value Fund has been deemed to not be a fully-benefit responsive investment contract.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **7. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian and recordkeeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the recordkeeping services are included in the net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the plan year ended December 31, 2024, the Plan did not make any direct payments to John Hancock Life Insurance Company that were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations. Additionally, the Company provides certain administrative services to the plan for which no fees are charged.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the individual participant account statements and the statement of net assets available for benefits.

### **9. Income Tax Status**

The Plan has adopted a volume submitter 401(k) plan offered by My Benefits, LLC. The plan is considered tax exempt under Internal Revenue Service Code Section 401(a). The prototype plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan continues to operate in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the plan is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 10. Prohibited Transactions – Delinquent Participant Contribution Remittances

For the plan years ended December 2022 through 2024 the Company failed to remit participant deferral contributions and loan repayments totaling \$150,791 to the Plan within the time limit required by the Department of Labor, representing a nonexempt loan of funds to the Company from the Plan.

With the exception of \$18,068 of delinquent remittances for the 2024 plan year, the Company has funded all contributions including lost earnings to the Plan, has filed Form 5330 with the Internal Revenue Service, and has paid the required excise taxes due to correct the delinquent remittances. For the remaining \$18,068 of delinquently remitted contributions, the Company is currently working with the Plan's third-party service provider to calculate lost earnings and file Form 5330.

### 11. Compliance Matters

The following compliance matters have been identified in the current and prior plan year audits that left uncorrected, still impact the plan years ended December 31, 2024 and 2023. As of the report date, management has corrected a number of these matters and is working with its third-party administrator to take appropriate actions to rectify the remaining matters. While compliance matters could have a significant detrimental impact on the ongoing plan operations, the Company does not believe that the resolution of the identified matters will have a negative impact on the Plan's qualified tax status. As such, the financial statements do not include adjustments that may be required should the Plan lose its qualified tax status as a result of the identified compliance matters.

During the plan year ended December 31, 2022, the Company failed to remit participant deferral contributions and loan payments totaling \$224 in a timely manner. As of December 31, 2024, the Company has corrected the delinquently remitted contributions by filing Form 5330 for the late remittances and remitting lost earnings to the Plan.

During the plan year ended December 31, 2023, the Company failed to remit participant deferral contributions and loan payments totaling \$132,499 in a timely manner. As of December 31, 2024, the Company has filed Form 5330 and remitted lost earnings to the Plan to correct this deficiency.

During the plan year ended December 31, 2024, the Company failed to remit participant deferral contributions and loan payments totaling \$18,068 in a timely manner. As of the report date, Plan management is working with their third-party service providers to file Form 5330 and remitted lost earnings to the Plan to correct this deficiency.

The Plan failed to complete required non-discrimination testing for the plan year ended December 31, 2024. Plan management is currently working with the Plan's third-party service providers to complete this required testing and make any required corrective distributions.

During the current and prior plan years, certain Plan operational activities were inconsistent with the provisions of the Plan Document. The following operational inconsistencies have been noted:

- Delinquent participant loans were not timely deemed according to the Internal Revenue Service regulations.
- Terminated participants with account balances under \$5,000 were not automatically forced out of the Plan in accordance with the Plan's force out provisions.

Plan management consulted with legal counsel and the Plan's third-party service providers regarding the appropriate correction methods for the deficiencies listed above. Actions taken to correct the deficiencies outlined above include:

- Filing Form 5330 and remittance of lost earnings for delinquently remitted participant deferral contributions and loan repayments.

Plan management is currently working with the Plan's third-party service providers to appropriately deem participant loans that are in default or that have extended beyond the statutory limit of time for outstanding participant loans.

### **12. Over-Funded Contributions**

During the year-ended December 31, 2024, the Company funded employer contributions to the Plan totaling \$5,696 based on an incorrect calculation of true-up contributions for 2023. As of the report date, the Company is working with its third-party service providers to forfeit these funds from affected participant accounts to correct this error.

### **13. Subsequent Events**

Effective August 1, 2025, the Plan was amended and restated. Pursuant to this restatement, the Plan changed service providers and all assets of the Plan were transferred to a new Plan custodian.
