**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of GPS Capital Markets, LLC Employee 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation available for benefits as of April 11, 2025 and December 31, 2024, and the related statement of changes in net assets in liquidation available for benefits for the period ended April 11, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of April 11, 2025 and December 31, 2024, and for the period ended April 11, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in Auditors' Responsibilities for the Audit of Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for preparation and fair presentation of financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis of Matter**

As described in Note 6 to the financial statements, the governing body of GPS Capital Markets, LLC Employee 401(k) Plan approved a plan of liquidation on November 24, 2024 and fully liquidated the Plan's assets on April 11, 2025. The Plan used liquidation basis of accounting in presenting its 2025 and 2024 financial statements. Our opinion is not modified with respect to the matter.

## Notes to Financial Statements

### Note 1 – Description of Plan

The following description of the GPS Capital Markets, LLC (the Sponsor) Employee 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of the Sponsor who have 3 months of service and have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan not to exceed the maximum allowable in any given plan year. The Sponsor may make discretionary profit-sharing contributions at the option of the Sponsor's board of directors. The Sponsor may decide each contribution period whether to make a discretionary nonelective employer contribution on behalf of eligible participants in accordance with the basic plan document. The Plan also allows participant after-tax contributions, up to the maximum allowed for a given year. During the period ended April 11, 2025, there were no contributions made to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their elective deferral contributions, employer safe harbor contributions, and actual earnings thereon. Additional discretionary matching contributions, if made, are subject to the following vesting schedule:

<u>Years of service</u>	<u>Vested</u>
At least one year	20%
At least two years	60%
At least three years	100%

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial withdrawal. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

## **Notes to Financial Statements**

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

### **Forfeited Accounts**

The forfeited accounts of non-vested terminated participants may be used to pay administrative expenses. At April 11, 2025 there were no account forfeitures.

### **Administrative Expenses**

Significant administrative expenses of the Plan related to the third-party administrator are paid by the Sponsor. Additional administrative expenses charged by the plan custodian and investment advisor are paid by the Plan.

### **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan's financial statements are presented on the liquidation basis of accounting in accordance with generally accepted accounting principles.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### **Investment Valuation**

Investments are reported at fair value (except for the fully benefit responsive contract, which is reported at contract value). Fair value is based on quoted prices for identical assets in active markets. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits**

Benefits are recorded when paid by the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Management of the Plan estimates that these notes are fully collectible and therefore has no reserve for expected credit losses.

#### **Concentrations of Credit Risk**

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities. Marketable securities are subject to daily changes in market valuations. The Plan believes it is not exposed to any significant credit risk on cash and cash funds.

### Subsequent Events

Management of the Plan has evaluated subsequent events through December 23, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

### Note 3 – Fair Value Measurements

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

**Mutual Funds** - These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

**Self-Directed Brokerage Accounts** - These accounts allow participants to invest in a wide range of securities outside the Plan's core investment options. The underlying investments generally consist of money market funds, corporate stocks, government securities and exchange-traded options, which are valued at quoted market prices or published NAVs as of the last reported sales price on the active market on which the securities are traded. Such investments are classified within Level 1 of the valuation hierarchy. The investments within self-directed brokerage accounts can generally be liquidated on a daily basis and are not subject to restrictions on redemption.

The Plan previously held a fully benefit-responsive group annuity contract with an insurance company, called the Standard Stable Asset 2. Under this contract, the insurance company maintained the contributions in a general account, which was credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract was fully benefit-responsive, contract value was the relevant measurement attribute for the portion of the Plan's net assets attributable to the contract. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were ordinarily permitted to withdraw or transfer all or a portion of their investment at contract value.

Certain events could have limited the Plan's ability to transact at contract value with the insurance company, including: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives.

The Plan was terminated on November 30, 2024. As a result, the events-limiting features were triggered, and the ability to transact at contract value was affected. However, under the terms of the contract, the insurance company was required to pay the Plan at contract value upon termination.

The Plan completed the liquidation of all of its assets, including the group annuity contract, on April 11, 2025. Upon liquidation, the insurance company settled the contract at contract value in accordance with its terms. As of April 11, 2025, the Plan no longer holds any investments, and therefore no investment contracts or related contract-value balances are reflected in the accompanying financial statements.

### **Note 6 – Plan Termination**

On November 24, 2024, the plan sponsor resolved to terminate the Plan effective November 30, 2024. The termination was approved by the Plan's Board of Directors and communicated to participants. As of the termination date, the Plan ceased accepting contributions, and all participants became fully vested in their accounts in accordance with the terms of the Plan and applicable regulations.

As of April 11, 2025, all assets of the Plan were fully distributed to the participants. All obligations of the Plan have been satisfied, and no further employer or participant contributions are anticipated.

### **Note 7 – Income Tax Status**

The Plan participates in a prototype plan sponsored by Fidelity Management & Research LLC. The Internal Revenue Service has determined and informed Fidelity Management & Research LLC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has not obtained a separate determination letter from the Internal Revenue Service. Although the Plan has been amended since the date of the determination letter received by Fidelity Management & Research LLC, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in accordance with the requirements to qualify for tax-exempt status.

### **Note 8 – Risks and Uncertainties**

Prior to its liquidation, the Plan invested in various securities that were subject to interest rate, market, and credit risks. Changes in the fair value of these investments could have affected participants' account balances and the amounts reported in the financial statements.

As of the liquidation date, the Plan no longer holds any investments, and therefore is no longer exposed to investment-related risks.

### **Note 9 – Party-in-Interest Transactions**

Plan investments as of December 31, 2024 included mutual funds and self-directed brokerage account which were managed by Fidelity Workplace Services, LLC, the administrator of the Plan. Therefore, these investments and associated transactions qualify as party-in-interest transactions. Fees paid by the Plan for these investment management services amounted to \$6,097 for the period ended April 11, 2025. Notes receivable from participants also represent party-in-interest transactions. The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
