INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of US Legal Support, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the US Legal Support, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Plan Restatement

Effective February 29, 2024, the Plan’s trustee and recordkeeper changed from Lincoln Financial Group Trust Company, Inc. and Lincoln Retirement Services Company, LLC, respectively, to Empower Trust Company, LLC (“ETC”) and Empower Retirement, LLC (“Empower”), respectively. The Plan was amended and restated effective February 29, 2024 to adopt a pre-approved plan sponsored by Empower. Any changes to the Plan provisions are described below.

The conversion initiated a blackout period beginning February 26, 2024 and continuing through March 22, 2024. During this period, participants could not access their accounts and could not initiate transactions such as investment transfers, withdrawals or loans until the trustee could accurately complete the conversion. Payroll deductions continued during this time and were reflected in participants’ accounts once the transfer was complete.

General

The Plan is a defined contribution plan originally established January 1, 2006, for all eligible employees of U.S. Legal Support, Inc. and a participating employer (the “Company”), except employees covered by a collective bargaining agreement, nonresident aliens who have no earned income from sources within the United States, and leased employees. Effective February 29, 2024, eligible employees include leased employees and exclude residents of Puerto Rico. Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following the completion of 90 days of service and the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 100% of eligible compensation subject to certain limitations prescribed by law. The Plan has an eligible automatic contribution arrangement which permits the Company to automatically enroll newly eligible employees into the Plan at a pre-tax salary deferral of 6% of eligible compensation unless the employee affirmatively elects otherwise. Automatic enrollment contributions begin as soon as administratively feasible on or after 30 days following the participant’s date of eligibility. Participants that are automatically enrolled will have their pre-tax salary deferral contributions increased by 1% on July 1st each plan year up to a maximum of 10%, unless the participant elects to opt out. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

The Company may make a discretionary matching contribution on a plan year basis equal to a uniform percentage of participants' salary deferrals. Eligible participants must have a minimum of 1,000 hours of service during the plan year and be employed by the Company as of the last day of the plan year. These conditions are not applicable to a participant in the event of death, termination of employment due to disability, retirement, or authorized leave of absence from the Company. The Company made discretionary matching contributions of \$574,299 in 2024.

The Plan is participant directed. Participants may change their contribution amounts at the beginning of a payroll cycle and investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution, as well as allocations of Plan earnings and any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Loans are repaid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence but not to exceed 15 years. The loans bear interest at the prime rate plus 1% as determined at the beginning of a calendar quarter in which the loan occurs and are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Effective February 29, 2024, the interest rate is determined on the first business day of the month the loan is originated. Participants may only have two loans outstanding at any time.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Participants vest in the Company discretionary matching contributions at 33% each year after one year of service and become 100% vested after three years of service. A participant must complete 1,000 hours of service during a plan year to qualify for a year of service. A participant will become fully vested in the Company discretionary matching contributions upon reaching normal retirement age or in the event of death, or total and permanent disability.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

Normal retirement age under the Plan is age 65. Upon a participant's retirement, disability, death, or termination of employment, the vested funds in the participant's account may be distributed in a lump-sum. Participants who terminate with an account balance of \$5,000 or less will be cashed out of the Plan as soon as administratively feasible. The Plan also allows in-service withdrawals at age 59½ and hardship withdrawals, subject to certain Plan provisions.

Forfeitures

Forfeitures of nonvested employer contributions shall be used to reduce the Company's contributions or pay administrative expenses of the Plan. The forfeiture balance at December 31, 2024 and 2023 was \$9,272 and \$5,576, respectively. During 2024, the Plan used \$9,075 in forfeitures to pay Plan administrative expenses. None were used to reduce Company contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments are reported at fair value. Through February 29, 2024, the Plan held an investment in a fully benefit-responsive investment contract, which was reported at contract value (See Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Collective Investment Trust Fund: Valued at NAV, based on the underlying unit value reported by the fund's trustee, based on the fair value of the underlying investments held by the fund, less liabilities. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The fund primarily consists of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations. Participant transactions (purchases and sales) may occur daily. Certain investment options offered by the Plan may be deemed to compete with this fund. The terms of the contract prohibit making a direct exchange from this fund to such competing funds. Instead, the exchange must first be made to a non-competing fund for 90 days. Were the Plan to initiate a full redemption of the fund, the issuer reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner. A 12 month advance written notice is required. The Plan has no unfunded commitments and no contractual obligations to further invest in this fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - STABLE VALUE ACCOUNT

As of December 31, 2023 and through February 29, 2024, the Plan invested in a fully benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln), contained in the general account of Lincoln. As described in Note 2, the Stable Value Account is reported at contract value. Contract value represents contributions made less withdrawals and administrative expenses, plus interest credited. Lincoln, as the contract issuer, is contractually obligated to repay the principal and interest at a specified crediting interest rate.

Interest is credited on the balance based on the five-year average of the Barclays Stable Income Market Index. Under this methodology, the credited rate for any particular calendar quarter is based on the 60-month average plus or minus a factor for the particular contract. Interest-crediting rates are reviewed on a quarterly basis for resetting. The guaranteed minimum interest rate is 1.00%.

Participants are allowed to withdraw amounts from the account, at any time, without restrictions upon retirement, termination, or other qualifying life event, but voluntary withdrawals for the purpose of transfer to other investments are limited by a 90-day wait period.

As of February 29, 2024 the stable value account was liquidated and the fund balance was transferred into the Morley Capital Management Stable Value CL 25-I.

NOTE 5 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Lincoln Financial Group Trust Company, Inc., the trustee of the Plan as of December 31, 2023 through February 29, 2024, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statement of net assets available for benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the period from January 1, 2024 through February 29, 2024.

ETC, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statement of net assets available for benefits as of December 31, 2024, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the period from March 1, 2024 through December 31, 2024.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

The Plan invested in a stable value account managed by an affiliate of Lincoln Financial Group Trust Company, Inc. through February 29, 2024, which qualified as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan, which obtained its latest opinion letter dated November 14, 2022, in which the Internal Revenue Service (IRS) stated that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

NOTE 8 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
