PNTSA, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Klamath Health Partnership, Inc. PNTSA and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Klamath Health Partnership, Inc. PNTSA's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

This description of Klamath Health Partnership, Inc. PNTSA (the Plan) (formerly Klamath Health Partners, Inc. PNTSA) is provided for general information purposes. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted on April 1, 1999, for employees of Klamath Health Partners, Inc. (the Employer). The Plan is a defined-contribution plan covering all employees of the Employer. Beginning in 2009, the Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2009, in part to reflect provisions of final regulations under Section 403(b) of the Internal Revenue Code (IRC). The Plan's most recent restatement was effective January 1, 2020. The Plan Administrator oversees governance of the Plan.

Contributions

Each year, participants may contribute pre-tax compensation or post-tax compensation (designated as Roth) up to the limits provided by the IRC. Employees age 50 or older are eligible to contribute "catch-up" contributions up to Internal Revenue Service (IRS) limits. The Plan also allows for participants to make rollover contributions from existing qualified plans into the Plan.

The Employer makes a matching contribution equal to a certain percentage of the amounts contributed by participants, with the percentage for each individual based on their years of service. Participants are eligible for matching contributions upon attainment of 18 years of age and completion of 24 months of service. In accordance with the provisions of the Plan, the Employer makes a matching contribution of between 1 percent and 7 percent of eligible compensation for each eligible participant, based on years of service.

Participants may direct the investment of their contributions into various investments offered through Variable Annuity Life Insurance Company (VALIC).

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and earnings on the specific investments held in the participant's account, reduced by any expenses or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum of the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates prevailing at the time of the loan origination. Participant loans are reported at their unpaid principal balances. Principal and interest payments are paid directly to VALIC from the participant.

1. Plan Description, continued

Payment of Benefits

In the event of death, disability, retirement, hardship, or termination of employment, the participant's account balance is payable as soon as administratively feasible after the date of the event. Distributions may be in the form of a lump sum payment, installments, annuities or partial payments. In-service distributions are available from employee deferral balances upon attainment of age 59½ and at any time with respect to rollover contributions.

The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's vested balance or the amount of the financial need.

Vesting

Participants are fully vested in their accounts at all times, including all Employer contributions and earnings thereon.

Plan Administration

The Plan is administered by the management of the Employer. Among other duties, the Plan Administrator is responsible to construe and interpret the Plan, decide questions of eligibility, and determine the amount, manner, and time of payment of any benefits. The Plan Administrator has appointed Northwest Retirement Plans as the third-party administrator and record keeper.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive insurance contracts, are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements. The Plan's investment in benefit-responsive unallocated insurance contracts is carried at contract value, which represents invested principal plus credited interest.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition, continued

Investments held by plans qualified under IRC Section 403(b) are limited to registered investment companies (mutual funds) and fixed or variable annuity contracts.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is stated on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan, other than incidental record keeping and investment fees charged to participant accounts, are paid by the Employer and are therefore excluded from these financial statements. Investment related expenses are included in net change in fair value of investments. Fees for the administration of notes receivables from participants and distributions are included in administrative expenses and charged directly to the participant's account.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest and reported net of deemed distributed loans. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Variable Annuity Life Insurance Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

4. Investment Contracts

The Fixed Account Plus and Short Term Fixed Account are fixed rate annuity contracts guaranteed by VALIC which provide a guarantee of principal and a guaranteed minimum rate of interest for the life of the contract of no less than 3 percent before expenses. There is no charge for cash surrender or withdrawals. The contracts are considered fully benefit-responsive and are reported as unallocated insurance contracts in the statements of net assets available for benefits at contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan has adopted a Volume Submitter 403(b) Plan sponsored by VALIC Retirement Services Company. VALIC Retirement Services Company, as Sponsor of the volume submitter, has received an opinion letter from the IRS dated April 5, 2018, that the Plan is acceptable under section 403(b) of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is currently being operating in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and tax-exempt.

6. Tax Status, continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party in Interest Transactions

Certain Plan investments are shares of registered investment companies managed by VALIC, the custodian of the Plan, or a fixed annuity contract sponsored by VALIC. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under professional standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

9. Fair Value Measurements, continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value (NAV) of shares held by the Plan in the underlying registered investment companies at year end. All mutual funds held by the Plan are open-end mutual funds held in a group annuity contract with VALIC that are registered with the Securities and Exchange Commission (SEC) and are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

10. Nonexempt Transactions

During the year ended December 31, 2024 and 2023, employee contributions totaling \$114,143 and \$65,267, respectively, were not remitted to the Plan within the appropriate time period by the Employer. Remittances totaling \$-0- and \$34 were fully corrected during the years ended December 31, 2024 and 2023, respectively. Total late remittances reported on the Form 5500 were \$179,410 and \$65,301 for the years ended December 2024 and 2023, respectively. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking appropriate steps to correct the situation by calculating lost earnings and interest and has further implemented procedures to ensure that all future remittances are made within the prescribed time period.

11. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.


