Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Goodheart-Willcox Company, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended April 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of April 30, 2025 and 2024, and for the year ended April 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following brief description of The Goodheart-Willcox Company, Inc. 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of The Goodheart-Willcox Company, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees who have attained 21 years of age and have completed 30 days of service are eligible to participate in the Plan. Eligible participants may enter the Plan on the first day of the month on or after they have met the eligibility requirements. Those who defer compensation to contribute to the Plan are eligible to receive Company matching contributions after the completion of one year of eligible service. One year of eligible service is defined by the Plan as 1,000 hours of service completed during a consecutive 12-month period. The year of service is credited to the participant as of the last day of the 12-month period. Eligible participants may begin to receive Company matching contributions on May 1 or November 1 after the above requirements are met.

Contributions: Eligible participants are automatically enrolled in the Plan upon meeting the eligibility requirements if a formal election not to participate is not made by the employee. An automatic deferral of 3% is deferred from eligible compensation of all employees that become eligible and do not elect a different deferral rate. Participants subject to automatic deferrals will also be subject to an annual 1% automatic increase up to 5%. A participant may elect to make before-tax contributions or Roth after-tax contributions. Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, through payroll deductions, not to exceed regulatory limits according to the Internal Revenue Code (IRC). Participants aged 50 or older are eligible to make catch-up contributions. Participants are allowed rollover contributions from other qualified defined benefit or contribution plans.

The Company makes safe harbor matching contributions equal to 100% of the participant's contributions that are no greater than 3% of the participant's eligible compensation and 50% of the participant's contributions that are greater than 3% but no greater than 5% of the participant's eligible compensation. The Company's matching contributions amounted to \$577,508 for the year ended April 30, 2025. The Company may also make qualified nonelective and discretionary contributions. There were no qualified nonelective or discretionary contributions for the year ended April 30, 2025.

Participant accounts: Participant accounts are credited with participant contributions, the Company's safe harbor matching contributions, the Company's discretionary contribution, if any, the Company's nonelective contribution, if any, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance, as defined.

Vesting: Participant, employer matching and qualified nonelective contributions and earnings thereon are 100% vested. Employer discretionary contribution vesting does not begin until two years of service have been completed, then 20% is vested annually until 100% vested. The participant is fully vested after six years of continuous service.

Investment options: Upon enrollment in the Plan, a participant may direct his/her investment into a variety of investment options as more fully described in the Plan's literature. Participants may change investment options at any time.

Forfeitures: Forfeitures may be used to pay any administrative expenses or offset any Company contributions. There were no forfeited nonvested accounts at April 30, 2025 or 2024. There were no forfeitures used to reduce Company contributions and no forfeitures used to pay administrative expenses during the year ended April 30, 2025.

Diversification: Diversification is offered to participants in The Goodheart-Willcox Company, Inc. Employees' Profit Sharing and Stock Ownership Plan and Trust (the ESOP), a related plan sponsored by the Company, who are close to retirement so that they may have the opportunity to move part of the value of their investment in the Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the ESOP may elect to diversify a portion of their accounts. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to the participant's account, less any shares previously diversified. In the sixth year, the percentage changes to 50% of the number of shares allocated to the participant's account. Participants who elect to diversify may direct the ESOP to transfer the value of the diversified Company shares from their stock contribution account in the ESOP as a cash distribution to the participants, roll over to the participants' individual retirement accounts or transfer to the Plan. For the year ended April 30, 2025, there was \$535,535 transferred from the ESOP to the Plan.

Payments of benefits: Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability or termination of employment. A participant's vested accrued benefit shall be paid in the form of a lump-sum payment. In-service withdrawals are permitted by the Plan upon attainment of age 59½. At April 30, 2025, there was no amount owed to former participants who had elected to withdraw their account balances.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements are prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through December 12, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Delaware Charter Guarantee & Trust Company (d/b/a Principal Trust Company) (the Trustee)

The following is a summary of the Plan's asset and income information as of April 30, 2025 and 2024, and for the year ended April 30, 2025, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4. Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of common/collective trusts: Valued based on the NAV of units of the common/collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Units of pooled separate accounts: Valued at NAV per unit of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is determined to be probable that the fund will sell for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value to another.

Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended April 30, 2025, there were no significant transfers in or out of Level 3.

Note 5. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their discretionary Company contributions.

Note 6. Related-Party and Party-in-Interest Transactions

The Plan's investments are held, invested and maintained by Delaware Charter Guarantee & Trust Company (d/b/a Principal Trust Company), the trustee. Principal Life Insurance Company, an affiliate of the trustee, also performs administration and recordkeeping services for the Plan. These transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to its service providers were \$825 for the year ended April 30, 2025.

Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 7. Income Tax Status

The Plan has adopted a volume submitter plan sponsored by Principal Life Insurance Company. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
