### ***Scope and Nature of the ERISA Section 103(a)(3)(c) Audit***

We have performed audits of the financial statements of Smile Doctors Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**Note 1. Description of the Plan**

***General***

The following description of Smile Doctors Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions

The Plan is a multiple employer defined contribution plan subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan was established on January 1, 2021 covering substantially all employees of Smile Doctors LLC and its affiliates (collectively, Company or Plan Administrator). Employees become eligible for participation on the first day of the month coinciding with or following their completion of two months of service with the exception of union employees, nonresident aliens, and leased employees. An acquired employee's entry date will be the beginning date of the first full pay period immediately following the first of the month coinciding with or next following the employee's acquisition hire date. Related employers who also participate in the Plan include Dana E. Fender, DMD PC; David L. Jones, DDS, PC; East Hartford Orthodontics LLC; Goggans Associates of North Carolina, PC; Goggans Dental Associates of Connecticut, PC; Gregory G. Goggans, DMD Arkansas PA; Gregory Goggans, DMD, PC; Jeffery D. Loveless, DDS, PA; Mack Orthodontics, PLC; Palmetto Orthodontics & TMJ, PA; Scott Law Ortho Corp PC; Scott V. Law DMD Louisiana A Professional Dental Corporation; Scott V. Law, DMD Missouri, LLC; Scott V. Law, DMD New Jersey, PC; SD Orthodontics PA; Siddhi J. Doshhi, LLC; Smile Doctors of Arizona, PC; Smile Doctors of Colorado PC; Smile Doctors of Indiana PC; Smile Doctors of Iowa PC; Smile Doctors of Kentucky PSC; Smile Doctors of Maryland, PC; Smile Doctors of Michigan PC; Smile Doctors of Minnesota PC; Smile Doctors of New Mexico, PC; Smile Doctors of North Dakota; Smile Doctors of Ohio, Inc.; Smile Doctors of Oklahoma; Smile Doctors of Pennsylvania, PC; Smile Doctors of South Carolina PC; Smile Doctors of South Dakota, PLLC; Smile Doctors of Tennessee PC; Smile Doctors of Utah PC; Smile Doctors of Wisconsin, PC; Smile Doctors of Wyoming, PC; and Smile Doctors of Orthodontics of Virginia PC. Charles Schwab Trust Bank (Charles Schwab or Custodian) and Bluestar Retirement Services, Inc. (Bluestar or Record-keeper) serve as the custodian and record-keeper of the Plan, respectively. Four officers of the Company serve as the Trustees of the Plan (Trustees).

***Contributions***

The Plan is funded through participant pretax and/or after-tax (Roth) elective deferrals and Company discretionary matching contributions. Each year, participants may contribute up to 100% of annual compensation, as defined by the Plan, subject to maximum limitations imposed by the Internal Revenue Code (IRC). Participants who are eligible to make elective deferrals under the Plan and who have attained age 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. Rollover contributions representing distributions from other qualified defined benefit plans or defined contribution plans are permitted by the Plan.

For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions in the amount of 50% of participant's elective salary deferrals on the first 2% of the participant's eligible compensation.

***Participant Investment Account Options***

The Plan provides for participants to direct both participant and Company discretionary matching contributions into a variety of mutual funds of registered investment companies and a common collective trust in accordance with participant investment elections and the provisions of the trust agreement and may change the allocation daily.

***Participant Accounts***

Subject to certain limitations on annual additions, each participant's account is credited with employee pretax and after-tax deferrals, Company contributions, and an allocation of plan earnings or losses and is charged with administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in elective deferrals, rollover contributions, and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's matching contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest 25% per year beginning after one year of service, with full vesting after four years. A participant will automatically become fully vested in the events of death, retirement, at age 65, or permanent disability, as defined by the plan document

***Notes Receivable From Participants***

Borrowings are available for all participants. Notes receivable from participants are limited to a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions as defined by the Internal Revenue Service (IRS). A participant may only have one note outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a rate of one percentage point over the prime rate as reported in the Wall Street Journal. Any note must be repaid within five years unless it's for the purchase of a primary residence. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections.

***Payment of Benefits***

Upon normal retirement age, death, disability, or termination, a participant's benefits are payable in a lump-sum amount equal to 100% of the participant's vested account balance. Employees may also make hardship withdrawals on the balance of their account related to their elective deferral contributions. Such withdrawals are subject to meeting hardship guidelines established by the IRS. Upon termination, vested account balances less than \$5,000 may be involuntarily cashed out to the applicable terminated participant within a reasonable time after terminating employment or rolled over to an individual retirement account.

***Forfeited Accounts***

Forfeitures are available to reduce future Company contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts available for future use totaled \$40,320 and \$9,550, respectively. These accounts will be used to reduce future employer contributions, reallocated to participants in the same manner as employer contributions, or pay plan expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The income or loss earned on participant accounts is allocated on a daily basis using the

previous day's ending account balance. Net appreciation of fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balances us any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document or note policy of the Plan.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants during 2024. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Custodian**

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds and a common collective trust are managed by Charles Schwab. Charles Schwab is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Company directly pays any other fees related to the Plan's operations.

The Plan paid approximately \$138,000 and \$49,000 of record-keeping fees to Charles Schwab during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan is terminated, each of the participants will have a nonforfeitable 100%

vested interest in his or her account balance, including all Company contributions, subject to payment of liquidation costs and expenses.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Bluestar Retirement Services, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
