### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the American Printing House for the Blind 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### Notes to the Financial Statements

#### 1. Description of the Plan

The following description of the American Printing House for the Blind 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all employees of American Printing House for the Blind, Inc. (the Plan Sponsor, Employer and the Plan Administrator) who meet the age requirements of the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established July 1, 1999 and was amended effective June 26, 2023.

##### Eligibility

Employees over the age of 21 are eligible to participate in the Plan. Eligible participants can enter the Plan on the first day of the payroll period following their date of hire, or upon reaching age 21. At that time, participants can begin deferring compensation into the Plan, and become eligible for the employer matching. Participants become eligible for the employer discretionary contributions after one year of service and 500 hours of service.

##### Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants may also make Roth contributions and contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants are automatically enrolled in an elective deferral contribution of 4% of compensation, unless the participant affirmatively elects a different percentage or elects not to make an elective deferral contribution. Deferrals increase 1% per year, not to exceed 10% of eligible compensation, for those participants who are automatically enrolled into the Plan.

The Plan Sponsor matches 100% of participants' contributions up to 4% of the participant's eligible compensation. In addition, the Plan Sponsor may choose to make an additional contribution to the Plan each year at its own discretion, subject to percentage limitations described in the Plan document. There were no discretionary contributions made during the year ended December 31, 2024.

##### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. Administrative expenses are charged to each participant's account when a benefit distribution is processed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to the Financial Statements, continued

### 1. Description of the Plan, continued

#### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at their discretion. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

#### Vesting

Participants are vested immediately in their contributions to the Plan as well as the employer's contributions to the Plan, plus actual earnings thereon.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump sum payment equal to the value of the participant's vested interest in their account, subject to the provisions of the Plan document. On termination of service, a participant whose vested account balance is over \$1,000 but not greater than \$5,000 and does not make a timely election with respect to distribution will receive his or her benefits as a direct rollover into an Individual Retirement Account or Annuity selected by the Plan Administrator. On termination of service, a participant whose vested account balance is under \$1,000 and does not make a timely election with respect to distribution will receive a lump sum payment.

#### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### 2. Summary of Significant Accounting Policies, continued

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive contracts which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

The Plan holds investments in a common trust fund which includes fully benefit-responsive investment contracts. Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor.

#### Reclassifications

Certain 2023 amounts have been reclassified to conform with 2024 presentation with no effect on net assets available for benefits or changes in net assets available for benefits.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through December 9, 2025, the date that the financial statements were available to be issued.

### 3. Information Certified and Provided by Trustees

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Ascensus (previously Newport), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the supplemental schedule.

The following table presents the fair value of investments (except for fully benefit-responsive investment contracts, which are reported at contract value) in the Plan that were certified by the trustee.

The trustee also certified to the completeness and accuracy of \$2,975,673 of net appreciation in the fair value of investments and \$364,031 of dividends related to the aforementioned investments for the year ended December 31, 2024.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 4. Fair Value Measurements, continued

*Collective trust:* Valued based on the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

The collective trust invests in a stable value fund which includes investment contracts issued by insurance companies, cash equivalents, and separate account investment contracts. Investments in this category can be redeemed immediately upon request. The fair value of investments in this category has been estimated using the NAV of the units of participation in the fund.

The Plan has a fully benefit-responsive common trust fund with T. Rowe Price. T. Rowe Price maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by T. Rowe Price. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The common trust fund invests in a stable value fund which includes investment contracts issued by insurance companies, cash equivalents, and synthetic investment contracts. Investments can be redeemed daily. Under certain circumstances, unit holders have agreed to the payment of redemption over a period of up to twelve months. The Plan Administrator does not believe that the occurrence of any event which would limit the Plan's ability to transact at contract value with participants is probable.

The contract value of the fund at December 31, 2024 was \$2,801,428 and \$3,183,110, respectively. The interest crediting rates were 3.29% and 3.04% as of December 31, 2024 and 2023, respectively. The average yield for the year ended December 31, 2024 was 4.29%.

### **6. Exempt Party-in-Interest Transactions**

Indirect fees are paid to Ascensus based on investment account values. Ascensus is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These fees range from 0.04% to 0.82% of the investment account value. The fees reduce the net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Additionally, administration fees were paid to Newport Group, Inc. for recordkeeping. The fees for the year ended December 31, 2024 were \$25,851.

### **7. Tax Status**

The Plan uses a prototype Plan document sponsored by Newport. Newport received an opinion letter from the Internal Revenue Service (IRS), dated November 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **8. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.
