NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2025 AND 2024

**Note 1 - Description of Plan -**

The following description of the Profit Sharing Plan and Trust of David Y. Martin, Jr., LLC (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Description of Plan

The Plan is a defined contribution plan covering all eligible employees of David Y. Martin, Jr., LLC (the "Company") who are at least 20 years of age and have one year of service as defined in the Plan, provided they worked at least 1,000 hours during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management oversees governance of the Plan, determines appropriateness of the Plan's investment offerings, and monitors investment performance.

In May 2024, the Plan's assets were transferred from T. Rowe Price Services, Inc. (trustee) to Lincoln Financial Group Trust Company, Inc. (trustee).

Contributions

Participants may contribute a percentage of their annual compensation as defined in the Plan, not to exceed the limits imposed under section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans. In addition to regular pre-tax contributions, the Plan also allows after tax Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution to participants of the Plan as determined annually by the Company's management. The Company also may make a discretionary profit-sharing contribution to all eligible participants of the Plan. In order to be eligible for this contribution, a participant must have worked 1,000 hours during the plan year and be employed on the last day of the plan year. The Company's discretionary matching contributions were \$84,419 for the year ended June 30, 2025, equal to the participant's contribution up to 2% of the participant's eligible compensation. No discretionary profit-sharing contributions were made for the year ended June 30, 2025.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and allocations of the Company's contributions, the Plan's earnings or losses, and certain Plan administrative expenses not covered by the Plan sponsor. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants will be 100% vested in discretionary qualified non-elective contributions made by the employer. Vesting in the Company's discretionary matching and profit sharing contribution is based on the following schedule.

## Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account, as described in the adoption agreement. Benefits are recorded when paid.

## Forfeited Accounts

Forfeited non-vested accounts may be used to reduce future employer contributions and to pay administrative expenses. At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$5,695 and \$4,766, respectively.

## **Note 2 - Summary of Accounting Policies -**

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. At June 30, 2025 and 2024, all assets of the Plan are participant directed.

Investment held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. As of June 30, 2025 and 2024, the Plan has no fully benefit-responsive investment contracts.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Plan custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

### Risk and Uncertainties

The Plan provides for various investment options in any combination of selected mutual funds with its trustee. These funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these funds, it is at least reasonably possible that changes in the values of these funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Administrative Expenses

The Company, at its sole discretion, may pay the administrative expenses of the Plan. If such expenses are not paid by the Company, they are paid out of Plan assets. Certain expenses of maintaining the Plan were paid directly by the Company for the years ended June 30, 2025 and 2024 and are excluded from these financial statements. Investment related expenses are included in net investment gain (loss).

### Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through December 12, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Plan Termination -**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

#### **Note 4 - Tax Status -**

The Company has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2022.

#### **Note 5 - Fair Value Measurements -**

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

**Mutual Funds** - The fair values of mutual funds are based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Stable Value Account** - The fair value is based on the net asset value of the underlying investments.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
