December 31, 2024, and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the AMPCUS INC. 401(K) P/S PLAN (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

AMPCUS, Inc. (The "Company") established the Plan effective January 1, 2008, to provide employees with a systematic means of savings and investing in the future. Employees who are at least 21 years of age are eligible to participate in the Plan on the first day of the plan month coinciding with or following the satisfaction of the eligibility requirements.

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan (including the authority and responsibility to invest, manage and control the assets of the Plan specifically allocated to the custodian). Reliance Trust Company is the appointed trustee of the Plan. Automatic Data Processing is the recordkeeper and provides certain administrative services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Contributions

Effective March 1, 2022, participants who have completed 6 months of service may elect to contribute up to 90% of eligible compensation, not to exceed the limits of the Internal Revenue Code. Before March 1, 2022, participants who had completed 12 months of service could elect to contribute up to 90% of their eligible compensation, not to exceed the limits of the Internal Revenue Code. Employees under collective bargaining agreements, non-resident aliens and leased employees are not eligible to participate in the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make contributions to the Plan as matching contributions at the discretion of the Company, as determined year to year. In addition, the Company may make nonelective profit-sharing contributions to the plan at the discretion of the Company, as determined year to year. Participants must have completed 6 months of service and 1,000 hours in the plan year and be employed on the last day of the year to receive matching or profit-sharing contributions. The Company did not make any contributions to the Plan during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and profit-sharing portion of their accounts, plus earnings thereon, is based on years of continuous service. Company matching and profit-sharing contributions vest according to the following schedule:

### Forfeitures

There are no forfeited nonvested accounts as of December 31, 2024, or 2023.

### Participant Loans

Participants may borrow from their accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. If a participant terminates employment with the Company, the loan becomes due and payable in full immediately. If the loan is not repaid, it will automatically be treated as a distribution at the end of the quarter subsequent to the quarter in which the default occurs.

### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also elect to roll over their accounts to another tax-deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$7,000 will be immediately distributed in a lump-sum payment. Participants may elect to roll over monies to another qualified plan at any time. Participants may withdraw the vested portion of their contributions in the event of financial hardship.

### Plan Fees and Administrative Expenses

The Company pays certain administrative expenses of the Plan, such as legal fees and audit fees.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of

### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

### Payment of Benefits

Benefits are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be a distribution, the participant's loan balance is reduced, and a benefit payment is recorded.

### Other Liabilities

Other liabilities represent excess deferrals and earnings on excess deferrals to the plan to be refunded to participants and erroneous contributions to the plan to be refunded to the Company.

### Use of Accounting Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes, and supplemental schedules. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan has an investment in a common/collective trust, which is composed primarily of fully benefit-responsive investment contracts and is reported at fair value using net asset value (NAV) as a practical expedient. The common/collective trust calculates NAV per share in a manner consistent with the measurement principles in FASB Accounting Standards Codification Topic 946 *Financial Services — Investment Companies*. Those measurement principles indicate that, in the determination of a common/collective trust's NAV, the relevant measurement is net assets, which include the fully benefit investment contracts held by the fund at contract value. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund. This practical expedient is not used when it is determined to be

probable that the fund will sell the investment for an amount different than the reported net asset value.

Registered investment company shares are valued at the daily closing price as reported by the registered investment companies.

Any unrealized appreciation and depreciation, as well as realized gains or losses for the year, are reflected as net appreciation or depreciation in fair value as shown on the statements of changes in net assets available for benefits. Dividends are recorded on the ex-dividend date. Interest is accrued on a daily basis. Purchases and sales are recorded on a trade-date basis.

#### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. See Note 10.

### NOTE 3 - INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments, dividends and interest and interest income on notes receivable from participants for the years ended December 31, 2024, and 2023 was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

### NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is based on the lowest level input that is significant to the fair value measure in its entirety.

## NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

As of December 31, 2024, approximately 12% of the plan's net assets were invested in STATE ST EQUITY 500 INDEX K. As of December 31, 2023, approximately 13% and 11% of the plan's net assets were invested in FID Freedom Index 2035 Premier and FID Freedom Index 2040 Premier, respectively.

## NOTE 6 - TAX STATUS

Effective May 1, 2022, the Plan was amended and restated to comply with the latest legislative and regulatory changes under the Cycle 3 Restatement for defined contribution plans. The Plan received a favorable IRS opinion letter dated October 6, 2020, confirming its pre-approved status.

Since that restatement, the IRS has issued additional guidance requiring plans to incorporate changes from the SECURE Act (2019), CARES Act (2020), and SECURE 2.0 Act (2022). These amendments must be formally adopted by December 31, 2026, although plans are expected to operate in compliance with the new rules in the interim.

The Plan administrator believes the Plan continues to be operated in compliance with the applicable requirements of the Internal Revenue Code and remains qualified and tax-exempt. The next full restatement cycle for defined contribution plans, known as Cycle 4, is scheduled to begin in late 2026.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years before 2022.

#### NOTE 7 - RELATED-PARTY TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Reliance Trust Company manages plan investments; the trustee of the Plan and ADP is the record-keeper of the Plan. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. The Company paid certain administrative expenses of the Plan for recordkeeping. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

#### NOTE 8 - PROHIBITED TRANSACTIONS – DELINQUENT CONTRIBUTIONS

During the year ended December 31, 2024, certain employee contributions totaling \$37,449 were not remitted to the plan on a timely basis.

During the year ended December 31, 2023, certain employee contributions totaling \$75,073 were not remitted to the plan on a timely basis.

#### NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Income, expenses, net assets, and changes in net assets per Schedule H of Form 5500 for the 2024 and 2023 agree with the 2024 and 2023 audited financial statements of the Plan, respectively.

#### NOTE 10 - SUBSEQUENT EVENTS

Effective January 1, 2025, Reliance Trust Company was terminated as the trustee of the Plan. As of that date, ADP Retirement Trust Services, LLC became the new trustee.
