Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of May 31, 2025 and September 30, 2024, and the related statement of changes in net assets in liquidation for the period October 1, 2024 to September 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 31, 2025 and September 30, 2024, and for the period October 1, 2024 to May 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter— Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 4 to the financial statements, the Board of Directors of Rio Grande Valley Sugar Growers, Inc. approved a plan of liquidation on February 16, 2024 and management determined liquidation is imminent. As a result, the Plan presents the financial statements on the liquidation basis of accounting. Also as described in Note 4, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of May 31, 2025. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Rio Grande Valley Sugar Growers, Inc. Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

As further discussed in Note 4, on February 16, 2024, it was announced that Rio Grande Valley Sugar Growers, Inc. will voluntarily and orderly liquidate as approved by the Board of Directors. The Plan was terminated on March 31, 2025 and fully liquidated on May 31, 2025.

General: The Plan is a defined contribution plan covering all full-time employees of Rio Grande Valley Sugar Growers, Inc. (the "Cooperative") including full-time seasonal hires, who have completed one year (twelve consecutive months) and a minimum of 1,000 hours of service.

Employees are eligible to enter the Plan on the first day of the month coinciding with or next following the date an employee has satisfied the eligibility requirements.

Contributions: Each year, participants may contribute a percentage of pre-tax annual compensation, a maximum of 90% as defined by the Plan, up to the maximum annual limitation per the Internal Revenue Service ("IRS"). The Plan allows participants who had attained age 50 by the end of the year to make catch-up contributions in accordance with section 414(v). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct these contributions into various investment options offered by the Plan. The Cooperative may, at its discretion, make matching contributions to the Plan, as well as an additional discretionary contribution. For the period October 1, 2024 to May 31, 2025, the Cooperative contributed a match of 100% on the first 4% of compensation that a participant contributed to the Plan and made no additional discretionary contributions. Cooperative contributions are invested in a manner consistent with the participant's contributions. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's own contributions and allocations of (a) the Cooperative's contribution, if any, and (b) the Plan's earnings and charged with an allocation of administrative expenses and his or her withdrawals. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting: Each participant is immediately 100% vested in his or her rollover and salary deferrals, catch-up contributions plus actual earnings thereon. Vesting in the remainder of the Cooperative's contributions plus earnings thereon is based on the following schedule:

A participant shall also be 100% vested in his or her Cooperative account upon early retirement age (55) and the completion of 6 years of service, normal retirement age (65), death prior to termination of employment, or retirement due to physical disability. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

As a result of management's decision to terminate the Plan, all participants became 100% vested in all contribution sources as of March 31, 2025 (date of termination). Refer to Note 4 for plan termination disclosures.

Payment of Benefits: Upon termination, participants or beneficiaries will receive a single lump-sum payment in an amount equal to the value of the participant's vested account. Participants may also elect to receive partial distributions or annuity payments if certain vesting and age requirements are met. Benefit payments are recorded when paid. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½. Refer to Note 4 herein for further disclosure.

Forfeitures: Forfeitures of non-vested Cooperative matching contributions are used to first reduce administrative expenses and then to reduce future Cooperative contributions payable under the Plan. Forfeited non-vested accounts totaled \$0 and \$45,943 as of May 31, 2025 and September 2024, respectively. No forfeitures were used to reduce Cooperative contributions during the period of October 1, 2024 to May 31, 2025.

Administrative and Investment Management Expenses: Certain administrative functions are performed by officers or employees of the Cooperative. No such officer or employee receives compensation from the Plan. Certain administrative expenses of the Plan are paid by the Cooperative. Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments and included in net appreciation (depreciation) in fair value of investments reported by the Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: As a result of the Cooperative's voluntary and orderly liquidation which was deemed imminent as of September 30, 2024 the accompanying financial statements are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States ("US GAAP"). The Plan's adoption of the liquidation basis had no effect on the plan's net assets as the fair value of the Plan's investments were determined to approximate liquidation values.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available in liquidation.

Investments Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820 defines fair value as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. FASB ASC 820 establishes a fair value hierarchy which requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of May 31, 2025 and September 30, 2024, and net appreciation in fair value of investments and interest and dividends for the for the period October 1, 2024 to May 31, 2025 was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services as of May 31, 2025 and the period January 1, 2025 to May 31, 2025 and Reliance Trust Company for the period October 1, 2024 to December 31, 2024 and as of September 30, 2024 (the trustees of the Plan).

NOTE 4 – PLAN TERMINATION

On February 16, 2024, the Board of Directors of the Cooperative formally approved a resolution to cease operations and liquidate the Cooperative through a voluntary and orderly process. As a result, the Plan utilizes the liquidation basis of accounting, in accordance with US GAAP, as liquidation of the Plan was deemed imminent and unlikely to be reversed due to the Cooperative's liquidation. As of September 30, 2024, the fair value of the Plan's assets approximated the amounts owed to participants.

Due to voluntary liquidation the Plan was terminated on March 31, 2025 and all participant distributions were completed by May 31, 2025. Upon termination of the Plan all participants became 100% vested in their accounts and all contributions to the Plan were ceased. Under the liquidation plans, participant account balances were liquidated through lump-sum cash payments or direct rollovers. Participants were notified on February 25, 2025 of the Plan's termination and given 60 days to make elections. Non-responding participants were defaulted into Individual Retirement Accounts (IRAs) at American Century Investments. Liquidation costs to the Plan were not material.

NOTE 5 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of and for the period of October 1, 2024 to May 31, 2025 and for the year ended September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS or Department of Labor; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Some administrative expenses of the Plan are paid directly by the Cooperative.
