Independent Auditor's Report

To: The Plan Administrator and Participants of 603 Healthcare 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed an audit of the accompanying financial statements of 603 Healthcare 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period of February 28, 2024 to December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of the Plan

The following description of 603 Healthcare 401(k) Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on February 28, 2024 by 603 Healthcare, LLC (referred to as the Plan Sponsor, Employer or the Company). The purpose of the Plan is to accumulate retirement income for its employees that will supplement retirement benefits provided to them by Social Security Administration. The Plan is a contributory single-employer 401(k) plan, under Section 401(k) of the Internal Revenue Code (the Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Retirement Committee of the Plan Sponsor has overall responsibility for the operation and administration of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan Sponsor is responsible for the general administration of the Plan. Transamerica Financial Life insurance Company (Transamerica) is the trustee, custodian and recordkeeper of the Plan.

Eligibility

Employee Elective Contributions – All non-union, non-leased employees become eligible to participate following the attainment of age 18 and the completion of three months of service. The entry date is the first day of the plan year quarter coinciding with or following the the date the eligibility requirements were satisfied.

Employer Discretionary Matching Contributions – The Employer may make a discretionary matching contribution equal to a percentage of eligible compensation deferrals. Annually, the Employer will determine the amount of the discretionary match percentage and will provide a separate notice no later than 60 days after the last match payment is made for the plan year. Participants are required to be employed on the last day of the plan year to qualify for discretionary matching contributions, when applicable.

Contributions

Each plan year, participants may elect to contribute a portion of their eligible compensation, as defined in the Plan, up to a maximum of \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, up to a maximum of \$7,500 in 2024. Contributions may be pre-tax or Roth 401(k) contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes automatic deferral of 3% of eligible compensation which is established upon entry into the plan and remains in effect until it is changed by the participant. The automatic deferral will increase annually by 1% up to a maximum of 10% of eligible compensation.

The Company, at its discretion, may make a discretionary matching contribution, equal to a percentage determined by the employer annually, when applicable. During the year ended December 31, 2024, no discretionary matching contributions were made.

Note 1 - Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the employee elective contributions, allocations of the Company's discretionary matching contributions (when applicable) and plan investment earnings and reduced by an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options

Participants must direct their contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year via direct phone or online access. As of December 31, 2024, the Plan offered a selection of mutual funds and one common collective trust fund as investment options for participants.

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's discretionary matching contributions (when applicable) become 20% vested after the second year of service as defined in the Plan document, 40% after the third year, 60% after the fourth year, 80% after the fifth year and 100% after the sixth year. An employee will become 100% vested upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

The vested value of a participant's account may be distributed upon death, disability, retirement or termination of employment. Benefits less than or equal to \$5,000 must be distributed in a single lump-sum payment. Benefits over \$5,000 are payable either by a single lump-sum payment or periodic installments (subject to minimum distribution rules) over a period of not more than the participant's life expectancy. Distributions to Plan participants turning 70 ½ (72 if 70th birthday is on or after July 1, 2019) are required in accordance with the Code and the Plan document.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions and (or) pay plan expenses. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or pay plan expenses. There were no forfeiture balances as of December 31, 2024.

Note 2 - Summary of Accounting Policies

Plan Administration

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Most administrative expenses are paid by the Company, except for the administrative costs associated with participant activity such as loan or distribution fees.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting and in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires that Plan management make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for details on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. While the Plan allows for loans to be taken out, the plan had no outstanding loan balance as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or plan sponsor as provided by the Plan document. Expenses that are paid directly by the plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 3 - Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for period of February 28, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica (the trustee of the Plan). This information has not been audited by the Plan's independent auditors.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

Note 4 - Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of the collective trust per unit based on the underlying investments comprising the trust and based on audited financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Rollover Contributions

An aggregate of \$249,805 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the Statement of Changes in Net Assets Available for Benefits.

Note 6 – Party-In-Interest Transactions

Transamerica is the trustee of the Plan and the Plan invests primarily in mutual funds and a common collective trust fund managed by the trustee, which are considered to be party-in-interest transactions. In addition, the Plan Sponsor paid certain expenses related to plan operations and investment activity to the Plan, and such expenses are excluded from these financial statements.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the company contribution of their account.

Note 8 – Income Tax Status

The Plan obtained its latest determination letter February 28, 2024 in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended is qualified and tax exempt.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 10 - Subsequent Events

The Plan has evaluated subsequent events through December 2, 2025, the date the financial statements were available to be issued and no additional subsequent events have occurred since December 31, 2024 that require recognition or disclosure in these financial statements.
