### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of First Coast Cardiovascular Institute 401(K) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from the qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**Note 1 – Description of the Plan**

The following description of the First Coast Cardiovascular Institute 401(K) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on May 1, 2017, as a defined contribution plan available to eligible employees of First Coast Cardiovascular Institute and the related employers CardioHealth, LLC and Bagnoli and Salah MD's Medical Group (collectively, the Company, Employers or Plan Sponsor). The Plan has been amended and restated throughout the years to comply with certain tax legislation. The Plan covers substantially all full-time employees of the Employers. Eligible employees are full-time employees who have completed 1,000 hours of service in a twelve month period and have reached the age of twenty-one (21) as defined in the Plan document. An employee shall become a participant on the first day of the first and seventh month following the date the employee completes the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan Administrator. Charles Schwab Trust Bank (the Trustee) is the Plan's trustee. Charles Schwab Trust Bank holds the Plan's investment assets, executes investment transactions and provides recordkeeping services.

Plan amendment

Effective, April 10, 2024, the Plan was amended to include credited years of service with the predecessor employers- CardioHealth, LLC and Bagnoli and Salah MD's Medical Group for its eligibility service requirement.

Contributions

Each year, participants may voluntarily contribute up to 100% of their annual eligible compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (the IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified or contribution plans (rollover). The Plan's provisions also provide for Roth 401(k) elective deferrals.

The Plan includes an auto enrollment provision whereby all newly hired employees are automatically enrolled in the Plan after reaching the 1,000 hours of service in a twelve month period of credited service requirement unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 6%. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a qualified automatic contribution arrangement (QACA) safe harbor match which is equal to 100% of the first 1% of a participant's eligible compensation, plus 50% of the next 6% of the participant's eligible compensation, as defined. For the year ended December 31, 2024, the Company's QACA safe harbor matching contribution totaled \$143,930. The Company may make additional discretionary and non-elective profit-sharing contributions to the Plan. No such discretionary or non-elective profit-sharing contributions were made during the year ended December 31, 2024. Participants are eligible for the Company's safe harbor, discretionary or non-elective profit-sharing contributions after meeting the eligibility requirements to participate in the Plan. All Employers' contributions are invested in funds in accordance with the participant's direction and the Plan's provisions. Contributions are subject to certain IRS limitations.

**Note 1 – Description of the Plan, Continued**

Participant accounts

Each participant account is credited with the participant's contributions and an allocation of (a) the Employers' contributions (if any), and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Employers' QACA safe harbor contributions, plus actual earnings or losses thereon. Vesting in the Employers' discretionary and non-elective profit-sharing contributions, plus earnings or losses thereon, is based upon the number of years of credited service. A participant is 100% vested in the Employers' discretionary and non-elective profit sharing contributions after six years of credited service based on a six-year graded vesting schedule. Regardless of years of service, participants are 100% vested upon reaching normal retirement age (65), becoming disabled, or upon death or termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to offset certain Plan administrative expenses or reduce future employer contributions. For the year ended December 31, 2024, forfeitures totaling \$6,582 were used to reduce the Employers' contributions. At December 31, 2024 and 2023, available unallocated forfeitures totaled \$8,022 and \$288, respectively.

Notes receivable from participants

Participant loans are not permitted under the Plan's provisions .

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in partial withdrawals. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$5,000 must elect a lump-sum distribution. Participants may elect to take an in-service distribution of vested funds if they meet certain defined requirements, including becoming disabled, reaching age 59½, or for heavy financial hardship needs, as defined.

Plan administration

The Company is the Plan Administrator and, as such, controls and manages the operations of the Plan. Charles Schwab Trust Bank (the Trustee) maintains the records of the participant data and invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of participants). Fees from covered service providers of the Plan are in compliance with the Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2). The Plan has contracted with NestEggs Retirement Plan Services to provide third party administrative services and fiduciary services to the Plan.

**Note 2 – Summary of Significant Accounting Policies, Continued**

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and the Plan's Trustee.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and those differences may be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the level of risk associated with certain investment securities, including the uncertainty related to changes in the value of investment securities, it is at least reasonably possible changes in such risks in the near-term would materially affect participants' account balances and the amounts reported in the financial statements.

Payment of benefits

The Plan records benefits when paid.

Plan expenses

Investment related expenses are included in net appreciation in fair value of investments. Certain administrative expenses, such as recordkeeping, trustee, and third-party administrator fees, are paid from Plan assets and classified as an expense rather than as a reduction of investment income. Certain other administrative expenses are paid by the Plan Sponsor and are not reflected in these financial statements.

Contributions

Contributions from Plan participants and the matching contributions from the Employers are recorded in the year in which the employee contributions are withheld from compensation.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the Trustee, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown on the statement of net assets available for benefits as of December 31, 2024;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H – Line 4i Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan’s independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial investment level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. There were no transfers of financial instruments into or out of Level 3 for the year ended December 31, 2024.

**Note 4 – Fair Value Measurements, Continued**

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds* – are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are deemed to be actively traded on national exchanges and transact at their published daily net asset value (NAV).

*Money market fund* – Money market fund is a public investment vehicle that is valued at the NAV of \$1. This NAV is a quoted price in an active market; thus these investments are classified within Level 1 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the Employers' contribution portion of their accounts.

**Note 6 – Party-in-Interest Transactions**

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers, and certain others. The Plan's investments are managed and administered by Charles Schwab. Charles Schwab is the Plan's Trustee and recordkeeper and, therefore, these transactions with Charles Schwab qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Employers. No officer or employee receives compensation from the Plan for these services.

The Plan contracted with NestEggs for third party administrative services. Therefore, these transactions qualify as party-in-interest transactions. The Plan Compensates NestEggs directly for such services. Such transactions are exempt from the prohibited transaction rules under ERISA.

**Note 7 – Tax Status**

On June 30, 2020, the IRS stated that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the Plan and its related trust is tax-exempt. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the Non-Standardized Pre-Approved letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Delinquent Participant Contributions**

For the year ended December 31, 2024, participant contributions totaling \$99,500, were not remitted to the Plan within the period prescribed by DOL regulations. Such transactions constitute non-exempt party-in-interest transactions as defined by ERISA. The Employers have not corrected the 2024 transactions for lost earnings as of the date of this report.
