INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Opinion

We have audited the accompanying financial statements of the RaceTrac, Inc. Group Health and Life Insurance Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the benefit obligations and net assets available for benefits (modified cash basis) of the RaceTrac, Inc. Group Health and Life Insurance Plan as of December 31, 2024 and 2023, and the changes in its benefit obligations and net assets available for benefits (modified cash basis) for the years then ended, in accordance with the modified cash basis of accounting as described in Note B.

Basis for Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A -- PLAN DESCRIPTION

The following description of the Racetrac, Inc. Group Health and Life Insurance Plan (the "Plan") provides only general information. Participants should refer to their participants' handbook or the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a contributory "employer welfare benefit plan" within the meaning of Section 3(1) of the Employee Retirement Income Security Act. The Plan was created for the purpose of providing hospitalization, accident, sickness, and death benefits to eligible employees of RaceTrac, Inc., Metroplex Energy, Inc., and Energy Dispatch, LLC, and their dependents. The Plan is self-funded from employee and employer contributions for most claims. The amount of contributions required from participants is determined by the Plan's Sponsor from time to time on a uniform and nondiscriminatory basis with respect to all persons similarly situated. Claims are paid directly by the Plan rather than by an insurance company. However, the Plan carries life insurance to cover Plan death benefits and aggregate and specific stop loss insurance. Stop loss insurance covers claims in excess of deductible amounts for medical or hospitalization claims. Recoveries from the stop loss insurance carrier of approximately \$4,156,000 and \$1,592,000 for 2024 and 2023, respectively, are netted into benefits paid to participants in the accompanying financial statements. The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 will be funded by future employer and employee contributions.

During 2023, RaceTrac, Inc. approved the reorganization of its ERISA-governed health and welfare plans, including the termination effective as of December 31, 2023, of a related plan for which the Plan has historically paid for dental claims incurred by this related plan for which it was to be reimbursed. Concurrent with the termination of this related plan, net assets of approximately \$1,990k and benefit obligations of approximately \$208k were transferred out of the related plan to the Plan.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The statements of benefit obligations and net assets available for benefits and changes in benefit obligations and net assets available for benefits have been prepared using the modified cash basis of accounting. The modified cash basis of accounting means that contributions and other revenues are recognized when received and claims and other expenses are recognized when paid. All qualified claims are contractual obligations of the employer. They must be funded when presented for payment by either the Plan, the Plan's stop loss insurance carrier or the employer.

Estimates:

The preparation of financial statements requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Obligations:

Plan obligations for health claims incurred by active participants but not reported at the end of the fiscal year are estimated by the Plan Administrator based on payments by the Plan subsequent to year end.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Benefit Obligations (Continued):

The Plan's benefit obligations are reported based on certain assumptions pertaining to benefit obligations paid after the end of the year. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Cash:

The Plan maintains its cash deposits at high credit financial institutions. Balances at times may exceed federally insured limits.

Date of Management's Review:

Subsequent events were evaluated through December 24, 2025, which is the date the financial statements were issued. Management has determined that no subsequent event disclosures are required.

NOTE C -- INCOME TAXES

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress and the Plan believes that it has no uncertain tax positions. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE D -- TERMINATION OF THE PLAN

Although the Sponsor has not expressed any intention to do so, RaceTrac, Inc. has the right under the Plan to modify the benefits provided and to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination, the assets then remaining should be subject to the applicable provisions of the Plan then in effect and should be used until exhausted to pay administrative expenses of the Plan and benefits to employees in the order in which claims were submitted.

NOTE E -- TRANSACTIONS WITH PARTIES IN INTEREST

The Plan's Sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. This party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

NOTE F -- TRANSACTIONS WITH RELATED PARTY

The Plan's Sponsor separately sponsored a plan that was created for the purpose of providing hospitalization, dental and vision care to eligible employees and their dependents until the related plan's termination effective as of December 31, 2023. Prior to the related plan's termination, the Plan paid for dental claims incurred by this related plan for which it subsequently sought reimbursement.
