### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**1. DESCRIPTION OF THE PLAN**

The following description of KR Contracting, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established on January 1, 2017 by KR Contracting, Inc. (the Company) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 12, 2023, the plan assets of the Plan were transferred from the Plan and merged with Trinity Technology, Inc. 401(K) Profit Sharing Plan and Trust into a new retirement plan.

Administration

The Company has appointed an Investment Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Reliance Trust Company (collectively referred to as "Reliance") to act as the trustee, custodian, and third-party administrator to process and maintain the records of participant data.

Participant contributions

The Plan document provides, among other things, that participants may contribute up to 100% of the compensation they receive from the Employer during the plan year, up to the maximum contribution allowed by the Internal Revenue Service, in the form of a pre-tax contribution.

Individual accounts are established for each participant. Each individual account is credited with the sum of all contributions made on behalf of the participant, plus Plan earnings minus an allocation of expenses of the Plan. Each participant is always 100% vested in his individual account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon having contributions remitted to the Plan, a participant may direct contributions credited to their account to any of the investment options.

Participants may redirect future contributions or exchange existing account balances at any time.

Employer contributions

The Company is allowed to make contributions to the Plan in the form of discretionary non-elective contributions, as defined in the Plan and as approved by the Board of Directors. In addition, the Company may, at its sole discretion, make additional non-elective contributions to the Plan in an amount necessary to meet the Company's requirements under an applicable prevailing wage statute.

Retirement benefits

The participant is entitled to the amount in their account, after reaching the older of normal retirement age or age 65. The benefit is paid in the form of a lump-sum distribution, partial payment, installment payments, or at the election of the participant the distribution may be rolled over to another qualified plan.

Vesting

Participants are immediately vested in their contributions. Participants are also fully vested in the employer's matching and profit-sharing contributions allocated to their account.

Death benefits

In the event that a participant dies before retirement, unless elected otherwise, the amount accumulated in the participant's account is paid in the form of extended payments or in a lump-sum distribution to the participant's beneficiary.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

Participant accounts

Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the Company's contribution, if any. Allocation of the Company's contribution is based on participant contributions or eligible employee compensation, as defined in the Plan.

Forfeitures

Forfeitures that are attributable to non-elective employer contributions are used to restore forfeitures, to reduce the non-elective employer contributions for the plan year in which such forfeitures occur, or to pay reasonable Plan expenses. At January 12, 2023 and December 31, 2022, forfeited non-vested accounts was \$0 and \$0, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into 28 investment options.

The options are listed, in the enrollment information provided during orientation and changes in investment option are timely provided to the plan participants.

Participant Loans Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Interest rates on outstanding participant loans accrue interest at the Prime Rate of interest. Principal and interest are paid ratably through weekly and biweekly payroll deductions.

Participant loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Basis of Accounting

These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions and deductions to net assets available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt or payment.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investments

The Plan's investment contract with the insurance company is stated at a contract value which approximates cost. Plan management has determined the deposit administration account to have fully benefit-responsive features, and thus has reported it at contract value. Contract value represents contributions made under the contract, plus interest income, less distributions for benefits and administrative expenses to date.

Purchase and sales transactions are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The Plan's administrator assigns levels and categories to the Plan's investments.

Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2: Observable inputs other than quoted prices for the assets, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan. This may include matrix pricing, yield curves and indices. No Level 2 inputs were available to the Plan.

Level 3: Unobservable inputs that reflects the Plan's own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances. No Level 3 inputs were available to the Plan.

**4. GUARANTEED INVESTMENT CONTRACT**

In 2021, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya) totaling \$0 for 2023 and \$243,325 for 2022. Voya maintains the contributions in a general fixed account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) and uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**5. PARTY-IN-INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees paid by the Plan for recordkeeping services amounted to \$4,491 for the period from January 1, 2023 to January 12, 2023. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan.

**6. TAX STATUS**

The Internal Revenue Service (IRS) has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Service Code (IRC). Although the Plans has been amended, the plan administrator believes the Plan document is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management of an organization to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

There are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.

**7. PLAN TERMINATION**

The Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, each participant will become 100% vested in their accounts, after the payment of all administrative expenses and benefits previously approved. Each participant will receive a portion of the total remaining assets in the same ratio as his or her account bears to the aggregate amount of all participants' accounts. On January 12, 2023 the Plan assets were transferred and merged into a new plan with Trinity Technology, Inc. 401(K) Profit Sharing Plan and Trust.

**8. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits and Note 3 as of January 12, 2023 and December 31, 2022, and on the schedule of assets (held at end of year) as of January 12, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period from January 1, 2023 to January 12, 2023.

**9. CARES ACT AND SECURE ACT**

The Plan will implement certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, amount others, allowing certain eligible individuals to receive Coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The optional features within these acts are currently being assessed but have not been implemented to date. Written amendments to the Plan to reflect these operational changes will be adopted at a late date in accordance with applicable law and IRS guidance.

**10. EVALUATION OF SUBSEQUENT EVENTS**

The Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through December 29, 2025, which is the date the financial statements were available to be issued.



**1. DESCRIPTION OF THE PLAN**

The following description of KR Contracting, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established on January 1, 2017 by KR Contracting, Inc. (the Company) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 12, 2023, the plan assets of the Plan were transferred from the Plan and merged with Trinity Technology, Inc. 401(K) Profit Sharing Plan and Trust into a new retirement plan.

Administration

The Company has appointed an Investment Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Reliance Trust Company (collectively referred to as "Reliance") to act as the trustee, custodian, and third-party administrator to process and maintain the records of participant data.

Participant contributions

The Plan document provides, among other things, that participants may contribute up to 100% of the compensation they receive from the Employer during the plan year, up to the maximum contribution allowed by the Internal Revenue Service, in the form of a pre-tax contribution.

Individual accounts are established for each participant. Each individual account is credited with the sum of all contributions made on behalf of the participant, plus Plan earnings minus an allocation of expenses of the Plan. Each participant is always 100% vested in his individual account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon having contributions remitted to the Plan, a participant may direct contributions credited to their account to any of the investment options.

Participants may redirect future contributions or exchange existing account balances at any time.

Employer contributions

The Company is allowed to make contributions to the Plan in the form of discretionary non-elective contributions, as defined in the Plan and as approved by the Board of Directors. In addition, the Company may, at its sole discretion, make additional non-elective contributions to the Plan in an amount necessary to meet the Company's requirements under an applicable prevailing wage statute.

Retirement benefits

The participant is entitled to the amount in their account, after reaching the older of normal retirement age or age 65. The benefit is paid in the form of a lump-sum distribution, partial payment, installment payments, or at the election of the participant the distribution may be rolled over to another qualified plan.

Vesting

Participants are immediately vested in their contributions. Participants are also fully vested in the employer's matching and profit-sharing contributions allocated to their account.

Death benefits

In the event that a participant dies before retirement, unless elected otherwise, the amount accumulated in the participant's account is paid in the form of extended payments or in a lump-sum distribution to the participant's beneficiary.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

Participant accounts

Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the Company's contribution, if any. Allocation of the Company's contribution is based on participant contributions or eligible employee compensation, as defined in the Plan.

Forfeitures

Forfeitures that are attributable to non-elective employer contributions are used to restore forfeitures, to reduce the non-elective employer contributions for the plan year in which such forfeitures occur, or to pay reasonable Plan expenses. At January 12, 2023 and December 31, 2022, forfeited non-vested accounts was \$0 and \$0, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into 28 investment options.

The options are listed, in the enrollment information provided during orientation and changes in investment option are timely provided to the plan participants.

Participant Loans Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Interest rates on outstanding participant loans accrue interest at the Prime Rate of interest. Principal and interest are paid ratably through weekly and biweekly payroll deductions.

Participant loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Basis of Accounting

These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions and deductions to net assets available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt or payment.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investments

The Plan's investment contract with the insurance company is stated at a contract value which approximates cost. Plan management has determined the deposit administration account to have fully benefit-responsive features, and thus has reported it at contract value. Contract value represents contributions made under the contract, plus interest income, less distributions for benefits and administrative expenses to date.

Purchase and sales transactions are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The Plan's administrator assigns levels and categories to the Plan's investments.

Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2: Observable inputs other than quoted prices for the assets, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan. This may include matrix pricing, yield curves and indices. No Level 2 inputs were available to the Plan.

Level 3: Unobservable inputs that reflects the Plan's own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances. No Level 3 inputs were available to the Plan.

**4. GUARANTEED INVESTMENT CONTRACT**

In 2021, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya) totaling \$0 for 2023 and \$243,325 for 2022. Voya maintains the contributions in a general fixed account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) and uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**5. PARTY-IN-INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees paid by the Plan for recordkeeping services amounted to \$4,491 for the period from January 1, 2023 to January 12, 2023. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan.

**6. TAX STATUS**

The Internal Revenue Service (IRS) has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Service Code (IRC). Although the Plans has been amended, the plan administrator believes the Plan document is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management of an organization to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

There are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.

**7. PLAN TERMINATION**

The Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, each participant will become 100% vested in their accounts, after the payment of all administrative expenses and benefits previously approved. Each participant will receive a portion of the total remaining assets in the same ratio as his or her account bears to the aggregate amount of all participants' accounts. On January 12, 2023 the Plan assets were transferred and merged into a new plan with Trinity Technology, Inc. 401(K) Profit Sharing Plan and Trust.

**8. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits and Note 3 as of January 12, 2023 and December 31, 2022, and on the schedule of assets (held at end of year) as of January 12, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period from January 1, 2023 to January 12, 2023.

**9. CARES ACT AND SECURE ACT**

The Plan will implement certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, amount others, allowing certain eligible individuals to receive Coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The optional features within these acts are currently being assessed but have not been implemented to date. Written amendments to the Plan to reflect these operational changes will be adopted at a late date in accordance with applicable law and IRS guidance.

**10. EVALUATION OF SUBSEQUENT EVENTS**

The Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through December 29, 2025, which is the date the financial statements were available to be issued.
