### Note 1: Description of Plan

The following description of the Serigraph, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

### General

Serigraph, Inc. (the Company) is the Plan sponsor. Associated Trust Company is the trustee and recordkeeper of the Plan. The Plan is administered by the Plan's Administrative Committee.

### Eligibility

Substantially all full-time employees of the Company who have reached 18 years of age are eligible to make contributions to the Plan. As of July 1, 2024, long-term, part-time employees who worked more than 500 hours in three consecutive years may enter the Plan subsequent to reaching 18 years of age. Prior to July 1, 2024, part-time employees who completed 1,000 hours per year and reached 18 years of age are also eligible to make contributions to the Plan. After six months of service, participants are eligible to receive discretionary Company matching contributions. After two years of service, participants are eligible to receive discretionary Company profit sharing contributions.

### Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation which will automatically be increased by 1% every September 1st, up to 15%.

As of February 5, 2024, the Company match was reinstated whereby the Company matched 50% of the first 4% of participant contributions. Prior to February 5, 2024, the Company match was suspended. Company matching contributions were \$358,016 for the year ended June 30, 2025. There were no Company profit sharing contributions made for the year ended June 30, 2025.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, as well as allocations of the Company's profit sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and any Company profit sharing contributions plus actual earnings (losses) thereon. The Company's matching contributions vest according to a four-year vesting schedule as follows:

Less than 2 years	0 %
2 Years	50 %
3 Years	75 %
4 Years or more	100 %

Participants become fully vested in the Company's matching contributions upon death or total and permanent disability.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Interest rates on the notes are determined by the Plan Administrator, and are commensurate with prevailing market rates. The maximum repayment period is five years, except in the case of a note to purchase a principal residence, in which case the term of the note is consistent with applicable laws and tax regulations. Interest rates on existing notes range from 4.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

#### Benefit Payments

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. Benefit payments are made in the form of lump-sum, equal installments over a period not to exceed the assumed life expectancy of the beneficiary, or any other method agreed to by the participant and the Plan Administrator, and which is allowable under the Internal Revenue Code (IRC). Under certain circumstances, participants may qualify for hardship withdrawals.

#### **Forfeited Accounts**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in Company contributions. Forfeitures are used to pay administrative expenses or reduce Company contributions. The amount of unallocated forfeitures was \$9,119 and \$2,039 as of June 30, 2025 and 2024, respectively. In 2025, administrative expenses of \$12,793 were paid from the forfeited nonvested account.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates and are subject to change in the near term.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

#### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Participant note and withdrawal fees are paid by participants. In 2025, professional fees were paid by the Plan. Substantially all other administrative expenses are paid by the Company. Expenses paid by the Company are excluded from these financial statements.

#### Subsequent Events

Subsequent events have been evaluated through December 5, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Certified by the Plan Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Associated Trust Company (the trustee of the Plan).

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* The fair value of common collective trusts represents the NAV of the fund shares. NAV is based on the value of the underlying assets owned by the funds minus liabilities.

### Note 4: Fair Value Measurements (Continued)

The MetLife Stable Value Group Annuity Contract, is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the bank collective trust. The fund's objective is to provide safety of principal, adequately liquidity, and a competitive yield with low return volatility. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The Putnam Stable Value, whose fair value is primarily based on quoted market prices for the underlying securities or similar instruments. The NAV of the common collective trust itself is not publicly quoted but the values are not dependent on the input of any significant judgments or assumptions by management. The primary investment objective of the Putnam Stable Value is to seek the preservation of capital. The fund primarily invests in investment contracts issued by insurance companies, banks and other financial institution.

Investments in the common collective trust funds can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4: Fair Value Measurements** (Continued)

(a) In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits. The NAV, as provided by the trustee, is used as practical expedient to estimate fair value.

### **Note 5: Income Tax Status**

The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator is not aware of any significant uncertain tax positions taken by the Plan.

### **Note 6: Party-In-Interest Transactions**

Certain Plan investments are managed by the trustee, and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in all Company contributions.
