To Whom It May Concern at the Internal Revenue Service,

HLA & Associates LLC, established its 401(k)-retirement plan in 2020. From 2020 through 2023, our previous HR, payroll, and 401(k) administrator, Paychex, handled all aspects of plan administration, including the timely preparation and electronic filing of the annual Form 5500 with the Department of Labor and IRS. While I was not personally involved in the filing process, I reasonably assumed that this critical compliance obligation continued to be managed on our behalf, as it had been for the prior five years.


In 2024, in an effort to reduce costs, we transitioned our HR, payroll, and 401(k) administration to ADP. Unfortunately, the scope of services with ADP does not include automatic preparation and filing of Form 5500. Neither Paychex nor ADP clearly communicated that this responsibility would shift to us upon the change in providers. As a result, the 2024 Form 5500 was not filed by the extended due date of October 15, 2025.

As soon as I became aware of the oversight in late November 2025, I worked promptly with ADP to complete and electronically file the return.

This is the first late Form 5500 in the plan's history, and the delay was caused solely by the transition between administrators and a misunderstanding of which provider was responsible for the filing. We have now documented the Form 5500 requirement in our internal compliance calendar and have engaged appropriate resources to ensure future filings are completed well in advance of the deadline.

We respectfully request that any late-filing penalties assessed by the IRS and the Department of Labor be abated in full under the reasonable-cause provisions.
