Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Pipe Fitters Local No. 533 Individual Account Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Pipe Fitters Local No. 533 Individual Account Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Pipe Fitters Local No. 533 Individual Account Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pipe Fitters Local No. 533 Individual Account Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Pipe Fitters Local No. 533 Individual Account Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on June 1, 1987, pursuant to a collective bargaining agreement between Pipe Fitters Association Local Union No. 533 (the Union) and the Mechanical Contractors Association of Kansas City (the Association). The Plan is a defined contribution plan covering all members of the Union working for employers contributing to the Plan. The Plan has been most recently restated effective January 1, 2015 and amended effective January 1, 2024. It is subject to the provisions of ERISA, as amended.

Eligibility

Employees become a Participant in the Plan on the date on which a contribution is received by the Plan on their behalf, as an Employee, from an Employer.

Contributions

Participating employers contribute to the Plan a stipulated amount for each hour worked by the member pursuant to the current collective bargaining agreement between employers and the Union. The Plan permits rollover contributions from Individual Retirement Accounts that comply with Internal Revenue Code (IRC) Section 408(a) and other tax-qualified plans. Employee deferrals are not required or permitted.

Effective October 18, 2023, the Plan was amended to permit rollovers from Individual Retirement Accounts that comply with IRC Section 408(a).

Employer contributions are subject to audit, and any delinquent accounts are subject to liquidated damages. At any point in time, certain accounts are receivable by the Plan due to audit results and may be the subject of various disputes or legal actions.

Participant Accounts

Each participant's account is credited with the Employer's contributions and allocations of Plan earnings or losses and expenses. Allocations are based on participant hours worked or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various investment options for participants including mutual funds and a collective trust fund.

Vesting

Participants are immediately 100% vested in all contribution sources.

Payment of Benefits

Distribution of a participant's account commences after any of the following events:

1. Retirement
2. Total and permanent disability
3. Death
4. No employer contributions to the participant's account for 12 or more consecutive months and the employee has not worked in the pipefitting industry in the area of the plan during that 12-month period.

Benefits are paid as either a 50% Joint & Survivor Annuity, a 75% Joint & Survivor Annuity, or a Single Life Annuity, depending upon a Participant's marital status when they receive their benefits. Participants may reject this form of payment and elect to receive their benefit in the form of a single, lump-sum payment or partial lump-sum payments.

Distributions may be paid automatically when the participant's benefits are equal to or less than \$1,000, no employer has remitted contributions on the participant's behalf for the prior 12 consecutive months, and the participant has not worked in the plumbing and pipefitting industry in the Plan's geographic jurisdiction within the prior 12 consecutive months. These distributions are paid in a single lump sum.

If a participant reaches their Required Beginning Date (RBD) of a Required Minimum Distribution (RMD) the participant may elect to receive a partial lump-sum distribution equal to their RMD amount once per year.

Effective January 1, 2024, the Plan was amended to modify the required minimum distribution rules for participants and surviving spouses that turn 73 after December 31, 2023.

Plan Termination

In the event of termination of the Plan, the assets then remaining, after providing for the expenses of the Plan and for the payment of any accumulated shares theretofore approved shall be distributed among the Participants. Each participant shall receive that part of the total remaining assets in the same ratio as his accumulated share bears to the aggregate amount of the accumulated shares of all participants.

Plan Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated August 28, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Plan Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through December 18, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at May 31, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Transamerica Retirement Solutions is the custodian of the investments as defined by the Plan. In addition, the Plan invests in investments managed by Transamerica as a registered investment advisor. Therefore, fees paid to Transamerica qualify as party-in-interest transactions. Fees of \$79,395 and \$74,488 were paid by the Plan to Transamerica for the years ended May 31, 2025 and 2024, respectively.
