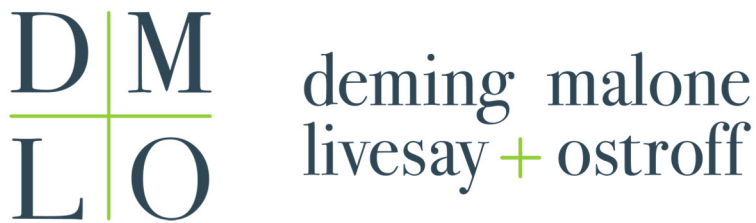

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D & M Tool Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Description of Plan

The following description of D & M Tool Corporation (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution retirement savings plan covering all full-time employees of Apollo Plastics Corporation, D & M Tool Corporation, PRD, Inc. and Specialty Manufacturers, Inc. (parent company) who have reached six months of service, are eighteen or older and have worked 1,000 hours. Excluded employees are union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining or certain nonresident aliens who have no earned income sources from within the United States. The Plan was established October 1, 1979 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Contributions:

Each year participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may also elect to defer a portion of their after-tax compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a contribution to match the employees’ elective deferrals. For the years ending December 31, 2024 and 2023, the Company matched 2% of participant deferrals contributed to the Plan. Discretionary profit sharing contributions may be made at the option of the Company’s board of directors. There were no discretionary profit sharing contributions made for the years ending December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant’s account is credited with the participant’s contribution and company matching contributions, as well as allocations of the company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years, then vests an additional 20% per year through six years of credited service, at which time the participant is 100% vested.

Payment of benefits:

On termination of service due to death, disability, or attaining normal retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service and hardship withdrawals are also permitted as defined in the plan agreement.

Forfeitures:

Forfeitures are used to pay for administrative expenses of the Plan and then may be used to decrease Company contributions to the Plan. At December 31, 2024 and 2023, there were no forfeited, non-vested accounts. Forfeited amounts of \$5,080 and \$6,250 were used to pay for administrative expenses and reduce employer contributions of the Plan during the years ended December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for the integrity and objectivity of the financial statements. The accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transition between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation of investments. Expenses of maintaining the Plan are paid by the Company and the Plan.

Date of management's review:

Management has evaluated events and transactions through December 12, 2025, the date the financial statements were available to be issued.

Note 3. Summary of Information Certified by Plan Trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by AdvisorTrust, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-In-Interest Transactions

D & M Tool Corporation (“Plan sponsor”) provides the Plan with certain administrative services for which no fees are charged. No officer or employee receives compensation from the Plan.

Creative Benefit Strategies (CBS), is the third-party administrator of the Plan, and therefore transactions with CBS qualify as party-in-interest transactions. Fees paid to CBS for the years ended December 31, 2024 and 2023 totaled \$11,485 and \$10,433, respectively.

Cambridge Investment Research, Inc. (Cambridge), is the investment advisor of the Plan, and therefore transactions with Cambridge qualify as party-in-interest transactions. Fees paid to Cambridge for the years ended December 31, 2024 and 2023 totaled \$12,500 and \$10,000, respectively.

PCS Retirement, LLC (PCS), is the recordkeeper of the Plan, and therefore transactions with PCS qualify as party-in-interest transactions. Fees paid to PCS for recordkeeping for the years ended December 31, 2024 and 2023 totaled \$9,032 and \$6,237, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one-hundred percent vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Income Tax Status

The Plan is a prototype plan offered by Creative Benefit Strategies, Inc. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and is exempt from federal income taxes. The Plan has been amended since the date of the opinion letter. However, the plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the

applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Prohibited Transactions

During the Plan years ending December 31, 2024 and 2023, certain employee contributions totaling \$9,379 and \$13,540, respectively, were not remitted to the Plan within the period prescribed by the Department of Labor regulations. The Company will make a contribution during 2025 to the affected participants' accounts to compensate those participants for lost earnings due to the delays.

During the Plan year ending December 31, 2024, plan expenses were paid from forfeitures in excess of the forfeiture amount available. The result was a negative balance of \$1,722 in the forfeiture account, which constitutes a nonexempt prohibited transaction and is reported in the Statements of Net Assets Available for Benefits as an Other Receivable. At December 31, 2024, \$1,722 was due to Plan for the prohibited transaction. The Company will make a contribution during 2025 to correct the prohibited use of Plan assets. No such matters were noted for the Plan year ending December 31, 2023.

Note 10. Subsequent Event

Subsequent to year end, the Plan selected Principal as its new Trustee. As of November 11, 2025 the Plan completed its transition to Principal.
