## Independent Auditors' Report

To the Plan Administrator  
of National Instruments 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the National Instruments 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As discussed in Note 11 to the financial statements, the Plan's 2024 financial statements reflect Plan net assets of \$0 as of December 31, 2024, as the Plan was terminated as of December 31, 2024 and assets were legally transferred to another employee benefit plan on December 31, 2024. Our opinion is not modified with respect to this matter.



## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

As of December 31, 2024 and 2023 and for the year ended December 31, 2024

(As Restated)

### 1. Description of the Plan

#### General

National Instruments 401(k) Plan (the “Plan”) became effective July 1, 1985 and covers substantially all eligible employees of National Instruments Corporation and certain adopting employers (collectively the “Company” or “Plan Sponsor”). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. All Plan assets are held by Charles Schwab Bank.

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more comprehensive description of the Plan’s provisions, a copy of which is available from the Company.

#### Plan Amendment and Transfer of Assets

On March 6, 2023, the Company acquired a 70% ownership interest in Tech180 Inc., and on August 11, 2023, the Company acquired the remaining 30% ownership interest. Following the full acquisition, the Company approved a corporate resolution effective August 11, 2023, to merge the Tech180 Inc. 401(k) Profit Sharing Plan and Trust (“Tech180 401(k) Plan”) into the Plan. As a result, all participants of the Tech180 401(k) Plan became active participants in the Plan. On May 22, 2024, all assets of the Tech180 401(k) Plan were transferred into the Plan, including approximately \$2 million in cash. Participants were required to make new investment elections in the Plan.

#### Plan Termination

On October 11, 2023, the Plan Sponsor was acquired by Emerson Electric Co. The Plan was terminated on December 31, 2024, and assets were legally transferred to the Emerson Savings Plan. The majority of assets were transferred in February 2025, with the remainder transferred by June 4, 2025, at which date the Plan’s asset balance was \$0.

#### Eligibility

Employees are eligible to participate upon the attainment of 18 years of age and date of hire. Under the enrollment provisions of the Plan, eligible employees are allowed to enter the Plan on the first day of each calendar month after meeting the eligibility requirements. Effective as of July 1, 2022, to be eligible for Company contributions, a participant must complete six months of service. Union employees, non-resident employees, leased employees, interns, and employees classified as co-ops, are not eligible to participate in the Plan.

#### Contributions

Participants may contribute up to 80% pre-tax of their annual compensation, as defined by the Plan. Roth contributions, catch-up contributions, and after-tax contributions up to 80% are allowed. Participant contributions are subject to certain Internal Revenue Code (the “Code”) limits. Participants may also contribute amounts representing distributions from other qualified defined contribution plans or individual retirement accounts (“rollovers”). The Plan also allows for in-plan Roth rollovers.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% unless the employee elects a different percentage or elects not to participate.

### 1. Description of the Plan (continued)

The Company may make matching contributions to the Plan equal to a discretionary percentage, to be determined by the Company, of the participant's contributions. For 2024, the Company made matching contributions of 50% of the first 8% of pre-tax contributions. All contributions are participant-directed into the investment options disclosed in Note 3. Employer contributions are subject to certain limitations.

#### Participant Accounts

Participants direct the investment of their accounts among various investment options offered by the Plan. Participants may change their investment options daily.

Each participant's account is credited with (a) participant's contributions, (b) an allocation of employer contributions and (c) an allocation of investment earnings, and is charged with (a) withdrawals, (b) an allocation of investment losses and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in both participant and Company contributions, including rollover contributions, plus actual earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of i) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or ii) 50% of their vested account balance, whichever is less. Notes receivable from participants are collateralized by the vested balance in the participant's account. Interest rates on participant loans are established at the prevailing prime interest rate at the time the loan is made plus 2%. Participants may only have one note receivable outstanding at a time. Principal and interest is paid through payroll deductions with equal installments made each pay period. The repayment period cannot exceed five years, unless the funds are used for purchase of a principal residence in which case repayment terms may be extended.

#### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount, installment, or partial payments equal to the vested interest in his or her account. For termination of service for other reasons, a participant may receive a lump-sum amount, installment, or partial payments equal to the value of his or her account balance beginning upon termination of service. In general, if a participant's vested account balance, as defined by the Plan, is greater than \$5,000 and employment is terminated other than due to retirement or death, the account may not be distributed before normal retirement without the participant's consent. Participants' account balances that are less than \$5,000 will be paid in cash or as a direct rollover to an individual retirement account. Participants are required to begin receiving distributions in accordance with the minimum distribution requirements of Internal Revenue Code section 401(a)(9).

### 1. Description of the Plan (continued)

In-service distributions may be made in the event of a hardship or if the participant has attained age 59.5. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (“IRS”). Distributions are subject to the applicable provisions of the Plan agreement.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

### 2. Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Risks and Uncertainties

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements and supplemental schedule.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and expenses charged to the Plan for investments in mutual fund accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs.

#### Payment of Benefits

Benefits to participants are recorded by the Plan when actual payment is made.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payment transactions are charged directly to the participant's account and are included in administrative expenses.

#### Recent Accounting Standards

The SECURE 2.0 Act of 2022, enacted on December 29, 2022, includes a wide range of provisions affecting retirement plans, with effective dates spanning from 2023 through 2026. Plan management has implemented operational changes necessary to comply with applicable provisions effective for the years ended December 31, 2024 and 2023. The Plan has until December 31, 2025 to adopt formal amendments. Plan management continues to evaluate the impact of SECURE 2.0 on future periods. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

### 3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

- d. This category includes a common/collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. The Galliard Retirement Income Fund is primarily invested in the Wells Fargo Synthetic Stable Value Fund. The fair value of this fund is valued at the net asset value of units held at year-end in accordance with the practical expedients available under ASC 820. Participant transactions (purchases and sales) may occur daily, however, the Plan has potential limitations on redemption which can delay complete redemption for a period of one year. Participant redemptions for common collective trusts are permitted with no other restrictions or notice periods and there are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no participant redemption restrictions for this investment; the redemption notice period is applicable only to the Plan.

### 4. Information Certified by the Custodian

### **5. Related-Party Transactions and Party-In-Interest Transactions**

Plan assets include investments in funds managed by Charles Schwab Bank, the custodian of the Plan, and notes receivable from participants. Therefore, these transactions qualify as party-in-interest transactions under ERISA and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### **6. Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated September 21, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is tax-exempt. The Plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for three years.

### **7. Excess Contributions Payable**

During the year ended December 31, 2023, the Plan received contributions of \$25,850 in excess of certain IRC code sections. The excess contributions were related to participants exceeding IRS annual limits elective deferrals and/or annual additions to the participants' accounts. The Plan administrator corrected the issue by forfeiting the excess contributions from the participants' accounts and making the corrective distributions in August and September 2024, in accordance with IRS requirements for the Plan year ended December 31, 2023.

During the year ended December 31, 2024, the Plan received contributions of \$42,612 in excess of certain IRC code sections. The excess contributions were related to participants exceeding IRS annual limits elective deferrals and/or annual additions to the participants' accounts. The Plan administrator is in the process of forfeiting the contributions from the accounts and making the corrective distributions to meet the IRS requirements for the Plan year ended December 31, 2024.

### 8. Prohibited Transactions

During 2024, the Plan Sponsor failed to remit participant contributions in a timely manner. The Plan Sponsor identified three instances during the year ended December 31, 2024, where \$1,086,724 in participant contributions were remitted to the Plan in violation of DOL regulations. The Plan Sponsor submitted the missing earnings and interest to the Plan in accordance with the DOL's Voluntary Fiduciary Correction Program in September 2024. A summary of nonexempt prohibited transactions related to delinquent remittances is shown in the attached supplemental schedule of delinquent participant contributions for the years ended December 31, 2024 and 2023.

### 9. Subsequent Events

Management has evaluated subsequent events through December 12, 2025, the date the financial statements were available to be issued, and has determined that no other subsequent events require disclosure.
