Independent Auditor's Report

To the Plan Administrator
Clarest Health 401(k) Plan (formerly known as ProCare LTC 401(k) Profit Sharing Plan and Trust)

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Clarest Health 401(k) Plan (formerly known as ProCare LTC 401(k) Profit Sharing Plan and Trust), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.



1. DESCRIPTION OF PLAN

The following description of the ProCare LTC 401(k) Profit Sharing Plan and Trust, which, effective January 1, 2024, changed the name to Clarest Health 401(k) Plan (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established effective May 3, 2010, as restated May 1, 2022, and again January 1, 2025. The Plan covers all employees, excluding union employees whose employment is governed by a collective bargaining agreement, nonresident aliens, leased employees and reclassified employees, of a controlled group of employers of Clarest Health, LLC (formerly known as Procure LTC Holdings, LLC) (the Company or the Plan Administrator) who are age 21 or older. The eligibility service requirements for elective deferrals, Company matching and nonelective contributions is immediate for exempt employees and upon completion of three months of service for non-exempt employees. Effective January 1, 2025, the Plan was amended to modify the eligibility date for both exempt and non-exempt employees to be the first day of the calendar month following completion of one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan provides retirement benefits to all eligible employees for the following controlled group of employers:

- Remedi SeniorCare Holding Corporation (including employees of affiliates) (effective January 1, 2025)

Contributions - Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe-harbor matching contributions on 100 percent of the first 3 percent of a participant's compensation, and 50 percent of the next 2 percent of the participant's compensation. Effective January 1, 2025, the Plan was amended to remove safe-harbor contributions and implement a discretionary employer matching contribution. The Plan Administrator determined the discretionary match for 2025 to be 50 percent of the first 4 percent of participant contributions. Non-elective and matching contributions may be contributed at the discretion of the Company. There were no non-elective or matching contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contributions, Company safe-harbor matching contributions, Company non-elective and matching contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions and the Company's safe-harbor and discretionary matching contributions, plus actual earnings thereon. Vesting in the Company's non-elective and matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six or more years of credited service. In addition, upon death, disability or attainment of normal retirement age, as defined by the plan document, a participant will become 100 percent vested in their entire account balance.

Effective January 1, 2025, participants are vested immediately in all contributions, including non-elective matching contributions.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the Plan Administrator, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years, or greater for the purchase of a primary residence.

Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment or roll over to an individual retirement account. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,874 and \$180, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$28,100, and plan administrative expenses were reduced by \$2,805, from forfeited nonvested accounts, in accordance with plan provisions.

Contributions receivable - Participant contributions and any related employer contributions are recognized in the period during which the employer makes the respective payroll deduction from the participant's compensation. Matching contributions are recorded in the relevant period in accordance with the terms of the plan document.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent events - Subsequent events were evaluated through December 18, 2025, the date the financial statements were available to be issued. Except as disclosed in Notes 1 and 3, there were no material subsequent events.

3. TRANSFERS INTO THE PLAN

Transfers from another plan represent account balances of participants of merging plans. Effective January 1, 2024, Medicine-On-Time, LLC became a participating employer in the Plan, and accordingly, the assets of Medicine-On-Time, LLC 401(k) amounting to \$3,695,460 were transferred to the Plan during the year ended December 31, 2024. Effective January 1, 2025, Remedi SeniorCare Holding Corporation and its affiliates became a participating employer in the Plan, and in January 2025 the assets of Remedi SeniorCare 401(k) Plan (Remedi Plan) amounting to \$45,793,232 were transferred into the Plan (see Note 11). In addition, participants enrolled in the Remedi Plan were automatically enrolled into the Plan for the December 27, 2024 pay date. As such, in December 2024, contributions related to that pay date of \$156,777 were received by the Plan and included as transfers from another plan during the year ended December 31, 2024.

4. INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, AdvisorTrust, Inc., the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation technique used for assets measured at fair value. There have been no changes in the technique used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. TAX STATUS

The Plan adopted a pre-approved plan offered by DWC - The 401(K) Experts. The pre-approved plan received an IRS Opinion Letter dated September 6, 2023, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their accounts.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

For the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Prior untimely remittances of \$113,785, of which \$102,581 were previously identified on the 2023 Schedule of Delinquent Participant Contributions were corrected during 2024. Untimely remittances identified on the Schedule of Delinquent Participant Contributions for 2024 total \$141,325, of which \$119,297 were corrected during 2024 and the remaining \$22,028 are to be corrected during 2025. Additionally, the Company has compensated participants affected with a contribution of lost earnings resulting from the late remittances for 2023 and 2024 in the amounts of \$3,272 and \$499, respectively. The Company will also be compensating participants for lost earnings for those to be corrected during 2025.

11. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For purposes of the Form 5500 filing, the Remedi Plan transfers that occurred in January 2025 as described in Note 3 were treated as if it occurred at the end of the 2024 plan year.
