**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Rocky Mountain SER/JOBS For Progress Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document description for a more complete description of the Plan's provisions.

**General**

The Plan is a single employer defined contribution plan covering all eligible employees of Rocky Mountain Service Employment Redevelopment (RMSER) (the "Company" or the Plan Sponsor'), who completed 1,000 hours of service performed within 12 consecutive months. The Plan has an age requirement of 21 or older. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

**Contributions**

Participants each year can contribute a percentage of their compensation, the lesser of 100% or the maximum allowed by law (\$22,500 for the year ended June 30, 2024) of pretax or after-tax annual compensation, as defined in the Plan. The Plan also allows for catch-up contributions for participants over 50 years of age. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company safe-harbor matching contributions are calculated at 100% of the first 3% of the employees' elective contribution plus 50% of employee elective contribution between 3% and 5%, for a maximum employer matching contribution of 4%.

The Plan also allows for discretionary non-elective employer contributions. The contribution will be allocated in proportion to the sum of eligible compensation plus eligible compensation in excess of 80% of the Social Security Taxable Wage Base. There were no non-elective employer contributions for the years ended June 30, 2024 and 2023.

The maximum IRC 415 limit for total contributions made on behalf of a participant (deferrals and employer contributions) is \$61,000 for the year ended June 30, 2024. Catch-up contributions can be made in excess of this limit.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds as options for participants.

**Participant Accounts**

Each participant's account is credited with the participant's elective deferrals and allocations of (a) the Company contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on each participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

**Forfeitures**

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0 respectively. Also in 2024, employer contributions and administrative expenses were reduced by amounts from forfeited non-vested accounts.

Participants are immediately vested in their contributions, rollover contributions plus actual earnings thereon. Vesting in the company's contributions is based on years of continuous services as follows:

Less than 3 years	0%
3 or More years	100%

Participants also become fully vested upon death.

**Payment of Benefits**

The Plan provides benefits for eligible participants upon retirement, death, termination, or permanent disability according to the form of payment elected by the participant within the limitations defined in the Plan. Participants who have reached the age of 59 1/2 are also eligible for distributions prior to termination. Distributions shall be made in the form of a lump sum, rollover or established Individual Retirement Account. The Plan allows hardship withdrawals of employee deferrals in accordance with Internal Revenue Service ("IRS") regulations.

**Notes Receivable from Participant**

Participants may borrow funds from their fund accounts subject to a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance. The notes receivable is secured by a balance in the participant's account and bear interest at which are commensurate with prevailing rates as determined by the Plan administrator. All notes must be repaid within a specified period, not to exceed 60 months. In most cases, repayment of the note will be made through after tax payroll deductions.

**NOTE 2.SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles. Employer contributions and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Expenses are recorded in accounting period in which they are incurred.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investment bought and sold as well as held during the year.

**Notes Receivables from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. As of June 30, 2024, \$2,190 was recorded as interest income on notes receivable from participants.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation(depreciation) of the fair value of investments.

**Subsequent Events**

The plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

**NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

**NOTE 4. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two-unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. GROUP ANNUITY WITH LINCOLN NATIONAL LIFE INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract known as The Guaranteed Account with Lincoln National Life Insurance Company. The value of the contract was \$653,357 and \$501,098 as of June 30, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contracts because this amount represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as show on the contract specifications. The interest crediting rate is declared on a quarterly basis. The contract amount maintained in the guaranteed account is guaranteed against loss of principal, minus all withdrawals, including charged and adjustments. The guarantee is based on Lincoln's ability to meet its financials obligations from general assets. The average crediting rate for the contract was 1.41% for the year ended June 30, 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. While the events may differ from contract to contract, the events typically include: (i) breach of contract; (ii) plan failure to meet the requirements of appropriate code sections; and (iii) failure to maintain and adequate balance in the investment. The balance guidelines are as follows: following the end of the third contract year, the value is less than \$15,000 or following the end of the third contract year there is no deposit activity for 24 consecutive month period and the contract owner account value is less than \$50,000. At this time the Company does not believe that the occurrence of any events, such as those described above, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 5. GROUP ANNUITY WITH LINCOLN NATIONAL LIFE INSURANCE COMPANY**

The guaranteed account is an evergreen contract that permits termination upon notice at any time, and provide for automatic termination if the contract value or the fair value of the underlying assets equals zero. If the fair value equals zero, the issuer of the wrap contract is obligated to pay the difference between the fair value and the contract value. If the Fund defaults in its obligations under contract and the Fund will retain the value of the underlying assets as of the date of termination. The Synthetic GICs generally permit the issuer or investment manager to convert the wrapped portfolio to a declining duration strategy, in which case the contract would terminate at a date that corresponds to the duration of the underlying fixed income portfolio on the date of an amortization election (Amortization Election). After the effective date of an Amortization Election, the fixed income portfolio must conform to the guidelines agreed upon by the issuer and the investment manager for the Amortization Election if the contract permits the issuer to terminate at the fair value, the issuer terminates the contract, and the contract provides for such an Amortization Election.

**NOTE 6. NON-PARTICIPANT DIRECTED INVESTMENTS**

The Plan's participants direct all investments. There are no non-participant directed investments as of June 30, 2024 and 2023

**NOTE 7. RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by Lincoln National Life Insurance Company the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also made direct payments to third party administrator of \$41,752. The Plan Sponsor pays directly any other fees related to the plan's operations. The Plan Custodian receives fees for administration and investment management.

**NOTE 8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its operations at any time and to terminate the plan subject to the provisions of ERISA. In the event of the plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the company may determine.

**NOTE 9. TAX STATUS**

The Plan adopted a volume submitter plan ("VSP"), which received an opinion letter in which the Internal Service stated that the VSP, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 9. TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10. RISK AND UNCERTAINTIES**

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
