### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Genesis Engineering Solutions, Inc 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined benefit plan under Section 401(k) of the Internal Revenue Code (IRC) adopted on April 1, 2001.

The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Vanguard Group, Inc. (Vanguard) is the investment broker for the plan and is also contracted to provide the plan recordkeeping and administrative services. Vanguard has an agreement with Ascensus, LLC to provide the recordkeeping and administrative services on Vanguard's behalf. Ascensus Trust Company (Ascensus) serves as trustee of the plan. Ascensus is not affiliated with Vanguard or any of its affiliates.

Effective December 1, 2024, the Plan appointed a new trustee ADP Retirement Trust Services, LLC and recordkeeper ADP Retirement Services (collectively "ADP Retirement"). Ascensus served as the recordkeeper and trustee and held and managed the Plan assets until December 1, 2024, at which point all Plan assets were transferred to ADP Retirement. The conversion initiated a blackout period beginning December 1, 2024, and continuing through January 15, 2025. During this period, funds could not be applied to the employee-selected funds or withdrawn from the Plan until the completion of the conversion. Employee contributions through payroll deductions continued to be made during the blackout period, and the contributions were deposited and held in the plan general account at ADP Retirement, until the completion of the blackout period. At the end of the blackout period, such funds were transferred to the investment options requested by each participant. The account balance and all future contributions of participants who had not provided investment instructions prior to the blackout period were invested in the Qualified Default Investment Alternative (QDIA) selected by the Plan. The Plan's QDIA is the Vanguard Target Retirement funds.

Effective December 1, 2024, the Plan adopted a prototype defined contribution plan document sponsored by ADP, LLC. There were no changes made to the Plan provisions.

**Eligibility**

The Plan covers all employees of Genesis Engineering Solutions, Inc. (the Company) who are age 21 or older. The Plan does not cover employees covered by a collective bargaining agreement and nonresident aliens who received no earned income from the employer from sources within the United States. Employees must complete at least 1,000 hours of service within the reporting period and be employed as of the last day of the year to be eligible to receive employer profit sharing contributions. The employees may enter the Plan on the first day of each month of the Plan Year.

**Contributions**

Participants may contribute on a pre-tax or after-tax basis up to 90% of their annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants.

The Plan allows for discretionary matching and profit-sharing contributions, determined annually. During 2024 and 2023, the Company matched 100% of participant deferrals up to 3% of compensation plus 50% of the next 2% and plus 25% of the next 2%. The Company discretionary matching contributions for the years ended December 31, 2024 and 2023 totaled \$771,509 and \$810,021, respectively. During 2023, the Company made a profit-sharing contribution to the Plan equal to 3.5% of eligible participants' compensation in the amount of \$687,506 (net of forfeitures). The Company did not make a profit-sharing contribution to the Plan during 2024.

**Participant Accounts**

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of the Company's contributions, investment earnings and losses and any administrative expenses paid by the Plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective deferrals, rollovers, and all earnings thereon. Vesting in the employer discretionary matching contributions and discretionary profit-sharing contributions is based on years of continuous service. After one year of service, a participant becomes 33.3% vested in discretionary matching contributions and discretionary profit-sharing contributions; the vesting percentage increases by 33.3% over the next two years so that a participant becomes fully vested in his or her account after three years of service.

**Notes Receivable from Participants**

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence.

**Notes Receivable from Participants (Continued)**

Plan participants may have up to two loans outstanding at any one time. Principal and interest are paid ratably through payroll deductions. Interest rates on the outstanding loans as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

**Payment of Benefits**

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, or a combination of the two. Partial withdrawals or installments are only permitted for required minimum distributions. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. The Plan allows in-service withdrawals at age 59½ and hardship withdrawals under certain circumstances, as defined in the Plan document. Withdrawals from rollover contributions are permitted at any time.

**Forfeited Accounts**

Forfeitures of nonvested balances of terminated participants may be used to reduce future employer contributions to the Plan or to pay plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,433 and \$15,381, respectively. During 2024 and 2023, the Plan used forfeitures of \$18,993 and \$4,105, respectively, to reduce employer contributions to the plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Contributions**

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses may be paid either by the Plan or directly by the Company. The Plan is not required to reimburse the Company for expenses paid on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA as follows:

- by Ascensus LLC as agent for Ascensus Trust Company, the trustee of the Plan as of and for the year ended December 31, 2023 and for the period ended December 13, 2024;
- by ADP retirement Trust Services, LLC the trustee of the Plan as of and for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the period presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund*

The Money Market Fund invests at least 99.5% of its total assets in cash, U.S. government securities, and/or repurchase agreements that are collateralized solely by U.S. government securities or cash. Although the fund invests in short-term U.S. government securities, the amount of income that a shareholder may receive will be largely dependent on the current interest rate environment. The fund seeks to maintain a stable \$1.00 net asset value (NAV) per share price.

*Mutual Funds*

The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan's assets include investments in funds managed by Vanguard and ADP Retirement. Vanguard was the investment broker for the plan and Ascensus LLC provided plan recordkeeping and administrative services pursuant to a partnership agreement with Vanguard during the year ended December 31, 2023 and for the period ended December 13, 2024. Therefore, the transactions in these funds qualify as party-in-interest transactions. Effective December 1, 2024, ADP Retirement provides custodial and recordkeeping services to the Plan. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Participant loans also qualify as party-in-interest transactions. There were no financial transactions recorded between the Company and the Plan other than contributions made. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 - TAX STATUS**

The Plan has adopted a prototype 401(k) profit-sharing plan sponsored by Ascensus LLC. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype profit-sharing plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). Effective December 1, 2024, the Plan adopted a prototype defined contribution plan sponsored by ADP, LLC. The prototype plan has received an opinion letter from the IRS dated October 6, 2020, which states that the prototype plan, as then designed, is in compliance with the applicable requirements of the IRC.

The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions for the statutory period; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - LATE REMITTANCES**

During the years ended December 31, 2024, the Company failed to remit to the Plan custodian participant contributions totaling \$67,181 within the period prescribed by Department of Labor regulations. These contributions are considered nonexempt party-in-interest transactions. The Company custodian calculated lost earnings on the delinquent remittances and the Plan sponsor remitted the amount to the Plan on October 6, 2025, at which time the lost earnings were allocated to the affected participants' accounts.
