## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Plan Administrator Representatives of the National Football League Non-Player Insurance Trust

### **Opinion**

We have audited the financial statements of the National Football League Non-Player Insurance Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025 and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

AS OF MARCH 31, 2025 AND 2024, AND FOR THE YEAR ENDED MARCH 31, 2025

---

### 1. ORGANIZATION AND BACKGROUND

The National Football League Non-Player Insurance Trust (the “Trust”), a Voluntary Employees’ Beneficiary Association (“VEBA”) trust, and its sole associated plan, the Coaches Life Insurance Plan (the “Plan”), provides life insurance for active, inactive, and terminated vested coaches, as well as accidental death and dismemberment (“AD&D”) coverage to active coaches. All Plan activity is accounted for within the Trust. To be eligible for the Plan, a participant must meet the definition of an active head coach or assistant coach with a Member Club of the National Football League (“NFL”), as defined in the Plan. Inactive (i.e. a coach under contract but no longer actively at work) and terminated coaches may be eligible to receive life insurance (AD&D coverage is not offered to inactive and terminated coaches) if they are vested in the NFL Club Employees’ Pension Plan and have at least three years of credited service. The Plan and Trust are subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants do not make contributions into the Plan. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s information.

The National Football League’s League Office (the “NFL League Office”) was established by the NFL Member Clubs to coordinate and handle certain administrative matters and transactions common to all the NFL Member Clubs, including the administration of the Trust. The NFL League Office handles the ongoing administrative functions of the Trust. There is no allocation of either direct or indirect NFL League Office expenses to the Trust. The cash balance held by the Trust is maintained in a separate bank account.

Administrative fees are paid to an outside third party to administer the Trust. The administrator handles all of the details of the Trust including the annual enrollment and the listing of all dependents and beneficiaries. In addition, a separate insurance carrier, provides insurance and claims administration of the Plan’s life insurance and AD&D programs. Under the arrangement with the insurance carrier, the Trust is liable for premiums and may be liable for claims under the participating insurance contract in effect if claims exceed certain contractual amounts. The Trust receives funds from the NFL Member Clubs in amounts equal to the premiums due for the Plan’s AD&D and life insurance premium payments coverage. These premiums are then aggregated and remitted to the insurance carrier. For the life insurance coverage, the Trust maintains a premium stabilization fund with the insurance company.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements of the Trust have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligation and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties** - The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates; health care inflation rates; and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimations and assumptions in the near term could materially affect the financial statements. The Plan's exposure to a concentration of credit risk is dependent upon the contract value of the premium stabilization fund which is recorded in the statements of net assets available for benefits.

**Cash** - Cash in the Trust consists of cash held in a noninterest-bearing bank account.

**Premium Stabilization Fund** - For experience-rated contracts, premium surpluses are recorded as a premium stabilization fund asset. If the insurance company requires payment of additional premiums due to a premium deficit, an obligation for the additional premiums is included in postretirement benefit obligations.

The Plan maintains a premium stabilization fund with an insurance company, Hartford Life and Accident Insurance Company, which was previously used to reduce current and future premium payments when premiums paid to the insurance company exceed the total of claims paid and other charges. During the year ended March 31, 2025, the premium stabilization fund was not utilized for premium payments. The premium stabilization fund has been included as an asset of the Trust until such amounts are used to pay relevant plan expenses. The fund is nonforfeitable should the insurance contract terminate.

The premium stabilization fund as of March 31, 2025 and 2024 was \$5,076,910 and \$4,491,578, respectively. The premium stabilization fund increased during the year ended March 31, 2025 due to a favorable experience surplus of \$400,270 and interest income of \$216,041. This asset is reported annually by the insurance company as the surplus premiums less the experience on the policy and fees plus the interest credit as defined in the insurance policy.

**Contributions from National Football League Member Clubs** - The Trust receives contributions from the 32 NFL Member Clubs, which the Trust then uses to pay premiums to the insurance carrier. These contributions are currently used to pay life insurance and AD&D premiums.

**Experience Surplus from Premium Stabilization Fund** – Amounts added to the premium stabilization fund are due to a favorable insurance experience and are recorded as additions in the Statement of Changes in Net Assets Available for Benefits.

**Life Insurance and AD&D Premiums** - Life Insurance and AD&D Premiums consists of premiums paid for life insurance and AD&D coverage for eligible participants. Life insurance premiums of \$1,023,797 and AD&D premiums of \$132,390 were paid by the Trust with contributions provided by the NFL Member Clubs.

**Administrative Expenses** - Third-party professional services incurred in the administration of the Trust are paid by the Trust.

### **3. POSTRETIREMENT OBLIGATION**

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to coaches for services rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired coaches, and (2) active coaches after retirement from service with the NFL Member Clubs. Prior to an active coach's full eligibility

date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that coach's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the NFL Member Clubs and from existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's independent actuary and is the amount that results from applying actuarial assumptions to the potential benefit payable under the Plan's benefit formula to estimate future death benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Significant assumptions used in the valuations as of March 31, 2025 and 2024, were as follows:

- Discount rates – 5.44% and 5.20%, as of March 31, 2025 and 2024, respectively.
- Mortality – Pri.H-2012 Employee & Retiree Mortality Headcount Weighted Table, with generational projection using scale MP-2021, as adjusted to reflect anticipated near-term and long-term endemic effects of COVID-19, updated as of November 2024 for March 31, 2025 valuation. Pri.H-2012 Employee & Retiree Mortality Headcount Weighted Table, with generational projection using scale MP-2021, as adjusted to reflect anticipated near-term and long-term endemic effects of COVID-19, updated as of January 2024 for March 31, 2024 valuation.
- Life Insurance Load - A minimum retention (or expense) load of 10% for fully insured life insurance benefits with face values in excess of \$5,000 was reflected. This benefit is valued for all retirees currently eligible and coverage ends at age 70 or the age retiring from the NFL Pension Plan.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations. The actuarial present value of postretirement benefit obligation presented in the accompanying financial statements are presented using the end of year benefit information date, March 31, 2025 and 2024.

#### **4. INCOME TAXES**

The Trust is exempt from federal income taxes under Section 501(c)(9) of the U.S. Internal Revenue Code and is exempt from state income taxes. The Trust has a favorable determination letter from the Internal Revenue Service dated September 13, 1974 and, accordingly, no provision for federal and state income taxes has been made in the accompanying financial statements.

#### **5. BENEFIT OBLIGATIONS FUNDING**

If there is a deficiency of the Plan's net assets over benefit obligations, the NFL Member Clubs expect to fund the benefit obligations through contributions as required on a pay-as-you-go basis.

#### **6. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS**

Certain ongoing administrative functions of the Trust are handled by the NFL League Office staff personnel. Other fees, such as legal fees, are handled by the National Football League Management Council (the "NFL Management Council"). There are no allocations of either direct or indirect NFL League Office or NFL Management Council administrative expenses to the Trust for the year ended March 31, 2025. See Notes 1 and 2 for other party-in-interest transactions.

## **7. TRUST TERMINATION**

Although it has not expressed any intention to do so, the NFL Commissioner has the right under the Trust and the Plan to amend or terminate the Trust or Plan subject to the provisions set forth in ERISA. In the event of a decision to terminate the Plan, the NFL Member Clubs will contribute the necessary amounts to fund all life insurance and AD&D premiums incurred prior to the date of termination.

## **8. SUBSEQUENT EVENTS**

Management of the Trust has evaluated subsequent events through December 11, 2025, which is the date the financial statements were available to be issued. There are no subsequent events requiring adjustments to or disclosure in the financial statements.
