To the Participants and Plan Governance

Opinion

We have audited the financial statements of the Rhinegeist Holding Company, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Rhinegeist Holding Company, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 8 to the financial statements, the Board of Directors of Rhinegeist Holding Company, Inc., the Rhinegeist Holding Company, Inc. Employee Stock Ownership Plan's sponsor, voted in December 2025 to terminate the Plan, which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon termination. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. PLAN DESCRIPTION:

The Rhinegeist Holding Company, Inc. Employee Stock Ownership Plan (the “Plan”) is a defined contribution plan covering certain employees of Rhinegeist Holding Company, Inc. and its wholly owned subsidiaries (“Sponsor” or the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan. The primary purpose of the Plan is to allow participants to acquire stock ownership interests in the Company. The Plan holds approximately 5% of the outstanding common stock of the Company. The Company also elected S-corporation status.

Eligibility

Generally, all eligible employees may participate in the Plan on January 1 in the year upon attaining the age of 21 and the completion of one year of service.

Contributions

The Company, at the approval of the Company’s Board of Directors, may make contributions to the Plan. Contributions can be in the form of cash and/or shares of Company stock, as determined by the Company’s Board of Directors. The Plan does not permit employee contributions.

Payment of benefits

Upon normal retirement, disability or death, benefits are paid in a single lump sum in cash as soon as administratively feasible after the last day of the Plan year in which the retirement, disability or death occurs. If termination is for other reasons, generally the vested portion will be paid no later than the close of the fifth Plan year (or longer for balances in excess of \$5,000) after the year of termination, unless the vested balance does not exceed \$5,000, in which case the distribution will be made as soon as administratively feasible in a single lump sum. If the balance exceeds \$5,000, the participant may elect to receive a distribution beginning no later than on or after the close of the fifth Plan year after termination, in substantially equal annual installments over a period not exceeding five years. In-service withdrawals are permitted if Employer contributions have accumulated in the Plan for a minimum of two years.

Voting rights

Participants are entitled to exercise voting rights attributable to those shares allocated to their accounts and are notified by the trustee prior to the time that such rights are to be exercised. Participant voting rights are exercised through the trustee, subject to provisions described in the Plan document.

Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account will be credited annually with their allocable share of Company contributions of cash or stock (including fractional shares), and with any forfeitures of Company stock. Only those participants who complete 1,000 hours of service and are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant’s eligible compensation, relative to total eligible compensation.

Vesting

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of

service with the Company. Provided the participant has at least 1,000 hours of service under the Plan, the participant's Plan benefit will be vested based on the following schedule:

Put option

Under the Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of stock distributed to participants for which there is no market. Any distributions of shares are immediately converted into cash.

Diversification

Diversification is offered to participants over a six-year period to those who have attained the age of 55 and have completed at least 10 years of participation in the Plan. In each of the first five years, a participant may diversify up to 25% their account balance. In the sixth year, the percentage changes to 50%. No withdrawal election shall be permitted if the balance in such Company stock account has a fair market value of \$500 or less, unless and until the balance in the account as of a subsequent allocation date in the election period exceeds \$500.

Forfeitures

Employer contributions are forfeited by participants upon termination before becoming vested. Forfeited amounts are allocated to remaining participants in accordance with Plan provisions. As of December 31, 2024 and 2023, there were no unallocated forfeitures.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following is a brief description of the significant accounting policies of the Plan.

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when distributed.

Administrative expenses

The Sponsor pays most Plan administrative expenses and such expenses are excluded from these financial statements. If the Sponsor does not pay such expenses, the trustee shall pay them from the Plan assets.

Subsequent events

The Plan has evaluated subsequent events through December 19, 2025, the date the financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Common stock: The fair value of the Rhinegeist Holding Company, Inc. common stock held by the Plan is valued based on an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of the company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company.

Interest bearing cash: The carrying value of the money market fund approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 15, 2024, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not been amended since receiving the determination letter. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC), and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. RISKS AND UNCERTAINTIES:

The Plan invests in common stock of the Company. This common stock is exposed to various risks, including a variety of risks associated with investing in an operating entity and the liquidity risk associated with investments in a private company. Due to the level of risk associated with the common stock, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such change could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

7. RELATED PARTY TRANSACTIONS:

The Plan invests in Company common stock. These transactions qualify as party-in-interest transactions. As noted in footnote 2, the Company pays most of the Plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

8. SUBSEQUENT EVENTS:

The Board of Directors of the Company adopted a board resolution to terminate the Plan effective December 12, 2025. As a result of the termination, all participant accounts became 100% vested.
