**INDUSTRIAL VENTILATION, INC. 401(K) RETIREMENT PLAN**  
**NOTES TO FINANCIAL STATEMENTS**

**A. Description of Plan:**

The following description of the Industrial Ventilation, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Plan is a defined contribution Plan covering all eligible employees of Industrial Ventilation, Inc. (the Company/Plan Sponsor) who have at least three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Effective January 1, 2024, the Plan was split into two separate Plans. Plan 001 includes participants who work in Idaho. Plan 002 includes participants who work outside of Idaho. During 2024, Plan assets for participants who work outside of Idaho were transferred to Plan 002. The Board of Trustees is responsible for oversight of the Plan.
2. **Contributions** – Each year, participants may contribute a percentage of annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributed a 33.33% matching contribution of up to 6% of Plan compensation through June 30, 2018. Effective July 1, 2018, the Company matching contribution increased to 50% matching contribution of up to 6% of Plan compensation. At their discretion, the Sponsor can make additional discretionary profit-sharing contributions to the Plan.
3. **Participant Accounts** – Participants may elect to contribute to the Plan as a reduction of their wages. Each Participant's account is credited with the Participant's contributions and an allocation of the Companies matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.
4. **Vesting** – Participants are immediately vested in their elective contribution accounts plus actual earnings thereon. The Companies discretionary contribution accounts are subject to a graduated vesting schedule that is determined by continuous years of service. An Employee is vested 20 percent after two years of qualified service and 20 percent for the next four years. A Participant is 100 percent vested after six years of credited service. Employees are fully vested upon death, disability, attainment of normal retirement age or Plan termination.
5. **Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates from 5.25% to 10.5%. Principal and interest are paid through payroll deductions. During 2024, loans totaling \$5,500 were offset due to participant terminations.
6. **Payment of Benefits** – On termination of service due to death, disability, or retirement, a Participant or Beneficiary may elect to receive either a lump-sum amount equal to the value of the Participant's vested interest in their account, or installment payments. For termination of service due to other reasons, a Participant may receive the value of the vested interest in their account as a lump-sum distribution.
7. **Forfeited Accounts** – When a participant terminates prior to fully vesting, the non-vested portion of the participant's account is used to reduce Employer contributions. At December 31, 2024 and 2023, there were forfeiture balances of \$3,956 and \$4,286, respectively. In 2024 and 2023, forfeited accounts of \$4,286 and \$4,881 were used to reduce employer contributions, respectively.

## **B. Summary of Significant Accounting Policies:**

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.  
  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
4. **Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.
5. **Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.
6. **Payments of Benefits** – Benefits are recorded when paid.
7. **Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.
8. **Subsequent Events** – The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
9. **Reclassifications** – Certain amounts for the year ended December 31, 2023, were reclassified to conform to the current year presentation. The reclassifications did not affect the net increase for the year ended December 31, 2023.

## **C. Plan Termination:**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

## **D. Tax Status of Plan:**

The Plan uses a pre-approved Plan document sponsored by Newport Group Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated November 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. Effective January 1, 2024, the plan was restated to use a pre-approved Plan document sponsored by Cetera Retirement Plan Specialists, which received an opinion letter from the IRS dated June 30, 2020. The Plan itself has not received an opinion letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

**D. Tax Status of Plan (Continued):**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**E. Information prepared and certified by trustee:**

The following information included in the accompanying financial statements and the information used to complete the supplemental schedule, Schedule H, Line 4i, Form 5500, was obtained from data that was prepared and derived from certified to as complete and accurate by John Hancock Trust Company LLC, the Trustee, as of and for the year ended December 31, 2024. The following information included in the accompanying financial statements and the information used to complete the supplemental schedule, Schedule H, Line 4i, Form 5500, was obtained from data that was prepared and derived from certified to as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC, the Trustees, as of and for the year ended December 31, 2023 and from January 1, 2024 to July 11, 2024:

**F. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**G. Fair Value Measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## G. Fair Value Measurements (Continued):

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, respectively.

*Self-directed brokerage accounts:* Self-directed investments brokered by John Hancock, are valued based on quoted market prices reported in active markets. These investments held by the self-directed brokerage accounts are deemed to be actively traded.

*Collective Trust Funds:* Valued at the net asset value (NAV) per unit as reported by the fund. Collective trust funds held by the Plan are regulated by state banking regulators. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The collective trust funds held by the Plan are deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

## H. Reconciliation of Financial Statements to Form 5500:

There were no reconciling items between the financial statements and the amounts reflected in form 5500 as of December 31, 2024 and 2023.

**I. Concentration of Credit Risk:**

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

**J. Plan Amendments:**

On January 1, 2024, the Plan was amended and restated as the Plan was split. The Plan was also amended to include an automatic increase feature for employee deferral contributions. Under this provision, participants who have elected to contribute to the Plan will have their deferral percentage automatically increased by 1% annually, up to a maximum deferral rate of 9%, unless the participant elects to opt out of the automatic increase or modifies the deferral percentage.

**K. SECURE 2.0:**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Many of the provisions have different effective dates, with some changes impacting 2023, 2024, 2025 and beyond. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

**L. Transfer of Assets:**

During 2024, the Plan transferred assets from Ascensus Trust Company to John Hancock Trust Company LLC. During this transfer there was a blackout period from July 3, 2024, to August 9, 2024, when participants could not contribute to the Plan.

During 2023, the Plan transferred assets from Newport Trust Company LLC to Ascensus Trust Company. During this transfer there was a blackout period from June 22, 2023, to June 26, 2023, when participants could not contribute to the Plan.

**M. New Plan Formation:**

On January 1, 2024, the Company started a new plan for the employees of Industrial Ventilation, Inc. who work outside of Idaho. As a result of the formation of the new Plan, an aggregate of \$4,954,758 was transferred into the new Plan and is included in the benefits paid to participants balance on the Statement of Changes in Net Assets Available for Benefits.

**N. Nonexempt Party-in-Interest Transactions:**

During the year ended December 31, 2024, the Company remitted participant deferrals totaling \$96,907 to the custodian later than required by the Department of Labor Regulation 2510.3-102. The Company will file a form 5330 with the IRS and pay the required excise tax on the transactions. In addition, participant accounts will be credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis. In 2025, the Company will reimburse the Plan for lost earnings of \$1,526 related to these contributions.
