Note 1

Plan Description

Description of Plan

The following description of the Joy Construction Corp. 401k Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan that was adopted on January 1, 2001 to provide retirement benefits for eligible employees of the Joy Construction Corporation (the Company) who had a year of service (at least 1,000 hours of service during the 12 month period beginning with their hire date or anniversary of their hire date) and have attained the age of 21. Entry date for the Plan is the January 1st or July 1st coincident with or next following the date upon which the eligibility requirements are met. The Plan was amended and restated effective June 5, 2017, for the inclusion of participant-directed contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was amended and restated again on March 15, 2019 to allow participants to withdraw all or part of their balance upon attainment of age 59 1/2. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants have the right to elect to defer a portion of their compensation which will then be contributed on their behalf to the Plan. For 2024 and 2023, the maximum statutory limits for employee deferrals are \$23,000 and \$22,500, respectively. For 2024 and 2023, employees 50 years of age or older could defer a maximum of \$30,500 and \$30,000, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans, IRAs, 403(b) plans, and 457 plans. Participants who make salary deferral contributions to the plan are eligible to receive a Safe Harbor Matching Contribution equal to 100% of the contributed amount for the plan year up to 4% of Plan Compensation.

Participant Accounts

Each participant's account is participant directed and is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including the safe harbor contributions and rollover contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of services due to retirement, attaining the age of 59 1/2, disability or death, a participant with a vested account in excess of \$5,000 may elect to receive a single lump-sum distribution of 100% of their vested account balance or a partial distribution of a portion of their vested account if permitted by the plan administrator. Participants with a vested account of \$5,000 or less will be eligible to receive a distribution of their entire vested account balance or a rollover of their vested account balance to another IRA selected by the plan administrator if they do not consent to the distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan permits distributions in the event of a hardship, as defined in the Plan. Participants at Normal Retirement Age (the later of 65 or the 5th anniversary of plan participation) may withdraw all or any part of their vested account.

Administrative Expenses

The Plan's administrative expenses are paid either by the Plan or by the Employer as provided by the Plan document.

Note 2 Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

The Plan's investments are reported at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Note 3 Fair Value Measurements

Accounting guidance provides for valuation techniques, such as the market approach (comparable market prices), the income approach (present value of future income or cash flow), and the cost approach (cost to replace the service capacity of an asset or replacement cost). A fair value hierarchy using three broad levels prioritizes the inputs to valuation techniques used to measure fair value. The following is a brief description of those three levels:

- *Level 1* : Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- *Level 2* : Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active; or
- *Level 3* : Unobservable inputs that reflect the reporting entity's own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at fair value on a recurring basis consisted of mutual funds in the amount of \$5,300,324 and \$4,303,868 as of December 31, 2024 and 2023 and are

categorized as Level 1 in the hierarchy. The Plan did not have Level 2 or 3 investments as of December 31, 2024 and 2023, respectively.

Note 4 Information Certified by the Plan's Trustee

Investments are carried at market value and held by John Hancock Life Insurance Company of New York the Trustee of the Plan.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation (depreciation) in fair value of investments, dividend and interest income for the year ended December 31, 2024, are based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employment Retirement Income Security Act of 1974.

Note 5 Tax Status

The Plan adopted a volume submitter plan sponsored by Heller Pension Associates Inc. The volume submitter plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan has been amended since the date of this opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 6 Plan Termination

Although they have not expressed an intention to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 Related Party Transactions

As of December 2024, John Hancock was the record keeper as defined by the Plan during 2024. Transactions involving these instruments are party-in-interest transactions. The Plan paid administrative fees totaling \$33,984 during 2024.

Note 8 **Prohibited Transactions**

During the plan year ended December 31, 2024, the Company failed to remit an aggregate of \$60,228 of participant contributions timely on 9 occasions, as reflected in the supplemental schedule of delinquent participant contributions. The Company will submit additional funds for lost earnings in the amount of \$523 to the affected participant accounts during 2025. The Company reported these transactions to the IRS under its voluntary correction program.

Note 9 **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 **Subsequent Events**

The Plan Administrator has evaluated subsequent events through December 16, 2025, the date the financial statements were available to be issued and has determined there are no subsequent events to be reported in the financial statements.
