INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Landis Supermarket, Inc. 401(K) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Landis Supermarket, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements are comprised of the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Landis Supermarket, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Landis Supermarket, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Landis Supermarket, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

NOTE A: DESCRIPTION OF PLAN

The following description of the Landis Supermarket, Inc. 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with a 401(k) feature covering all employees of Landis Supermarket, Inc. ("Company") who have attained the age of 21 and completed one year of service by being credited with at least 1,000 hours of service. The Plan is subject to the provisions of Employment Retirement Income Security Act of 1974 (ERISA). The plan administrator and plan sponsor are responsible for oversight of the Plan. The plan trustee reviews the appropriateness of the Plan's investment offerings and monitors investment performance and discusses with the plan sponsor any suggested changes. The Plan has implemented the required provisions of the Secure Act 2.0.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan subject to the Federal dollar limitation. Participants may elect to make traditional (before tax) contributions, or Roth (after tax) contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan currently offers mutual funds. Participants also have the option of investing in self-managed brokerage accounts with Charles Schwab Trust Company. The Company match contribution is discretionary from year to year. In 2025, the Company contributed 25 percent of the first 3 percent of base compensation that each participant contributed to the plan. Additional profit sharing amounts may be contributed at the option of the Company's management. The Company did not make a discretionary profit sharing contribution in the current year. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferrals plus actual earnings thereon. Participants are vested in the Company's match and discretionary contribution portion of their accounts based on years of continuous service and are vested 20% after two years of credited service and 20% per year thereafter, becoming 100 percent vested after six years of credited service.

Payment of Benefits

On termination of service due to retirement, death or disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump-sum amount (participants become 100% vested upon death, disability, or upon reaching normal retirement age of 65, while still an employee) or periodic installments of at least \$1,000, if the participant's vested benefit in the Plan exceeds \$7,000, based on the required minimum distribution rules. If the participant's vested benefit in the Plan does not exceed \$7,000, then the benefit will be distributed in a single lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Due to timing differences there may be benefit payments payable for employees who terminated their employment and requested their distributions prior to the end of the plan year but have not yet been paid. At March 31, 2025 and 2024 there were no amounts payable for these benefits.

The Plan includes the option for hardship withdrawal provisions which were included in the Bipartisan Budget Act of 2018.

Forfeitures

Forfeited non-vested accounts can be used to reduce Company contributions (or reallocate as Company contributions) or to pay Plan expenses. The forfeiture balance at March 31, 2025 and 2024 was \$730 and \$1,335, respectively.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may have only one loan outstanding at any one time. Loan terms will be no more than five years unless the loan qualifies as a "home loan" for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing interest rates on commercial loans. Interest rates on outstanding loans as of March 31, 2025 range from 5.25% to 10.50%. Principal and interest are paid ratably through weekly payroll deductions.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the plan trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments is recorded net of fund expenses. Net appreciation/depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 or 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions for the plan year ending March 31, 2025 prior to June 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees along with the Plan management fees. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Cash and Cash Equivalents

The Plan considers all short-term securities purchased with a maturity of three months or less to be cash equivalents.

Subsequent Events

The Plan has evaluated subsequent events through December 30, 2025, the date the financial statements were available to be issued.

NOTE C: FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used at March 31, 2025 and 2024.

NOTE D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions.

NOTE E: TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and trustee believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: TRUSTEE CERTIFICATION

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the plan years ending March 31, 2025 and 2024. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the investments, with the exception of the self-managed brokerage accounts, reported in the accompanying statements of net assets available for benefits as of March 31, 2025 and 2024 and the supplemental Schedule H, Item 4(i) - Schedule of Assets (Held at End of Year) as of March 31, 2025, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended March 31, 2025.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H: RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invested in mutual funds managed by Reliance Trust Company, the trustee as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation/depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The fees paid by the Plan to the third party administrator amounted to \$80,523 for the year ended March 31, 2025.

The fees for the Plan's audit for the year ended March 31, 2025 were \$13,275.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
