Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Maplevale Farms, Inc., Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note A - Description of Plan

The following description of the Maplevale Farms, Inc., Retirement Plan (Plan) provides only general information. Participants should refer to the plan adoption agreement and subsequent amendments for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with employees eligible to participate upon completion of 1,000 hours of service within a 12-month period and having attained the age of 20. The Plan was adopted March 17, 1992, and was most recently restated effective August 3, 2023, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has an Eligible Automatic Contribution Arrangement (EACA), with a designated automatic pre-tax deferral amount of 4%. Employees who are hired, rehired, or whose entry date for elective deferrals is on or after July 1, 2016, are eligible for the EACA.

Contributions: The Company matches 25% of each participant's elective deferral contribution, limited to 25% of the first 4% contributed by each participant, and the company also makes an additional discretionary contribution that is determined annually. Employee contributions are allowed to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of plan earnings and employer contributions.

Vesting: Participants are immediately vested in their elective deferral contributions.

Employer contributions are vested according to the following schedule:

Payment of Benefits: Upon termination of service due to death, disability, retirement, or other separation, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution or in substantially equal installments. Partial withdrawals or installments are only permitted for participants and beneficiaries who must receive required minimum distributions. Hardship distributions are permitted by the Plan beginning January 1, 2022. The Plan allows early retirement at age 62 for fully vested participants and permits in-service distributions to participants who have attained age 59½.

Forfeited Accounts: As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33,213 and \$57,588, respectively. These amounts were used to reduce employer contributions for the years 2024 and 2023, respectively.

Participant Loans: Loans to participants are permitted. The minimum participant loan amount is \$1,000. Participants may only have one outstanding participant loan at a time; refinancing is allowed.

Note B - Significant Accounting Policies

Plan Termination: Although it has not expressed any intent to do so, the plan sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement: The Plan follows ASC Topic 820, *Fair Value Measurements*, which defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

ASC Topic 820 establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's judgments about the assumptions that market participants would use in pricing the asset or liability based on the best information available in the circumstances.

The hierarchy is broken down into three levels based on the reliability of inputs, as follows:

Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

Level 2 - Valuations are based on quoted prices in markets that are not active, or for which all inputs are observable, directly or indirectly.

Level 3 - Valuations are based on inputs that are not observable and are significant to the overall fair value measurement.

Payment of Benefits: The Plan records benefits to participants when paid.

Administrative Expenses: The plan sponsor absorbs all significant costs of plan administration.

Income Taxes: The Plan follows ASC Topic 740, *Income Taxes*, which prescribes a recognition threshold and measurement principles for financial statement recognition and measurement of uncertain tax positions.

Note D - Fair Value Measurements (Continued)

The Plan's common/collective trusts (Level 2) are valued at the net asset value (NAV) per unit reported by the trustee at the measurement date. NAV is based primarily on observable inputs of the trusts underlying assets.

Note E - Group Annuity Contract with Insurance Company

The Plan invests in group annuity contracts that are designed to provide preservation of principal and a stable credited interest rate. The issuers guarantee both principal and interest, subject to the terms of the contracts. These investments are reported at contract value which represents contributions plus credited interest, less withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contracts are fully benefit-responsive investment contracts. Changes in contract value and interest credited are reported as investment income in the statements of changes in net assets available for benefits. Total contract value was \$447,248 and \$570,074 as of December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to, the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, an amendment to the Plan document, or a change in the administration or operation of the Plan.

Note F - Parties-in-interest Transactions

Various companies provide investment advisory, recordkeeping, trustee, and auditing services to the Plan, and therefore are considered parties-in-interest. During 2024 and 2023, trustee services were provided to the Plan by John Hancock Trust Company, LLC, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC. Third-party administration services were provided by John Hancock Retirement Plan Services, LLC, and Empower Retirement, LLC. Some fees paid for such services comprise administrative expenses that are customary and usual for the types of services provided and qualify as party-in-interest transactions. There were no amounts due from, or payable to, parties-in-interest as of December 31, 2024 and 2023.

Note G - Tax Status

Effective August 3, 2023, the Plan amended and restated the plan, adopting a non-standardized form of prototype plan sponsored by John Hancock Retirement Plan Services, LLC. The IRS has informed John Hancock Retirement Plan Services, LLC, by opinion letter dated June 30, 2020, that the Plan is acceptable for use by employers for the benefit of their employees under IRC Section 401. Although the Plan has been amended subsequent to the date of this letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is exempt. The Plan's information returns are open to Internal Revenue Service examination for the 2021 tax year and all subsequent years.

Note H - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note I - Benefits Payable

As of December 31, 2024 and 2023, no participants had elected to withdraw from the Plan but had not yet been paid.

Note J - Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation. Those reclassifications have no effect on the previously reported change in net assets available for benefits.

Note K - Subsequent Events

Subsequent events were evaluated through December 15, 2025, which is the date the financial statements were available to be issued.
